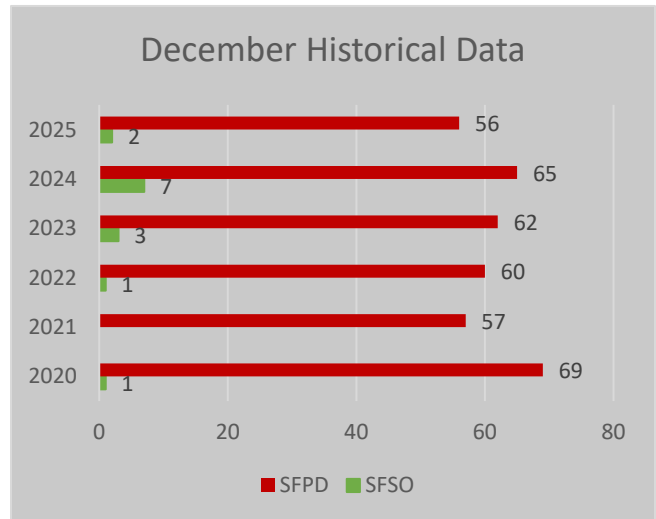
**Re: San Francisco Department of Police Accountability December 2025 Monthly Statistical Report**

Dear President C. Don Clay and San Francisco Police Commissioners:

**Summary of Complaints Received in December 2025**

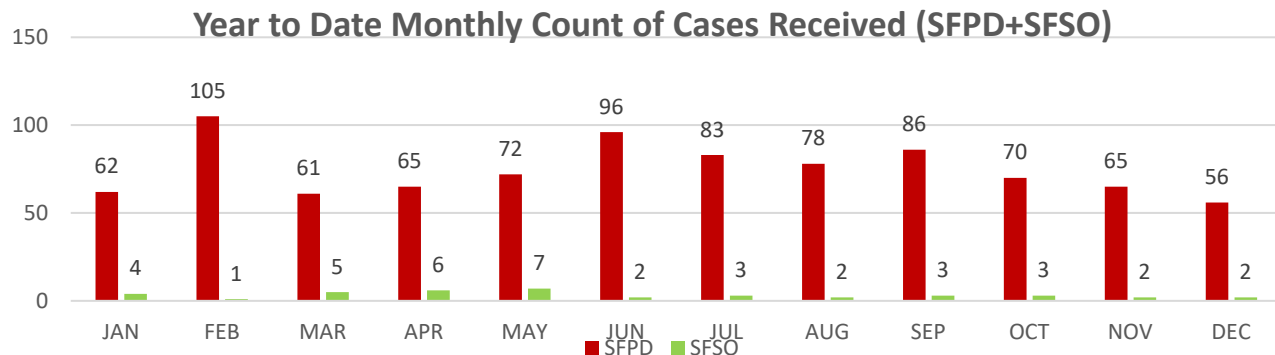
The Department of Police Accountability received a total of **58** cases in **December 2025**, **56** SFPD complaints and **2** SFSO complaints. Compared with a total of **72** cases, **65** SFPD complaints, and **7** SFSO complaints in the same period last year, the **December 2025** case total is **11%** lower than the five-year average and is **19%** lower than the previous year.

From January through December, the DPA received a total of **939** new cases, **899** SFPD complaints and **40** SFSO complaints. Compared with the **790** cases filed during the same period in 2024, **737** SFPD complaints and **53** SFSO complaints. The December year-to-date case total represents a **19%** increase in new complaints over last year.



Currently, DPA has a total of **232** pending cases **193** SFPD and **39** SFSO.

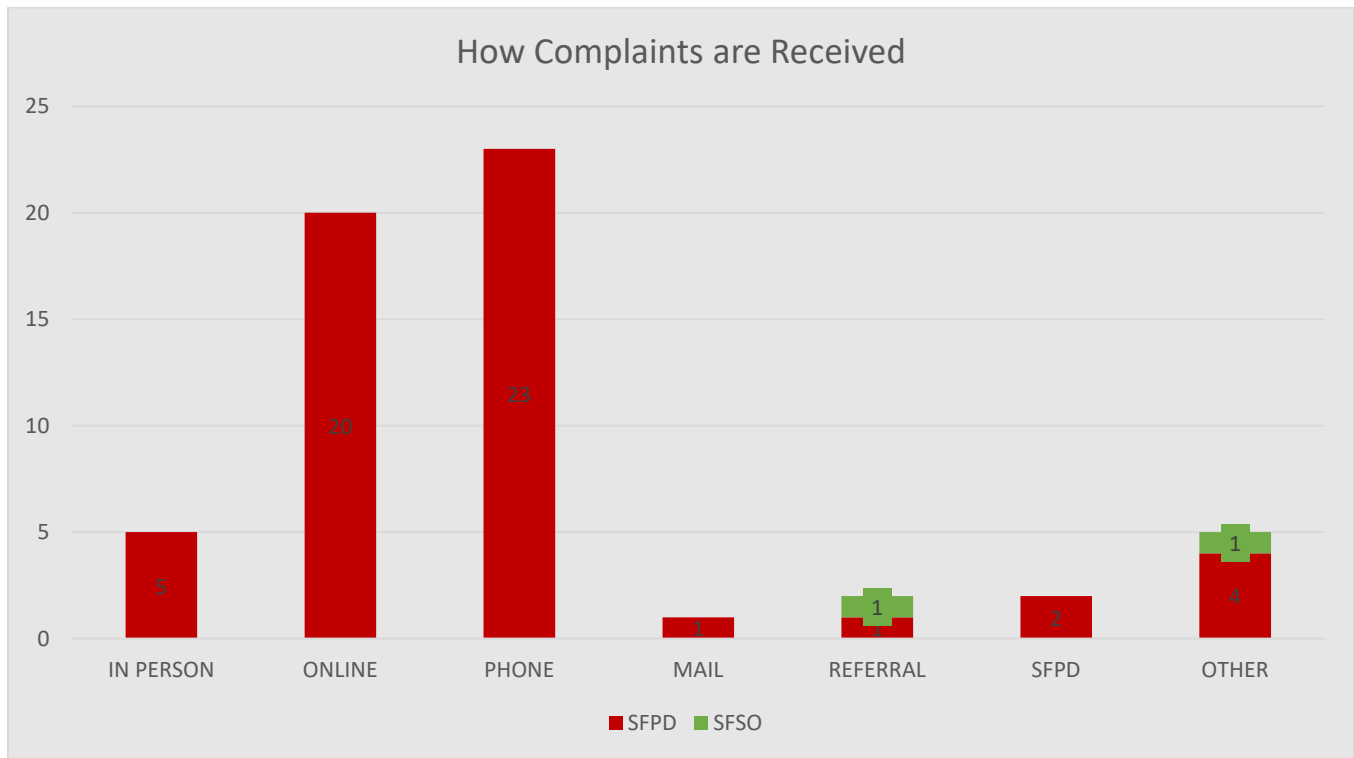
In December, DPA received a total of **0** referrals from the SF Sheriff's Office and referred a total of **1** cases to SFSO.
