SUBJECT: The City Is Not on Track to Meet Its Digital Accessibility and Inclusion Standard

Goals

#### **EXECUTIVE SUMMARY**

In November 2021 the City and County of San Francisco (City) adopted the Digital Accessibility and Inclusion Standard (DAIS), which requires city departments to provide residents and visitors equitable access to all digital services and web content. This assessment by the Office of the Controller (Controller), City Services Auditor (CSA), Audits Division, found that city departments are behind on their efforts to adhere to the implementation schedule of DAIS and that the Committee on Information Technology (COIT) and the City Administrator's Digital Services division (Digital Services) could have better supported departments' efforts to comply with DAIS.

In addition to the local requirement, federal law requires local governments to ensure people with disabilities have an equal opportunity to benefit from their digital content by April 2026. According to COIT, it has limited enforcement authority to require and ensure departments' compliance. The combined efforts of COIT, Digital Services, Mayor's Office on Disability, Office of Civic Engagement and Immigrant Affairs, and all city departments are critical in ensuring that the City's public-facing digital content provides equitable access for city residents and visitors with disabilities.

#### **BACKGROUND, OBJECTIVE & METHODOLOGY**

#### **Background**

Digital Accessibility and Inclusion Standard. In November 2021 the City adopted the Digital Accessibility and Inclusion Standard (DAIS), which requires city departments to provide residents and visitors equitable access to all public-facing websites, online applications, and digital content run by or for the City. This includes digital content created by departments, commissions, elected officials, employees, consultants, and vendors. DAIS requires the City's digital content to comply with all city, state, and federal laws and regulations, including Title II of the Americans with Disabilities Act (ADA).<sup>1</sup>

DAIS requires all new and existing content to:

- 1. Follow San Francisco's equitable design requirements and Level AA of the most recent Web Content Accessibility Guidelines (WCAG).
- 2. Provide vital information for the public at a fifth-grade level.
- 3. Provide human translation of vital information in the threshold languages defined by the Language Access Ordinance (LAO).

Exhibit 1 summarizes the requirements of DAIS.

Committee on Information Technology. Composed of 13 department heads that represent each of the City's major services areas, COIT is the governance body under the Office of the City Administrator that makes decisions for the future of San Francisco's technology and policies that support strategic goals such as cybersecurity and disaster preparedness. In coordination with Digital Services, the Mayor's Office on Disability, Office of Civic Engagement and Immigrant Affairs, City Attorney, and the Office of Contract Administration, COIT provides guidance and trainings to city departments on their website accessibility remediation efforts to comply with DAIS. COIT is responsible for assessing compliance with DAIS and for incorporating digital accessibility and inclusion in its evaluation of budgetary requests.

*Digital Services.* The Office of the City Administrator's Digital Services team works with departments to improve public services by using digital tools, ensuring an inclusive and equitable experience for

residents. According to Digital Services, in coordination with the Mayor's Office of Disability and COIT, it consulted with departments to get their input on DAIS and provided templates and guidelines for departments to use in conducting accessibility reviews of their websites. Digital Services is also responsible for departments' migration to the City's *SF.gov* domain and to ensure that departmental websites meet DAIS requirements.

*DAIS Implementation Schedule.* Departments had until May 2024 to ensure that their existing public digital content adheres to the new standards. COIT established an implementation schedule for DAIS, which is summarized in Exhibit 2.

#### **Objective and Scope**

The objective of this assessment was to evaluate the City's digital accessibility and inclusion efforts and assist in the evaluation of accessibility reviews, consistent with the requirements of DAIS, which states that the Controller's CSA will evaluate the City's digital accessibility and inclusion efforts and assist in the evaluation of accessibility reviews.

This assessment focused on the 30 city departments that indicated to COIT that they would not migrate their websites to the *SF.gov* domain (SF.gov) and therefore would conduct their own website accessibility reviews and any needed remediation in accordance with DAIS. The assessment did not include departmental websites that have migrated or are migrating to *SF.gov* as of February 2024, all of which are managed by Digital Services. CSA may determine whether a future audit will be conducted to ensure that departments on *SF.gov* are complying with all requirements of DAIS.

#### Methodology

To achieve the objective, we:

- Reviewed requirements in DAIS and guidelines developed by COIT and Digital Services to understand departments' responsibilities.
- Obtained a list of departments not migrating to SF.gov and planning to assess and implement their own compliance with DAIS.
- Reviewed website accessibility reviews submitted by departments to determine whether they comply with COIT's schedule for DAIS accessibility reviews. Departments were allowed either to conduct their own website accessibility review or to use a third-party vendor to do so.

This assessment is for a nonaudit service. Generally accepted government auditing standards do not cover nonaudit services, which are defined as professional services other than audits or attestation engagements. Therefore, COIT is responsible for the substantive outcomes of the work performed during this assessment and is responsible to be in a position, in fact and appearance, to make an informed judgment on the results of the nonaudit service.

#### **RESULTS**

Observation 1: COIT and Digital Services could have better supported departments' efforts to comply with the Digital Accessibility and Inclusion Standard by May 2024.

COIT and Digital Services did not conduct adequate initial outreach to city departments, created templates that omitted some DAIS provisions for departments' accessibility reviews, and did not finalize a pre-qualified vendor pool to facilitate departmental reviews in a timely manner. These are factors that may have caused some departments to fall behind on progress toward the goal that all online and public content meets accessibility standards by May 2024.

In October 2022 COIT sent a survey to 64 city departments to determine which would not be migrating to the *SF.gov* domain. COIT identified 30 departments that were not migrating to *sf.gov* and needed to conduct their own accessibility reviews by May 2023 to identify digital content that must be remediated by May 2024 to comply with DAIS. (Because *SF.gov* is designed to follow all standards outlined in DAIS, any departments already on or moving to that domain are considered in compliance with DAIS.)

Besides the 30 departments discussed above, we found that an additional 9 departments have an unknown compliance status regarding DAIS. Of these 9 departments, 4 were not included in COIT's initial outreach, and 5 initially indicated they would be moving to *SF.gov* but had not started the migration process with Digital Services as of late March 2024.

Digital Services created templates for departments to use as a baseline for their website accessibility reviews. However, departments that used Digital Services' templates might not fully comply with DAIS because the initial templates were incomplete and did not map out:

- **Each guideline in WCAG 2.1 Level AA.** The issue types in the templates, which address areas of accessibility such as color contrast, either did not include all WCAG 2.1 Level AA guidelines or were not clear as to how the accessibility areas were related.
- Specific applicable provisions in the language access ordinance such as applications or forms to participate in a department's program or to receive its services.
- Any of San Francisco's equitable design requirements, specifically the affordability requirement related to data and the security requirement outlined in the City's Cybersecurity Policy.

Departments not migrating to *SF.gov* may use a vendor to conduct their website accessibility review and remediation to comply with DAIS. However, COIT did not finalize the pre-qualified list of suppliers until after the May 2023 review deadline. Thus, departments that were waiting for the pre-qualified supplier pool to be finalized could not meet the deadline.

## Observation 2: 15 of 30 departments had not completed their website accessibility reviews as of February 2024.

Of the initial 30 city departments that indicated that they were not migrating their websites to the *SF.gov* domain, 11 (37 percent) sufficiently completed their website accessibility reviews by the May 2023 deadline. As of February 2024, of the remaining 19 departments:

- 15 did not complete their website accessibility reviews.
- 3 completed their reviews after the May 2023 deadline.
- 1 completed its review but it was based on an outdated standard.

Exhibit 3 summarizes the status of city departments' compliance with this requirement.



#### Notes:

The Public Library (Library) is the department that completed its review but the vendor that conducted the Library's review used WCAG 2.0 as its criteria instead of the more updated WCAG 2.1, Level AA.<sup>2</sup> The City requires public-facing websites to conform to WCAG 2.1, Level AA, at a minimum. Many departments that are not migrating to *SF.gov* indicated that they could not conduct their website accessibility reviews due to limited time and/or staffing. Thus, departments not migrating to *SF.gov* are lagging on the citywide effort to meet the requirements of DAIS.

In addition to DAIS, the ADA, Title II, is a federal law that requires local governments to give people with disabilities an equal opportunity to benefit from their digital content. This must be done by using WCAG 2.1, Level AA, as the technical baseline by April 24, 2026. However, according to COIT, it has limited enforcement authority to require and ensure departments' compliance. The combined efforts of COIT, Digital Services, Mayor's Office on Disability, Office of Civic Engagement and Immigrant Affair, and all city departments are critical to ensuring that the City's public-facing digital content provides equitable access for city residents and visitors with disabilities.

#### Recommendations

The Committee on Information Technology should:

- 1. Work with the Digital Services division to ensure templates provided to departments are complete and include all requirements in the Digital Accessibility and Inclusion Standard, including those related to Web Content Accessibility Guidelines, the language ordinance, and the City's equitable design requirements.
- 2. Reevaluate and, if needed, change the deadline for the City's digital content to comply with the Digital Accessibility and Inclusion Standard, communicate the current or new deadline to departments, and remind departments to remediate their digital content by the deadline.
- 3. Remind departments to ensure vendors conducting their website accessibility reviews use the current version of the Web Content Accessibility Guidelines or use Digital Services' current templates for all future reviews.
- 4. Encourage departments to migrate their websites to the City's *SF.gov* domain if self-compliance with the Digital Accessibility and Inclusion Standard is infeasible.
- 5. Immediately reach out to departments that stopped engaging with COIT or those that were omitted from the initial outreach process to determine how they will remediate their websites to comply with the Digital Accessibility and Inclusion Standard.
