PRESENT: President John Trasviña, Vice President Rebecca Saroyan, Commissioner Jose Lopez, Commissioner Robin Abad Ocubillo, and Commissioner Lily Wong.

(1) **PUBLIC COMMENT**

At this time, members of the public may address the Board on items of interest to the public that are within the subject matter jurisdiction of the Board except agenda items. With respect to agenda items, your opportunity to address the Board will be afforded when the item is reached in the meeting with one exception. When the agenda item has already been reviewed in a public hearing at which members of the public were allowed to testify and the Board has closed the public hearing, your opportunity to address the Board must be exercised during the Public Comment portion of the calendar. Each member of the public may address the Board for up to three minutes. At the discretion of the Board President, public comment and remote public participation may be limited to two minutes per person. If it is demonstrated that public comment and remote public participation will cumulatively exceed 15 minutes, the President may continue Public Comment and/or remote public participation to another time during the meeting.

SPEAKERS: Georgia Schuttish spoke about the Valley Street project. She stated that it was tantamount to a demolition and the property owner should have gotten a demolition permit as that would have enabled better oversight of the house.

SPEAKERS: President Trasviña noted that Ms. Schuttish was referring to Items that were no longer on the agenda. Regarding the case to be heard, he assured the parties that the Board had read the materials submitted and that it was ready to hear the matter. He welcomed everyone to the hearing.

SPEAKERS: Executive Director Lamarre stated that after a review of the record, a determination was made that the Board of Appeals lacked jurisdiction to hear these appeals. She stated that the permits that were appealed were postentitlement phase permits for the housing development project approved under Planning Commission Motion No. 21448 (2022-008784CUA) and Building Permit No. 2022/1223/9051, which authorized the construction of two dwelling units, and therefore were not subject to appeal under Government Code Section 65913.3(c)(3). She further stated that the appeals had been administratively dismissed pursuant to Article V, Section 11 of the Rules of the Board of Appeals.

ACTION: Upon motion by Commissioner Lopez, the Board voted 5-0 to deny the appeal and uphold the Variance Decision on the basis that it meets the five findings required by Planning Code Section 305(c).

SPEAKERS: Commissioner Wong disclosed that she sits on the Planning Department’s Community Equity Advisory Council, which advises the Department’s staff on strategies to engage diverse communities. She stated that this work had not involved the appellant or the determination holder in this matter. She further stated that she did not believe that sitting on the Council would impact her ability to be fair and impartial.
