

# **Good Neighbor Policy**



- I. While hosting entertainment, permit holder shall always have a staff member on site who is able to provide proof of permit, is trained in every aspect of venue operation, and is aware of all permit conditions.
- 2. Permit holder is responsible for the safety and security of venue patrons and the surrounding neighborhood. The Commission approved security plan shall be followed, and permit holder shall secure the sidewalk for a 100-foot radius in all directions around the premises of the business to prevent injury to persons and/or damage to property. Security staff shall be placed at all entrances and exits during the period from 10:00pm to such time past closing that all patrons have left the vicinity.
- **3.** Permit holder shall post easily visible signs outside each entrance and exit instructing patrons to:
  - a) Respect the neighborhood by keeping voices low,
  - b) Follow City & County of SF smoking regulations<sup>2</sup>, and
  - c) Obey City & County of SF anti-loitering regulations.3

All signs and walkways shall be well lit. Sidewalks shall be kept clear for pedestrians. Cars shall not be double parked.

4. Permit holder shall provide a phone number to all interested neighbors for immediate contact with a staff member on site who has direct authority over the premises, knowledge of all permit conditions, and shall respond in a timely manner to address concerns.

- **5.** Permit holder shall maintain, and be prepared to verify, records at the premises of current L.E.A.D certification<sup>4</sup> for all persons working at the premises.
- 6. Permit holder shall maintain all entrances and exits to the building and all sidewalks within 100 feet of the premises in a clean and sanitary condition. At some point between 30 minutes after closing and 8:00am, permit holder shall walk the area within 100 feet of the property and dispose of any litter that may have been left by patrons.
- 7. Permit holder shall take measures to reduce the amount of sound that escapes the venue. All doors and windows must be kept closed while hosting entertainment, unless otherwise conditioned on the permit. Permit holder shall be familiar with, and abide by, sound ordinances enforced by the Entertainment Commission, including but not limited to, the following:
  - a) Regulation of Noise Noise Limits
    - 1) Commercial & Industrial Property<sup>5</sup>
    - 2) Public Property<sup>6</sup>
  - b) Outdoor Amplified Sound Regulations<sup>7</sup>
  - c) Unnecessary Noise8
- **8.** Within 24 hours of any violent incident, or any time SFPD responds to a call for service at the premises, permit holder shall complete and send an incident report to (1) their SFPD District Station Permit Officer and (2) the Entertainment Commission.





I am confirming receipt of your letters of concern regarding La Media Cancha's LLP permit that will be heard before my Commission tonight. These letters will be included in their file as well. Please note that they were originally slated to be on the consent agenda, but due to your messages, I am recommending to my Commission that they vote to move them to the regular agenda, so there is an opportunity for further review. You are welcome to attend tonight's hearing and speak during public comment on this item. You may attend in person or remotely via Teams (agenda is attached), and each person will have 3 minutes to speak during public comment. Please know that the Commission nor the applicant can respond to your comments as it's not an opportunity for discussion.

I also wanted to let you know that I sent your emails (with personal information redacted) to the owner, Jose, and his consultant, Jorge. They let me know that they've not received any complaints directly, so they were surprised to learn of your concerns.

Regarding the 311 complaints that Joyce submitted, Jorge let me know that the owner cleans up after his customers, but sometimes there is waste left by homeless individuals or those using the bus stop directly in front of the business. He also said there is a city cleaning crew that passes along Mission Street almost daily to pick up trash accumulated overnight and helps keep the sidewalks clean. I do want to mention that the complaints about human feces do not fall under the EC's purview and should be directed to the Department of Public Works (DPW).

I'll also note that we did receive a 311 sound complaint about the business on Thursday, October 2<sup>nd</sup> at 10:56pm. My inspector responded to the complaint on Saturday, 10/4 at 9pm and during his inspection he observed indoor prerecorded music playing. The manager on duty was familiar with the LLP permitting process and said he understood they were not permitted to have entertainment unless the Commission approved their permit, so they've been playing prerecorded music only.

Lastly, if you don't already have direct lines of communication with Jose, please let me know if you'd like me to send an intro email. I'd be happy to connect you all so you can voice your concerns directly as well.



Thank you for informing me about the letters. It's strange, as to date no one has filed any complaints or notified the owner of any issues, either at the establishment or through any other means.

José will not need an interpreter. Regarding the business, it began operating in 2021 and has no connection to MAMA COCO, the previous establishment.

Last Saturday, October 4th, he mentioned that a city inspector visited due to a complaint about "loud music" and "karaoke." However, none of those activities were taking place at that time, and the inspection report should reflect this.

As for the trash and other debris accumulating in front of the business, the owner cleans up after his customers, but he cannot be held responsible for the waste left by homeless individuals or those using the bus stop directly in front. Additionally, there is a city cleaning crew that passes along Mission Street almost daily to pick up trash accumulated overnight. This city program helps keep the sidewalk clean from the unscrupulous individuals who leave waste during the night.

There are always people who may speak negatively about the business—perhaps something common within the community—but I hope the commission carefully considers the possibility of ill-intentioned motives behind such complaints.

I am writing to submit supplemental evidence regarding my opposition to the Limited Live Performance Permit application by La Cancha Media 1.

As requested, here are several 311 complaint case numbers I personally filed concerning human feces and sanitation hazards directly outside this location:

- Case #101001639126 (March 2025) Human feces remained for 3 days; City closed the case without cleaning.
- Case #101001627676 (March 2025) Human feces at the entrance; case marked "resolved," but no cleaning occurred.
- Case #101001563900 (February 2025) Human feces on the sidewalk; case closed "no work needed."
- Case #101000418481 (2024) Human feces reported; case closed without action.

Attached are screenshots from the 311 system showing the conditions and case records. These incidents demonstrate that the City has repeatedly failed to provide adequate enforcement and sanitation response, leaving the burden on the landlord and residents. Families and children are exposed to these hazardous conditions daily.

This is clear proof that current enforcement is already insufficient. If a Limited Live Performance Permit is granted, the problems of intoxicated patrons, public disorder, and sanitation hazards will only increase, creating an even greater risk to community health and safety.

For these reasons, I respectfully urge the Commission to deny this permit application.

Dear Kaitlyn,

My name is <>. I live in the <>. Our property <> with the La Cancha Media restaurant. As a family who suffer daily from the noise disturbance and nuisance caused by the restaurant, we vehemently oppose granting the La Cancha Media restaurant the permit for live performances. The restaurant's owners have a terrible track record of working with the residents to address issues caused by the business: since the restaurant's opening in around 2022, we have been complaining to the restaurant's business owners, the property owner of the restaurant's building, 311, the local police, and we even sent complaint to the Entertainment Commission (entertainment.enforcement@sfgov.org) as well as the office of the San Francisco Board of Supervisors. But to no avail. The restaurant's owners continue to bully the nearby residents.

In addition to opposing the permit, we implore the Entertainment Commission to finally listen to the complaints from nearby residents and take actions to regulate the restaurant, as we believe it is the Entertainment Commission's responsibility to protect the residents from the restaurant's bullying.

In this email, you will find:

- 1. Reasons that we oppose granting the restaurant the permit for live performances.
- 2. Evidence of how the restaurant has been causing many problems in the neighborhood. Note: it seems that <u>311.org</u> is missing older complaints. Aslo, you won't find too many recent complaints because the nearby residences have

found 311 complaints to be ineffective. After all, the restaurant has been causing the same issues for more than 3 years with no authorities willing to intervene.

**Noise Disturbance** – The restaurant already plays music at excessive volume. Many a night, the restaurant would play music at high volume well past 11PM. Hi good morning, <>

I am confirming receipt of your letter of opposition for La Media Cancha 1's Limited Live Performance (LLP) permit application, and will include it in their file for my Commission to review.

Additionally, I wanted to let you know that I looked at our complaint history for 2024 and 2025, and we have never received a sound complaint about this location. Are you using 311 or contacting SFPD non-emergency? What are the complaints about?

There was no other opposition or concern voiced about this application, but I did want to let you know that should the permit be approved, they would have to adhere to the Good Neighbor Policy (GNP, attached) which, among other things, requires the doors to stay closed during entertainment. Additionally, they'd have to adhere to an approved indoor sound limit (there is no outdoor programming nor speakers proposed under this application), and the business would fall under my Commission's purview for enforcement. I have inspectors who work in the field to respond to complaints in real time (mostly on weekend nights) and if the business is found in violation of their permit, we have an enforcement escalation policy that starts with education, but can also result in citations with a monetary fine. Additionally, if there are ongoing issues, my Commission can require the business to reappear before them at a hearing to potentially recondition their permit to have more restrictive days/times of entertainment.

Please let me know if you have specific questions for me, or if you'd like me to connect you with the owner directly. I strongly encourage this as I've found that neighbors having direct lines of communication with the business is often the most effective way to mitigate any issues.

I am a resident of this neighborhood and I strongly oppose the above-referenced application. This area

is primarily residential, and the community is already suffering from severe disturbances: large groups

loitering outside, public drinking and intoxication, and even public urination. These activities present

serious public safety and sanitation concerns.

In addition, loud music and crowd noise frequently extend late into the night, making it difficult for

families, children, and working residents to rest. Young children are especially impacted —the constant

noise disrupts sleep and harms their ability to study and concentrate.

I have submitted multiple noise and nuisance complaints to 311. Despite these complaints, the

problems persist. If a Limited Live Performance permit is granted, it will likely exacerbate the impacts

and create further disruption for the neighborhood.

For these reasons, I respectfully and firmly request that the Entertainment Commission deny this

 Hours cap. Entertainment may not start before 10:00 AM. All entertainment must end by 9:00 PM

(Sun-Thu) and 10:00 PM (Fri-Sat).

 Sound control. Install a locked sound-level limiter on all audio chains, calibrated by a qualified

technician. Keep digital logs available upon request. At the property line, comply with Police Code

Article 29: not to exceed ambient +8 dBA and ambient +8 dBC.

• Security & loitering management. Provide staffed line management on busy nights; prevent

loitering; post signage; perform nightly sidewalk cleanup within 50 feet of the premises.

• Neighbor communications. Post a 24/7 complaint phone number and email; maintain a complaint



Thank you for taking the time to review our community's concerns. Please include this email in the record. This message supplements my prior submission sent on 10/6/2025; I am not reattaching those exhibits (311 screenshots, camera stills, evidence log).

- 1. Illegal entertainment already operating. The business has run karaoke/entertainment without a permit, showing blatant disregard for the law and this Commission's authority.
- 2. Public-health hazards caused by patrons. Neighbors' cameras captured patrons urinating and vomiting in front of homes; numerous 311 reports were closed without cleanup and landlords had to wash sidewalks themselves. (311 case numbers previously provided, incl. #101001639126, #101001627676, #101001563900, #101000418481; noise #101002720187.)
- 3. Incompatible with mixed-use residential. Families, seniors, and children share a common wall; amplified entertainment here is fundamentally incompatible with residential use.
- 4. Enforcement has already failed; approval would worsen harms. Problems persist despite repeated 311 reports.
- 5. From two houses away ,we can clearly hear the amplified music and party shouting late at night even with window closed. This level of propagation shows the site is fundamentally incompatible with mixed-use residential neighbors.

For these reasons, I respectfully urge the Commission to deny the LLP application for La Media Cancha.

Hi Kaitlyn,

Because our properties directly abut with zero physical setback or open space between them, I believe that measuring the noise "outside of the property plane," as described in San Francisco Police Code Article 29, must occur at the shared property line to accurately reflect the impact on the neighboring property.

An exterior measurement taken away from the shared wall (for example, in front of the building or across the

street) would not represent the actual exposure at the property boundary. The shared wall functions as the property plane, and transmission through that wall is the main pathway of disturbance.

I respectfully request that any compliance sound check or inspection include measurements:

\* At or immediately adjacent to the shared property line, and

\* Within the affected interior space, consistent with San Francisco Police Code Article 29 § 2909(a)(2), which allows interior measurement in attached residential units when the noise source is in another building or dwelling.

This approach would align with the intent of Article 29, which evaluates whether noise levels exceed the allowed limits "outside the property plane," while acknowledging that in a zero-lot-line situation, that location is effectively the common wall.






