NOW, THEREFORE, the undersigned petitioner(s) do/does hereby petition for a conditional license as follows, to-wit:

- 3 Petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on the most recently certified ABC-253.
- 4 When the sidewalk seating area of the premises is being utilized for the sales, service, and consumption of alcoholic beverages, a premises employee shall be in attendance and maintain continuous supervision at all times of said area.
- 5 When the sidewalk seating area is being utilized for the sales, service, and consumption of alcoholic beverages, the barrier/fencing/railing shall be in place at the boundary location approved on the most recently certified ABC 257.

My name is Kingston Wu and I am one of the Managing Members of Golden Eye Social, an Augmented Reality Darts Bar and Restaurant that opened to the public in May 2025.

This letter is to notify you that we are applying for a Place of Entertainment (POE) permit with the San Francisco Entertainment Commission.

We are applying for the POE permit so we can offer live music mid-week for private buy-outs and Moscone Center related events, and on the weekends to liven the atmosphere and attract guests to our business. In addition, we would like to have outdoor amplified sound for tables on the sidewalk.

The POE permit requires that indoor entertainment must end by 2am, outdoor amplified sound must end by 10pm, and that we adhere to a sound limit set forth by the Entertainment Commission.

Additionally, we are required to follow the Entertainment Commission's Good Neighbor Policy (GNP), which is included with this letter for your reference.

We will manage the sound pollution rigorously, and well as staff appropriately to manage the anticipated crowd these public and private events might bring.

As we plan on being on a fixture of this block for years to come, we will make to abide by the Good Neighbor Policy not only as attached, but as one is taught growing up. Any issues outside of our control will be handled appropriately by our experienced management team, and with onsite security which will be customary for these types of events.

# Good Neighbor Policy

1. While hosting entertainment, permit holder shall always have a staff member on site who is able to provide proof of permit, is trained in every aspect of venue operation, and is aware of all permit conditions.
2. Permit holder is responsible for the safety and security of venue patrons and the surrounding neighborhood. The Commission approved security plan shall be followed, and permit holder shall secure the sidewalk for a 100-foot radius in all directions around the premises of the business to prevent injury to persons and/or damage to property.<sup>1</sup> Security staff shall be placed at all entrances and exits during the period from 10:00pm to such time past closing that all patrons have left the vicinity.
3. Permit holder shall post easily visible signs outside each entrance and exit instructing patrons to:
  - a) Respect the neighborhood by keeping voices low,
  - b) Follow City & County of SF smoking regulations<sup>2</sup>, and
  - c) Obey City & County of SF anti-loitering regulations.<sup>3</sup>All signs and walkways shall be well lit. Sidewalks shall be kept clear for pedestrians. Cars shall not be double parked.
4. Permit holder shall provide a phone number to all interested neighbors for immediate contact with a staff member on site who has direct authority over the premises, knowledge of all permit conditions, and shall respond in a timely manner to address concerns.
5. Permit holder shall maintain, and be prepared to verify, records at the premises of current L.E.A.D certification<sup>4</sup> for all persons working at the premises.
6. Permit holder shall maintain all entrances and exits to the building and all sidewalks within 100 feet of the premises in a clean and sanitary condition. At some point between 30 minutes after closing and 8:00am, permit holder shall walk the area within 100 feet of the property and dispose of any litter that may have been left by patrons.
7. Permit holder shall take measures to reduce the amount of sound that escapes the venue. All doors and windows must be kept closed while hosting entertainment, unless otherwise conditioned on the permit. Permit holder shall be familiar with, and abide by, sound ordinances enforced by the Entertainment Commission, including but not limited to, the following:
  - a) Regulation of Noise - Noise Limits
    - 1) Commercial & Industrial Property<sup>5</sup>
    - 2) Public Property<sup>6</sup>
  - b) Outdoor Amplified Sound Regulations<sup>7</sup>
  - c) Unnecessary Noise<sup>8</sup>
8. Within 24 hours of any violent incident, or any time SFPD responds to a call for service at the premises, permit holder shall complete and send an incident report<sup>9</sup> to (1) their SFPD District Station Permit Officer and (2) the Entertainment Commission.



My name is Kaitlyn Azevedo, and I am the Deputy Director of the SF Entertainment Commission. If you are receiving this message, you have submitted a letter of opposition for Golden Eye Social's Place of Entertainment (POE) permit application with my office.

Golden Eye Social holds a Type 47 liquor license with the state Alcohol Beverage Control (ABC) to operate as a restaurant with bar service, and they are currently allowed to be open until 2am. Initially, Golden Eye Social's POE permit application included indoor entertainment with the doors and windows closed until 2am, and outdoor amplified sound at the front of the business until 10pm. After hearing concerns about the outdoor programming, the owner of Golden Eye Social has removed the outdoor component from the application entirely. **This means there will be no outdoor amplified sound at the business under this permit application.** I'll also add that should the indoor POE permit be granted, the business will have to comply with an indoor sound limit set in accordance with the City's sound ordinance, as well as our Good Neighbor Policy (GNP, attached).

If you'd like to rescind or amend your letter of opposition, please let me know.



I am a property owner and full time resident who lives across the street from Golden Eye Social. I would like to formally contest Golden Eye Social's POE application.

Golden Eye Social is on the bottom level of a heavily populated housing complex (SOMA Square Apartments) and across the street from my residence at Museum Parc (300 3rd St, San Francisco, CA 94107) which is also a heavily populated housing condominium complex.

Earlier on 2025 Golden Eye Social had several days where they operated their outdoor sound system and a slap held a late private event. The noise was so loud that working families (mine included) could not sleep until 2am. The outdoor speakers are very loud with heavy base that carries noise pollution for several blocks.

Please do not disrupt everyone who lives across the street. There are 250 residential units here.







I am writing as a **homeowner at Museum Parc** to respectfully request that the Commission **deny the Place of Entertainment permit** sought by Golden Eye Social. This request is on docket EC-1906 on the December 16 agenda.

Golden Eye Social is located **directly across Third Street from Museum Parc**, a large residential condominium community. The permit being considered would allow **amplified music, both indoors and outdoors, until 2:00 AM**. Noise of this magnitude and duration, so close to a residential building, would make it extremely difficult — and in many cases impossible — for owners and residents to sleep, work, and comfortably occupy their homes.





Dear Members of the San Francisco Entertainment Commission,

I am writing as a homeowner with two units in the residential building directly across from the proposed Golden Eye Social location on Third Street, both facing the site in question. I

am submitting this comment in strong opposition to the Place of Entertainment permit (Docket EC-1906), particularly the request to allow amplified music outdoors and late into the night.

Our building was constructed at a time when residential sound-proofing standards were significantly lower. The units facing Third Street have thin, large windows, and noise carries directly and intensely into the bedrooms. Even prior operators at this same site (Spin) caused serious disruption when interior doors were opened for ventilation. On warm nights, when they opened the front door or even cracked windows because the interior became hot and crowded, the sound, especially low-frequency bass, traveled straight into our homes. Sleep became impossible. This was with indoor-only entertainment.

Allowing amplified outdoor music or late-night exterior activity at this exact location would be exponentially more disruptive. This is not ordinary “city noise.” Bass frequencies and amplified sound penetrate walls and windows in a way that is physiologically and psychologically exhausting. For residents, including families with infants, children, and working adults, this would create ongoing nightly disturbance and a significant reduction in quality of life.

This neighborhood is indeed mixed-use, and residents understand and accept ordinary urban activity. But Golden Eye is seeking to introduce a new, substantially more intrusive use into a long-established residential environment. In land-use terms, this is a classic “coming to the nuisance” situation. The residential building predates this entertainment use, and its structural characteristics make it especially vulnerable to noise encroachment. Approving outdoor amplified entertainment here would effectively impose a burden on existing residents that they have no way to mitigate.


The City has an interest in supporting nightlife, but it also has an obligation to prevent unreasonable noise impacts on homes, particularly when the affected building cannot retrofit itself to modern soundproofing standards. This site is simply incompatible with late-night outdoor entertainment due to the direct line of sound transmission into residential units.

For these reasons, I respectfully urge the Commission to deny the application as currently proposed. At minimum, outdoor amplified sound and late-night hours must not be permitted at this location.





My husband and I have been full-time resident homeowners in Museum Parc since 1989. Museum Parc is a condominium complex with 233 units directly across the street from Golden Eye Social at 300 Third Street. There are at least seven floors of condominiums with their bedrooms facing Golden Eye Social's side entrance on Third Street. The SoMa Square Apartments are located directly above the commercial space housing Golden Eye Social. We are writing to you to formally oppose Golden Eye Social's POE application.

Needless to say, we have seen many changes in the neighborhood and are supportive of new businesses. Our neighborhood has always been "mixed use" and we enjoy the diversity of residential units and businesses in the area. However, our understanding is the POE application specifically requests outdoor amplified sound for tables installed on the sidewalk. We hope you deny their request. Even with amplified sound ending by 10pm, before the business submitted their POE application, please see the attached photo taken from the bedroom window after

10pm on Friday, October 31 this year—the crowd on the sidewalk did not disperse until well after midnight, close to 2am. The indoor sound system was also cranked up and with all the people out on the sidewalk in front, they had propped the door open.

In closing, while we are supportive of the new business, we respectfully request that Golden Eye Social confine all music and customer activity to the interior space—without propping doors open—in consideration of neighboring properties (Good Neighbor Policy.) For these reasons, we ask that the Entertainment Commission deny their POE application for amplified outdoor music and outdoor seating.



I am confirming receipt of your letter of opposition for Golden Eye Social's Place of Entertainment (POE) permit application and will include it in their file for my Commission to review.

I also wanted to mention that entertainment permits fall under my Commission's purview for enforcement and I have inspectors who respond to complaints in real time when they are in the field. If the business is found in violation of their permit, we have an enforcement escalation policy that starts with education, but can also result in citations with a monetary fine. And, if there are ongoing issues, my Commission can require the business to reappear before them at a hearing to potentially recondition their permit to have more restrictive days/times of entertainment.

Additionally, should the permit be granted, the business will have to comply with an approved sound limit set in accordance with Municipal Police Code Article 29, which outlines the City's sound ordinance. They must also have their doors and windows closed any time they host indoor entertainment, and for the outdoor amplified sound the volume of the prerecorded music should not exceed ambient levels at a distance of 50' from the property plane.

Lastly, please let me know if you'd like me to connect you with the owner, Kingston, to voice your concerns so he can address them directly. I've found that neighbors having direct lines of communication with operators is often the most effective way to mitigate any issues, and I know that Kingston is very open and willing to speak with anyone who has questions or concerns.

Dear Commissioners,

I am writing as a resident of Museum Parc to respectfully but strongly urge you to deny the Place of Entertainment permit application for Golden Eye Social, located directly across Third Street from our residential high-rise.

As proposed, this permit would allow amplified music, both indoors and outdoors, until 2:00 AM. In a dense, predominantly residential environment such as ours, this would create a significant and ongoing disturbance, with serious emotional, community, and financial consequences for the people who live here.

Museum Parc is a residential high-rise, not a nightlife district. Many of us work early hours, have children, are older adults, or are otherwise especially sensitive to chronic late-night noise. Allowing amplified music across the street until 2:00 AM would:

- Disrupt sleep and daily functioning, causing ongoing stress and

emotional strain.

- Undermine the sense of safety, comfort, and community that residents reasonably expect in their homes.
- Create a financial hardship by making units more difficult to rent or sell, and potentially diminishing property values due to increased noise and late-night activity.

A residential high-rise is simply not an appropriate place to be subjected to sustained, amplified music into the early morning hours. The impact would not be occasional or temporary; it would fundamentally change the living conditions for hundreds of residents who have built their lives here with the expectation of reasonable quiet at night.

For these reasons, I respectfully request that the Entertainment Commission deny the Place of Entertainment permit application for Golden Eye Social (Docket EC-1906).

As resident homeowners of Museum Parc condominiums (300 3rd Street), we were very pleased when Golden Eye Social moved into the long vacant space on the corner of 3rd and Folsom. Neighborhood businesses struggled post-pandemic and we were pleased that renovations had been made to the space and the business had opened.

We understand an original Golden Eye Social permit application, which had requested outdoor amplified sound, will now be modified to exclude outdoor music. Additionally, we ask the Commission ensure Golden Eye hold the indoor sound system down to reasonable levels, to reasonable hours – with doors closed.

Before Golden Eye submitted their POE application (with amplified sound ending by 10pm), the business held an event on the evening of 10/31 and crowds on the sidewalk did not disperse until well after midnight. The indoor sound system was also amplified and, with all the people out on the sidewalk in front, they had propped the door

open causing disruptive noise to neighboring residences.

While we are supportive of the new business, we respectfully ask that the Commission require Golden Eye Social to confine all music and customer activity to the interior space—without propping doors open—in consideration of neighboring properties and a good neighbor policy.

On behalf of the Museum Parc Homeowners Association, we write to strongly oppose the Golden Eye Social Club's application for a Place of Entertainment (POE) Permit, Docket EC-1906, on the December 16 Commission agenda.

Museum Parc is a 233-unit residential condominium at 300 Third Street, with many units facing directly toward the Golden Eye property. This area is primarily residential, and the proposed entertainment activities are wholly incompatible with our neighborhood.

Our concerns include:

- **Noise and Sleep Disruption:** The building's single-pane, floor-to-ceiling windows will not contain amplified music, indoors or outdoors, causing significant and persistent noise late into the night.
- **Impact on Property Values:** Continuous noise will make units facing the venue difficult to sell or rent.
- **Incompatibility with Residential Area:** Outdoor amplified music and indoor live performances will create a constant nuisance for Museum Parc residents and those in neighboring SoMa Square Apartments.

While we are amenable to outdoor seating for food service, any outdoor activity must conclude by 10:00 PM. **We cannot accept any outdoor or amplified music.**

Given the residential nature of the area and the impact on residents' quality of life, we strongly urge the Commission to **reject this POE permit application.**

My name is Michael Peng and I live at Museum Parc, directly across the street from Golden Eye Social.

I am writing to formally oppose the granting of a Place of Entertainment permit under Docket EC-1906.

While I support local businesses and even have been to and enjoyed my time at Golden Eye, the proposed hours and nature of this permit are fundamentally incompatible with the residential character of our immediate block.

My objection is based on the following concerns regarding noise and public nuisance:

1. Proximity and Sound Bleed: Because my apartment is directly across the street, allowing amplified music until 2:00 AM will inevitably cause sound to penetrate my living space during sleeping hours. Even with soundproofing, the bass from amplified entertainment travel through structures and are difficult to mitigate. The establishment has actually already played extremely loud music without a permit, and the bass and general noise levels were untenably high in a neighborhood that already suffers from public works and conference disruption.
2. Secondary Public Disruptions: A 2:00 AM permit invites late-night foot traffic, rideshare congestion, and noise from patrons lingering on the sidewalk to smoke or wait for transport. These disturbances often continue well past the venue's closing time, extending the disruption to 2:30 AM or 3:00 AM.
3. Quality of Life: As a resident, I would really prefer to have a quiet home at night.

Granting this permit would impose an unreasonable burden on my ability to sleep and function, significantly degrading the quality of life for myself and my neighbors.

I am a resident of Museum Parc, located directly across Third Street from Golden Eye Social, and I am writing to strongly oppose the Place of Entertainment permit requested under docket EC-1906 for the December 16 agenda.

Several residents have **already experienced amplified noise and low-frequency bass vibrations coming through walls** from this business **even though this permit has not yet been granted**. These vibrations are particularly disruptive, as bass noise travels easily through building structures and cannot be mitigated by closing windows or doors. This raises serious concerns about the level of impact the neighborhood would face if amplified music were officially permitted until 2:00 AM, both indoors and outdoors.

Golden Eye Social's proximity to a large residential community makes late-night amplified sound incompatible with the surrounding area. Sleep disruption, stress, and diminished quality of life are real and ongoing concerns for residents who live immediately nearby. Dear Members of the San Francisco Entertainment Commission,

I am writing to submit a formal public comment regarding Docket EC-1906, the application by Golden Eye Social for a Place of Entertainment Permit that would allow amplified music indoors until 2:00 AM. My household owns a condominium unit in Museum Parc, located directly across Third Street from the proposed establishment.

I respectfully urge the Commission to **deny this permit**.

Museum Parc is a densely populated residential building, and residents already experience substantial ambient noise from traffic, late-night activity, and general urban conditions along Third Street. Introducing an establishment authorized to play amplified music until 2:00 AM would materially worsen the noise environment for hundreds of residents directly opposite the venue.

While I understand the importance of supporting local businesses, the proposed operating conditions are incompatible with the residential nature of our building and the immediate neighborhood. Even with sound mitigation measures, the late hours and the proximity of the venue to homes make it extremely likely that amplified music will carry across the street and disrupt

residents' ability to rest.

For these reasons, I ask that the Commission consider the significant impact on the surrounding residents and decline to approve the requested Place of Entertainment Permit.

Thank you for your time and for your thoughtful consideration of this matter.

Dear Neighbors

My name is Kingston Wu. I am the Managing Member of Golden Eye Social that opened to the public in May 2025 as an augmented dart bart, and restaurant. *Our management team comprises the former General Manager and Beverage Director of District Wine Bar, and our Chef previously headed R&D at Black Sheep Foods, Asana, Alembic, and Town Hall Restaurants.*

As you are aware, we are applying for a Place of Entertainment (POE) permit. We want to invite concerned neighbors by our restaurant on **Tuesday, January 20<sup>th</sup> between 4pm to 6pm** where I will host you and walk you through our application, and address any concerns you may have. To accommodate this meeting date, we are deferring our POE hearing, yet again, to **February 3<sup>rd</sup> 2026 at 5:30pm in City Hall room 416**

As a reminder, we are applying for the POE permit so we can offer live music mid-week for private buy-outs and Moscone Center events, and on the weekends to liven the atmosphere. Please remember:

- Our business model is to be an elevated restaurant & lounge with music, not a nightclub and as such, we do not have a fixed DJ booth or dance floor
- We have not and will not charge “cover” to enter our restaurant
- We are currently open 5 days a week for dinner and we **already** have the ability to stay open until 2am each day and can play pre-recorded music with our existing sound system.

As a voluntary concession for our neighbors to address some initial reactions to our application, we will:

- Remove the request to add outdoor amplified sound for tables on the sidewalk.
- Limit our live entertainment past 10pm to Fridays and Saturdays and no more than 4 other days a month
- Offer to coordinate sound testing inside Museum Parc residences prior to our first live music night, to ensure our sound system does not elevate noise beyond regulated levels.

Two lovely ladies from Museum Parc came on by to chat with me today. One arrived at 5:20pm and another arrived at 5:45pm.

Both ladies were balanced in their approach to our application. They said that we deserved to have entertainment as the other businesses around us did, but wanted to make sure that they weren't kept up until 2am with loud music or woken by customers leaving our premises at that time.

One mentioned City Nights guests exiting the venue at 2am as the primary source of nuisance for residents living at the BACKSIDE of the building. She wanted to know our security plan and asked to ensure that guests were properly escorted off premise. She was glad to know we had one, and was further pleased when we mentioned our guests had access to the validated parking garage connected to our retail space,

Another was primarily concerned with music penetrating her unit during the night. She really liked my proposal to conduct sound tests in her unit (she lived on the 8th floor facing our restaurant) and limiting the sound to a level that didn't disturb her. She was more of a scientist type, and thought that would be a clean solution. I further offered to test out of various units on different floors facing our unit.

Both resident's contact information is below. I said that I would be happy to copy them on a sound test with someone from the Entertainment Commission, or simply myself with a decibel meter, or a third party, and electronically limit sound.

We individually toured the property, and clarified the current application points: Friday and Saturday until 2am, and no more than 4 more entertainment nights per month, with no outdoor amplified music.

Let me know if you have any questions or concerns. Seemed promising!

I have been a resident/owner in the neighborhood since 1989 - initially living in the apartments directly above GES and later relocating to the Museum Parc condominiums directly across the street from GES. I've always enjoyed the benefits of living in a thriving mixed-use urban neighborhood – we have a good mix of residential, commercial, conventions, sports, and tourist attractions. Most residents enjoy – or at least tolerate – the occasional venue buyouts during conventions, the traffic created during street closures for conventions or parades or protests or construction, the cheering in the streets when one of our local sports teams wins a game or championship but each of these events are one-offs even though there are a varied amount of one-offs in the neighborhood.

For the past 35 years that I have lived in this neighborhood, the space currently occupied by Golden Eye Social has always been a restaurant with bar service and good stewards of the neighborhood. GES, operating less than one year in the neighborhood, also operates with a Type 47 liquor license with the Alcohol Beverage Control as a restaurant with bar service until 2:00am. Dear Commissioners:

I am a [REDACTED] (Museum Parc), directly across from Golden Eye Social at 311 3rd Street. I previously submitted a letter of opposition on December 6, 2025, and have since corresponded with Deputy Director Kaitlyn Azevedo regarding this application. Deputy Director Azevedo has been very responsive to my communications, and I appreciate that.

I acknowledge that Golden Eye Social has withdrawn the outdoor amplified sound component from their application, and I appreciate that concession. However, I continue to have significant concerns about the indoor Place of Entertainment permit as currently proposed. I respectfully request that the Commission either deny the application or impose specific protective conditions that I outline below.

**This Application Seeks to Transform a Restaurant Into a Functional Nightclub**

Golden Eye Social holds a Type 47 liquor license as a restaurant with bar service. But the business they are describing—live entertainment until 2:00 a.m. on Fridays and Saturdays plus up to four additional nights per month—is functionally a nightclub, regardless of the licensing terminology. That could mean up to 12 nights per month of live entertainment until 2:00 a.m.

Notably, Golden Eye Social's current ABC license includes an operating restriction stating that "no noise shall be audible beyond the area under the control of the licensee." This restriction recognizes the residential context of this location. However, the same license provides that if the Entertainment Commission grants a Place of Entertainment permit, the noise limits in that permit override this default standard. In other words, approving this POE application would *loosen* the noise protections that currently apply to this premises—not tighten them. The Commission should weigh this carefully.

This application represents a fundamental change from the restaurant-type establishments that have occupied this space for more than three decades. The location at 311 3rd Street was previously home to Max's Delicatessen for many years, followed by Osha Thai, which operated there for approximately 20 years until Golden Eye Social took over the space in May 2025. Throughout this entire period, the space functioned as a restaurant, not as an

entertainment venue.

The space was designed and built out as a restaurant. It lacks the acoustic infrastructure—such as double-pane windows, sound isolation, and physical depth providing separation from the street—that purpose-built entertainment venues incorporate.

Critically, this space sits directly below the St. Francis Place apartments (SoMa Square) and directly across 3rd Street from Museum Parc, a 234-unit condominium building. No resident of either building purchased or leased their home expecting a late-night entertainment venue in this location. Approving this permit would impose a significant and permanent change on a residential corner that has never hosted this type of use.

### **Pre-Approval Sound Testing Is Essential**

In his January 12, 2025 letter to neighbors, Mr. Kingston Wu offered to "coordinate sound testing inside Museum Parc residences prior to our first live music night, to ensure our sound system does not elevate noise beyond regulated levels." I appreciate the gesture, but this approach is backwards. Sound testing should occur *before* the Commission grants the permit, not after. Conducting tests after approval asks residents to trust that problems will be remediated rather than prevented, and it deprives the Commission of empirical data that would inform its decision.

The Commission routinely sets specific internal sound limits as permit conditions—for example, 88dBA/100dBC or 97dBA/100dBC measured at designated locations. If such limits are material to the permit, then actual measurements taken before the hearing would demonstrate whether this venue's physical characteristics can realistically meet those standards.

Golden Eye Social occupies a former restaurant space. I understand the building has single-pane windows and is not a deep space with significant acoustic separation from the street. These structural realities should be evaluated through testing before approval, not assumed away or left for post-hoc enforcement.

**Request:** I ask that the Commission defer action on this application until Golden Eye Social conducts sound testing at actual performance volume, with measurements taken both inside the venue and inside Museum Parc units facing 3rd Street. Results should be submitted to the Commission and affected neighbors before any hearing.

### **Patron Egress and Public Safety Concerns**

My concerns extend beyond sound transmission through walls. When a venue closes at 2:00 a.m., concentrated groups of patrons exit simultaneously onto the sidewalk. They wait for rideshares, smoke, and continue conversations—all generating noise that requires no permit but significantly disturbs residents trying to sleep. This is particularly problematic on 3rd Street, where sound reflects off the buildings on both sides.

I am also concerned about crime associated with late-night entertainment venues in this area. The SoMa neighborhood has documented incidents of violence connected to nightlife. Temple Nightclub at 540 Howard Street (approximately two blocks away) was the site of a 2011 incident in which a medical student was beaten to death and two other men were stabbed the same night. The Entertainment Commission ordered that club to improve security. In 2016, a

fatal shooting occurred at a nightclub on the 400 block of 6th Street. More recently, in 2023-2024, there have been assaults and robberies connected to SoMa entertainment venues.

I am not suggesting Golden Eye Social would operate irresponsibly. But the Commission should recognize that adding another late-night entertainment venue to this residential corner increases the probability of incidents, and the burden of that increased risk falls on residents who did not choose to live near a nightclub.

### If the Commission Is Inclined to Approve, Specific Conditions Are Necessary

Should the Commission determine that approval is appropriate, I respectfully request the following conditions:

1. **Sound mitigation upgrades:** Require installation of double-pane windows and any additional soundproofing necessary to ensure that interior sound levels do not produce measurable increases in ambient noise inside Museum Parc units, with verification testing before live entertainment commences.
2. **Lower sound limits:** Set internal sound limits at the lower end of the range the Commission has approved for similar venues, given the immediate proximity to residential buildings.
3. **Earlier end times on weeknights:** Limit entertainment to 11:00 p.m. on Sunday through Thursday. The proposed "no more than 4 other days per month" beyond Friday and Saturday could mean up to 12 nights per month of entertainment until 2:00 a.m.—an unacceptable burden on residents.
4. **Patron dispersal requirements:** Require dedicated security presence on the 3rd Street sidewalk from 30 minutes before closing until 30 minutes after closing, with responsibility for actively dispersing patrons and preventing congregating, loitering, or queuing on the sidewalk.
5. **Coordination with SFPD Southern Station:** Require a formal coordination plan with the Southern Station (located nearby at 1251 3rd Street) for nights when entertainment is scheduled.
6. **Expedited review trigger:** If the Commission receives more than three verified noise or disturbance complaints from distinct households within any 60-day period, require Golden Eye Social to appear before the Commission for potential reconditioning without the usual escalation process.

### Conclusion

The Entertainment Commission's mission includes balancing the needs of entertainment venues with those of neighbors. In this case, the neighbors include hundreds of residents in two residential buildings immediately adjacent to the proposed venue. We are not opposed to Golden Eye Social operating as the restaurant it is currently licensed to be. We are opposed to the transformation of this corner into a late-night entertainment district.

I intend to attend the February 3, 2026 hearing and speak during public comment. I am sharing this letter with my neighbors at Museum Parc and encouraging them to attend or submit their own comments.
