Hello,

I am confirming receipt of your letter of opposition for RT Bistro and will include it in their file for my Commission to review.

I also wanted to provide some context about the Fixed Place Amplified Sound (FPAS) permit for your awareness. Should the business be approved for the permit they would be conditioned so that the amplified sound cannot exceed ambient volumes at a distance 50' from the property plane. Additionally, entertainment permits fall under my Commission's purview for enforcement and I have inspectors who respond to complaints in real time when they are in the field. If the business is found in violation of their permit, we have an enforcement escalation policy that starts with education, but can also result in citations with a monetary fine. Additionally, if there are ongoing issues, my Commission can require the business to reappear before them at a hearing to potentially recondition their permit to have more restrictive days/times of entertainment.

Please let me know if you'd like me to connect you with the owner to voice your concerns so they can address them directly. I've found that neighbors having direct lines of communication with the permit holder is often the most effective way to mitigate any issues.
