Dear President Clay and Honorable Commissioners,

The South of Market Business Association (SOMBA) recognizes the importance of establishing police district boundaries that are both operationally effective and responsive to the communities they serve. We understand and appreciate the thoughtful work being done to improve public safety across San Francisco.

We are aware that the Police Commission has accepted a report—including a Recommended Map—which has been forwarded to the Mayor and Board of Supervisors. We fully support this map, which provides appropriate coverage for the Tenderloin, Lower Polk, and Lower Nob Hill neighborhoods.

As for the South of Market (SoMa) area, we believe it is both logical and necessary to move the Tenderloin Station boundary north of Market Street. Sixth Street—particularly the portion currently under Tenderloin's jurisdiction—continues to suffer from serious and persistent quality-of-life issues. These challenges often fall outside of Tenderloin Station's effective reach, requiring us to contact both Tenderloin and Southern Stations for assistance. This dual reporting structure has led to confusion, delays, and diluted accountability.

We therefore strongly recommend that Southern Station assume full responsibility for Sixth Street and the surrounding area south of Market. Assigning dedicated officers from Southern Station would result in faster response times, more consistent service, and improved coordination with community stakeholders. While we acknowledge the ongoing demands faced by Tenderloin Station, the worsening conditions on Sixth Street require focused attention and immediate action.

We urge the Commission to also ensure that Sixth Street receives the dedicated resources it deserves. Realigning the boundary to place this corridor fully within Southern Station's jurisdiction would promote clearer communication, faster deployment of resources, and more unified support for revitalization efforts.

Although SOMBA is rooted in SoMa, we regularly collaborate with business associations across the city and fully support the recommendations submitted to you by the broader coalition. We respectfully urge the Commission to adopt the proposed boundaries that reflect this unified and community-driven vision.



Where we are now



What could this mean?

60-90K service calls annually could be added to Southern's already stretched workload...it has the most Priority A calls of any district

To balance the added calls, part of Mission Bay could be shifted to Bayview. The two foot beat officers dedicated to the area around the Embarcadero Navigation center– already only staffed on a voluntary overtime basis—would certainly never get staffed.



Recommended Changes

#1 - From Tenderloin to Southern: boundary moves from Mission St. to Market St. between 3rd St. and 9th St.

#7 From Central to Southern: boundary moves from Mission St. to Market St. between Steuart St. and 3rd St.

#8 - From Southern to Bayview: boundary moves from 16th St. to Mariposa St. between Illinois St & Vermont St then extends to Division St, Townsend St, and I-280

#9 - From Southern to Mission: area bounded by Mission St., 9th St., Division St., 13th St., and South Van Ness Ave moves from Southern to Mission

#10 - From Southern to Northern: area bounded by Market St., South Van Ness Ave, 13th; St. Duboce Ave moves from Southern to Northern

Proposed Map

In September, the Proposed Map option was created in response largely to internal SFPD feedback, leadership discussions, and from some community feedback.

The Proposed Map considered heavily the staffing constraints the SFPD currently faces. The driving strategy was to suggest changes that would benefit the department but would not require resource adjustments to enact.

As a result, five changes were suggested and agreed upon by the collective present.



After the creation of the Proposed Map, the ARCBridge team ran a series of data comparisons to evaluate what these changes could mean for the department's delivery of services.

Data comparisons were also conducted evaluating Calls between the current (As-Is) to the Recommended Map.

Hi Alice.

I'm always happy to answer questions or help out. I haven't heard that there is a renewed push to change boundaries again. Since nothing has changed on our end as our staffing shortages remain the same, I don't see it being feasible to bush our boundaries to Market. I certainly would speak out against it for all the same reasons as before.

I believe the estimate of increased number of calls was 90,000 per year for the new Southern District. This was for the first proposal. In order to manage that many additional calls, our staffing would need to double which is currently impossible.

The officers assigned to the Hospitality Zone Task Force (HZTF) are all assigned to Southern. There was 1 Lieutenant, 1 sergeant, and 6 officers that were transferred to Southern Station to be part of the HZTF. We had shifted 1 officer from partol to the HZTF. They don't handle many calls for service because their roll is to be visible on their beat. They do handle calls from time to time, but I don't have the exact number now. They have prevented calls for being on their beat through being flagged down or deferring crime. These can be hard to quantify, but it is certainly happening.

I hope this helps. My last day is tomorrow. Lt. Dien Ha or Lt. Ryan Crosby will be filling in until the Chief announces my replacement. They can be reached at Dien.X.Ha@sfgov.org and ryan.crosby@sfgov.org.

I'm writing to express my full and urgent support for redrawing the boundaries of the Tenderloin Police Station, as outlined in the "Recommended Map" submitted by the Tenderloin, Lower Polk, and Lower Nob Hill coalition.
