Item 1.0 Call to Order by Commissioner Mason, Roll Called by the BHC Clerk.

Item 4.0 It was discussed to avoid repeated site visits to the same programs within a short period. It was suggested reviewing the past six years with consideration of covid -related disruptions. Prioritize based on Commission goals such as a focus on adults, youth, families, and veterans. Programs are funded by behavioral health services. Consider programs with higher number of grievances are complaints. Check contracts for programs to align visits with oversight responsibilities.

- Jessie the enhanced oversight of third-party contracts especially those involving crisis centers and underutilize facilities
- Site utilization: noted the need to promote crisis centers to marginalized populations and ensure they have accessible and well publicized
- Prospective commissioner’s comments expressed eagerness to contribute and concerns about the appointee process
