Additionally, Acceptance Place aims to reduce the impact of chemical dependency in the population of gay and bisexual men, and Joe Healy Detoxification Program is a medically managed residential detoxification, treatment and education program with a length-of-stay of up to 7 days for alcohol withdrawal, 14 days for benzodiazepine withdrawal, and 12 days for prior-authorized opiate withdrawal.
