Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott, reported on crime trends YTD: Violent Crime down 13 percent; homicide down 200 percent; rape down 54 percent; robbery down 24 percent; assault up 5 percent; human trafficking down 33 percent. Property Crimes down 39 percent; burglary down 32 percent; motor vehicle theft down 42 percent; arson up 41 percent; larceny theft down 40 percent. Gun violence is up 0 percent compared to 2024; One non-fatal shooting incident this week; total 15 fire-arm related

incidents resulting in 17 victims YTD. One homicide for the week; there is a total of 1 homicide YTD with 1 resulting from a firearm; 300% overall clearance.

Significant Incident: Assault on Officer with vehicle, 2/6/25 17:50, 9th, Southern, Officers located a stolen vehicle as a result of a Flock ALPR notification, suspect took off in stolen vehicle, fled with vehicle and subject car collided with patrol vehicle as suspects were leaving scene, no arrests made, investigation ongoing. 6th and Natoma Traffic Collision, driver struck pedestrian in crosswalk, serious injuries, victim did survive. Fatal Traffic Collision, 2/7/25 16:27, Jones St, Central, solo scooter crashed into a pole, person transported, did not survive injuries. Police pursuit on Sunday, 24th and Van Ness, Mission, Officers notified via Flock notification for a wanted vehicle, vehicle wanted for felony grand theft out of Berkeley, CA, Officers tried to initiate a stop on the car, driver did not stop, turned into a pursuit, started around Stonestown area and terminated at 24th and South Van Ness, suspect's vehicle hit an occupied parklet, 6 injured, side swiped vehicles.
