Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott, reported on crime trends YTD: Violent Crime down 13 percent; homicide down 200 percent; rape down 53 percent; robbery down 24 percent; assault up 5 percent; human trafficking down 33 percent. Property Crimes down 37 percent; burglary down 30 percent; motor vehicle theft down 41 percent; arson up 9 percent; larceny theft down 38 percent. Gun violence is up 5 percent compared to 2024; Three non-fatal shooting incidents this week; total 18 fire-arm related incidents resulting in 20 victims YTD. No homicides for the week; there is a total of 1 homicide YTD with 1 resulting from a firearm; 300% overall clearance.

Significant Incident: Three non-fatal shootings. Non-fatal shooting on 2/13/25, time not determined, victim self-transported, victim claimed someone he knew shot and robbed them, victim in stable condition, suspect's identity still being investigated, according to victim happened at area of Polk and Larkin. Non-fatal shooting on 2/16/25 00:30, Sutter and Polk, Northern, Officer responded to hospital

for victim who self-transported with gunshot wound, advised in area when heard gunshot and felt pain, no further information provided, no arrest, investigation ongoing.

Significant arrest: Non-fatal shooting at 2/12/25 12:46, Sunnydale and Sawyer, two groups shooting at each other, stray bullet struck an uninvolved victim, transported in stable condition, one arrest, investigation ongoing. Arrest made in a 2022 Homicide case, on 8/1/22 victim shot multiple times in unit block of Brookdale, victim succumbed to injuries, during investigation evidence located, two years later investigators received information from that evidence that identified one of the possible perpetrators, on 2/12/25 suspect located and arrested, handled through the juvenile justice system as suspect was 16 years old at time of incident. Robbery on 3300 block of Fillmore, 2/14/25 afternoon, victim at work, suspect entered pointed a gun and demanded property, suspect fled on foot, later located, detained and arrested by responding Officers. Assault with knife, 2000 block of Mission, 2/11/25 16:30, victim followed into location by suspect who brandished knife and attempted to stab victim, struggled ensued, knife caused laceration to victims hands, victim transported, in stable condition, suspect arrested at scene.

Strategies: Wanted to highlight NBA All Star Game and Chinese New Year Parade and all the work that went into that, with multiple city departments – no significant incidents and/or crime associated with NBA All Star Game. Thanked all Officers and city employees working these events. Chinese New Year Parade went off without a hitch, very well attended, no crime incidents, very good event – thanked all participants. Sideshow activity in Bay Area over weekend -clarify some of the information that have gone out through some media outlets- there were no sideshows in San Francisco, there was a sideshow around 02:30 on the Bay Bridge, handle by CHP and assistance of SFPD, busy night, around 21:30 advised by outside Police Department that sideshows were occurring outside of San Francisco, and started coordination, advised that small group actively involved in sideshow were heading toward San Francisco across Bay Bridge, disrupted by CHP and went back East. Stunt Driving Response Unit activated, reported scouting cars throughout the night. Assisted Daly City PD about 02:00 when hundreds of vehicles ended up in Daly City, fireworks set off and vehicles fled, at least one arrest and two cars impounded.

Thierry F.: Spoke about Lunar New Year and year of the snake and taking care of the future. Paulette Brown: Spoke about son, Aubrey Abrakasa's, murder, asked for focus on unsolved homicides, referencing homicide clearance rate. Continued to speak about son.

Tenderloin, 3. Airport, 1. Not Applicable, 1. Out of Jurisdiction, 1. Pending, 2. Allegation Summary: Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-19%. Use of Force-The officer failed to comply with Department General Order 5.01-10%. Neglect of Duty-The officer drove a City vehicle in a grossly negligent or reckless manner-10%. Neglect of Duty-The officer failed to properly investigate-6%. Conduct Unbecoming an Officer-The officer failed to write an incident report-6%.

Audits: DPA is initiating an audit of SFPD's use-of-force, as required by Charter.

Outstanding Issues: DPA brought on three new interns for the Spring semester and recently opened applications for our Summer internship program.

Public comment shall be open for a minimum of 90 days, and final action shall be taken no earlier than May 20, 2025.
