

Summary of Complaints Received in February 2026


The Department of Police Accountability received a total of **69** cases in **February 2026**, **67** SFPD complaints and **2** SFSO complaints. Compared with a total of **106** cases, **105** SFPD complaints, and 1 SFSO complaint in the same period last year, the **February 2026** case total is **1%** higher than the five-year average and is **35%** lower than the previous year.

Currently, DPA has a total of **233** pending cases, **196** SFPD and **37** SFSO.

In February, DPA received no referral(s) from SF Sheriff's Office and referred a total of **2** case(s) to SFSO.




Year to Date Monthly Count of Cases Received (SFPD+SFSO)
