First Amendment to

Memorandum of Understanding between

City and County of San Francisco

and San Francisco Community College District

THIS AMENDMENT (this "Amendment") is made as of February 15, 2019, in San Francisco, California, by and between **San Francisco Community College District** ("City College"), and the **City and County of San Francisco**, a municipal corporation ("City"), acting by and through its Department of Children, Youth & their Families.

Recitals

WHEREAS, City and City College have entered into the Memorandum of Understanding, dated July 13, 2017, to fund and support the Free City College Program; and

WHEREAS, City and City College desire to modify the Memorandum of Understanding on the terms and conditions set forth herein to fund Free City Summer Session for the school year of 2018-2019; and

WHEREAS, approval for funding Free City Summer Session was obtained when City's Board of Supervisors approved a budget covering City College's school year of 2018-2019;

NOW, THEREFORE, City and City College agree as follows:

Article 1 Modifications to the Memorandum of Understanding

The Agreement is hereby modified as follows:

1.1 Section 1.1, subparagraph (c) of the July 13, 2017 Memorandum of Understanding currently reads as follows:

"BOG Eligible Student" shall mean an Eligible Student who has qualified for a California Community Colleges Board of Governors Fee Waiver.

Such section is hereby amended in its entirety to read as follows:

"BOG Eligible Student" shall mean an Eligible Student who has qualified for a California College Promise Grant.

- 1.2 Section 5.1 currently reads as follows:
 - 5.1 **Maximum Amount of Funds.** In no event shall the amount of Funds disbursed hereunder exceed eleven million, two hundred and thirty-three thousand, nine hundred and four Dollars (\$11,233,904).

Such section is hereby amended in its entirety to read as follows:

5.1 Maximum Amount of Funds. In no event shall the amount of Funds disbursed hereunder exceed twelve million, four hundred and thirty-three thousand, nine hundred and four Dollars (\$12,433,904).

Article 2

Effective Date

Each modification set forth in Article 1 shall be effective on and after the date of this Amendment.

Article 3

Legal Effect

Except as expressly modified by this Amendment, all of the terms and conditions of the parties' July 13, 2017 Memorandum of Understanding shall remain unchanged and in full force and effect.
