- Information was presented on how the SFDPH Health Care for the Homeless

collaborates with other San Francisco Federally Qualified Health Centers (FQHCs) and hospitals, including sharing an organizational chart that shows that the SFPDH includes its own major Trauma 1 hospital and a rehabilitation center. Collaboration with the San Francisco Community Clinic Consortium and its member clinics, many of which are San Francisco FQHCs, was discussed as well.

- The sliding fee scale and policy was presented. Sliding fee discounts apply for uninsured HCH clients when accessing HCH program services. SFDPH has a nominal fee of \$0 for clients with income under 100% of the Federal Poverty Line and a sliding fee scale for those with income over 100% of the Federal Poverty Line.

  - Patient Satisfaction and Patient Grievances
  - o Review Efficiency and Effectiveness of the Health Centers
