- **Agenda #8: Bill Blum announced that the New Director of Primary Care will be announced very soon. Beth Neary announced that the next Health Care for the homeless federal audit will be at the end of January 2024.**
- **Agenda Item #10: Emily Kehl applied to be a member HCH Co-Applicant Board. Emily is no longer a City employee and works at a non-profit focused on housing security and is now eligible to join the board as a San Francisco community/non-patient representative. HCH CAB will vote on membership at a future meeting with quorum.**

 - **Suggestion to add the following to the form:**

- **HCH CAB reviewed draft Health Care Industry Definition for the San Francisco Health Care for the Homeless Co-Applicant Board. HCH CAB confirmed the Health Care Industry proposed definition captured the collective recommendations and was adequately clear.**

- **Action Item #12: Beth Neary presented on the Sliding Fee Scale and Sliding Fee Scale Analysis.**
 - Typo was noted on “4)” where 500% FPL should be updated to 550%.
 - Also group recommended a note be added to specify the median income in San Francisco for better framing of why SFHN has a sliding fee scale (funded by local funding) that extends to 550% FPL as opposed to a HRSA required scale going only up to 200% FPL. The very high local cost of living influences the local government to fund health care services to uninsured clients who might otherwise not seek needed health care.
