RE: **Annual Report of Gifts Received in FY 2024-25**

As required by section 10.100-201 of the San Francisco Administrative Code and consistent with the policy and procedure for the acceptance of gifts adopted by the Health Commission in October 1995, this is the annual report of gifts received in FY 24-25.

During FY 24-25, DPH received approximately \$1.9M in gifts from 26 separate donors. The majority of gifts were donations to Laguna Honda Hospital, totaling approximately \$1.3M mainly for the care, general benefit and comfort of patients. Separate donations totaling approximately \$505K and \$13K were made to Central DPH and Zuckerberg San Francisco General Hospital, respectively.

Gifts received during FY 24-25 substantially increased from the prior year due to the donation of Covid-19 test kits from state sources, which accounted for over \$1.3M of the approximately \$1.9M received during FY24-25.
