Purpose of Agreement:

This Agreement will support the Community Health Workers (CHW) and Medi-Cal Reimbursement Pathways Pilot Services, a citywide CHEP initiative designed to expand San Francisco’s CHW capacity and prepare community-based organizations for sustainable Medi-Cal reimbursement under CalAIM. Activities for this Medi-Cal reimbursement pilot billing will include CHW-delivered, culturally relevant, community-centered chronic disease prevention strategies, health education, outreach and engagement, screenings, navigation support, linkage to Enhanced Care Management (ECM) and Community Supports, follow-up to address social determinants of health to ensure collaborative workflows, assessment of dietary chronic disease outcomes, and feasibility of medical-billing within CBO infrastructure which will include the tracking the percentage of services that are eligible for Medi-Cal billing. This also funds organization infrastructure development and review of billing systems that include CHW training, documentation standards, revenue cycle processes, workflows, data systems, and quality improvement activities. This program is designed to support San Francisco residents disproportionately impacted by chronic disease, including but not limited to Black/African American, Native Hawaiian/Pacific Islander, Latinx, Native American/American Indian, Asian/Asian American, and other vulnerable communities. Outreach prioritizes neighborhoods with historical health disparities and limited access to prevention services where chronic disease disparities and barriers to care are most concentrated.

All My Usos (AMU) is a San Francisco community-based organization committed to advancing culturally responsive frontline health services, intergenerational wellness, and health equity through education, outreach, and community capacity building. In addition to direct health services, AMU has led long-standing community-building initiatives that include working towards promoting health access and chronic disease prevention in communities most impacted by health disparities. Since 2017, AMU has provided cohort-based programs and culturally responsive resource navigation. In 2023, AMU played a leading role in recruiting, training and supporting the first and largest cohort of Pacific Islander students to enroll in the City College of San Francisco (CCSF) Community Health Worker (CHW) program and as a result 9 community leaders successfully completed the program. AMU’s CHW services deliver chronic disease prevention to reduce barriers to care and improve health outcomes for Medi-Cal beneficiaries and uninsured community members.

All My Usos was selected under RFP SFGOV0000011360 – Community Health Worker and Medi-Cal Reimbursement Pathways Pilot Services. All My Usos was one of the highest ranked proposers. The RFP allows for an Agreement of up to 10 years which includes contract options which may or may not be exercised with an initial one-year term with a five one-year option to extend.
