Everyone attending the meeting in person is encouraged to wear a mask throughout the meeting. Each member of the public attending in person may address the Commission for up to two minutes. Public speakers using consecutive interpretation assistance will be allowed to speak for twice the amount of the time.

1. Call to Order and Roll Call

Chair Souza called the meeting to order at 5:45 p.m.

2. Ramaytush Ohlone Land Acknowledgment

We, the San Francisco Immigrant Rights Commission, acknowledge that we are on the unceded ancestral homeland of the Ramaytush Ohlone who are the original inhabitants of the San Francisco Peninsula. As the indigenous stewards of this land and in accordance with their traditions, the Ramaytush Ohlone have never ceded, lost nor forgotten their responsibilities as the caretakers of this place, as well as for all peoples who reside in their traditional territory. As guests, we recognize that we benefit from living and working on their traditional homeland. We wish to pay our respects by acknowledging the ancestors, elders and relatives of the Ramaytush Community and by affirming their sovereign rights as First Peoples.

Chair Souza read the land acknowledgment statement.

6. Chair Reports

a. Commission Streamlining Task Force Update (Director Rivas)

This item is to allow Director Rivas to provide an update on the work of the Commission Streamlining Task Force and allows Chair Souza to discuss actions the Commission can take.

Director Rivas provided an overview of the work of the Commission Streamlining Task Force. Clerk Shore has submitted a questionnaire on the Immigrant Rights Commission, and OCEIA has posted information on social media. The Task Force will discuss its recommendations for the Immigrant Rights Commission on October 15, 2025 and Commissioners are encouraged to share with their networks. Members of the public can send letters to the Task Force to inform the recommendations and attend the October 15 meeting to respond to the recommendations. Commissioners discussed how to encourage community members to get involved, and Chair Souza continued the item to the next Executive Committee meeting.

b. Upcoming Hearing on Sanctuary City Policy (Commissioner Obregon)
This item is to allow Chair Souza and Commissioner Obregon to discuss plans for an upcoming IRC hearing on sanctuary city policy led by Commissioner Obregon.

Director Rivas provided an update on Commissioner Obregon's plans for the IRC hearing on sanctuary policies, which is being planned for October 27, 2025.

Commissioner Wang suggested inviting the airport director to an upcoming meeting, and Chair Souza said the item would be discussed at the next Executive Committee meeting and invited Commissioner Wang to join the meeting.
