I am writing in strong support of Bulo Shoes for inclusion in the Legacy Business Registry. The business meets all of the requirements for Registry status and has been a significant cultural anchor in Hayes Valley for over three decades.

Bulo Shoes first opened on Hayes Street on December 3, 1994, and has operated continuously in San Francisco ever since, with no break in service other than the temporary, mandatory shutdown during the COVID emergency. The business has remained rooted in District 5 for more than thirty years, satisfying the Legacy Business program longevity requirement, but more importantly, it has evolved from a single storefront into a longstanding neighborhood institution.

Bulo Shoes has also made a lasting contribution to the identity of Hayes Valley. The store was one of the first in San Francisco to bring contemporary Italian footwear and designer craftsmanship to a neighborhood that was just beginning to re-establish its commercial identity in the 1990s. Its curation of independent, hard-to-find makers helped define Hayes Valley's reputation as a hub for design-forward, small-scale retail. The store has been featured in local and national publications for its influence on the area's style and culture, and its customer base spans generations of San Franciscans. Alongside its economic role, Bulo Shoes participates in community events, supports local nonprofits, and is an active member of the Hayes Valley Merchants Association, reinforcing its value to the neighborhood's history and character.

Finally, Bulo Shoes remains committed to preserving the traditions that have defined the business since its founding. The store continues to focus on craftsmanship, quality materials, and personal service, sourcing footwear and accessories from independent designers and long-established makers. The owner plans to continue operating the business for years to come and is exploring long-term

succession options to ensure the continuity of its defining traditions well beyond the current ownership.

Bulo Shoes is exactly the kind of longstanding, community-serving business the Legacy Business Registry exists to recognize and support. It reflects the cultural identity of Hayes Valley, provides stability to the local commercial corridor, and preserves a craft-based retail tradition that is increasingly rare in San Francisco.

For these reasons, I strongly encourage the Commission to approve Bulo Shoes' application.

Written Historical Narrative

Introduction

a. Describe the business. What does it sell or provide?

Bulo Shoes is a retail store offering footwear and accessories for both men and women from hard-to-find designers who use high-quality materials in unique ways.

b. Describe whom the business serves.

Most of Bulo Shoes' customers are regular ones who have supported the business for decades. It serves the Hayes Valley, Lower Haight, and Cow Hollow neighborhoods. In the early 2000s, it also started having a presence online. The general demographic of Bulo Shoes is women from 25 to 65 years old. Women represent about 75 percent of the sales. The rest of the sales are from men within the same age range.

c. In about 2-5 words (15-30 characters), describe what the business is known for.

Hard-to-find, quality shoes.

Criterion 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

a. Provide a short history of the business, including locations and owners.

Bulo Shoes was established by Enrico Perella on December 3, 1994, at 437-A Hayes Street in the Hayes Valley neighborhood.

Enrico opened the store armed with an MBA in Business & Marketing and many years of customer service experience. Working closely with friends in the industry back home in Italy, he filled his new store with an eye-catching array of Italian footwear, and San Francisco couldn't get enough! Enrico watched Hayes Valley transform into a popular shopping destination, and he curated his collections accordingly. He was among the very first to sell CYDWOQ shoes and first introduced the United States to Alberto Fermani Shoes, Officine Creative, Lemargo, Pantanetti, and more.

On December 6, 1996, Bulo Shoes opened a second location in Hayes Valley at 418 Hayes Street. Enrico wanted to divide the store into women's and men's shoes, so for logistical and strategic reasons, he took the opportunity to rent 418 Hayes Street, which has a basement to stock more inventory for online sales.

In January 2000, an LLC was created, and Mauro Giuli joined the business as a co-owner. Mauro, at the time, had around 60 stores in Italy under his name, Mauro Giuli, and was one of the main suppliers of Bulo Shoes. Enrico had been collaborating with Mauro before 1994 with some American brands that Mauro was selling in Italy. The two had the idea of opening a shoe store in San Francisco. Enrico opened the store in 1994, and Mauro was supplying most of the shoes for the first season. Then Enrico started buying different brands to change the mix of merchandise. Mauro officially joined Bulo Shoes as a co-owner in 2000.

On November 1, 2000, a third location of Bulo Shoes opened at 3044 Fillmore Street in the Pacific Heights neighborhood. Enrico and Mauro wanted to serve a different part of San Francisco. Because the rent was very high, the 3055 Fillmore Street location closed on July 31, 2005, when the five-year lease expired.

On June 15, 2009, during the Great Recession, the original location at 437-A Hayes Street closed, leaving only one location of Bulo Shoes at 418 Hayes Street, where it remains today.

In 2010 during the recession, Enrico Parella bought out Mauro Giuli and once again became the sole owner of the business. Business was slow during the recession, and Enrico and Mauro had different ideas on how to run the business and which kind of shoes to carry.

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

The only time that Bulo Shoes closed was from March to June of 2020 due to mandatory closures during the COVID pandemic.

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Bulo Shoes has contributed to the history and identity of Hayes Valley and San Francisco. The business was one of the first retail shoe stores to offer related unknown Italian shoe brands with the same speed of fashion that was happening in Italy. At Bulo, centuries-old shoemaking

traditions and contemporary design go hand in hand. They love to work with new and hard-to-find designers who use high-quality materials in unique ways. In the store, you can find Cydwoq sandals made by hand in California, classics from Blundstone and comfortable flats from Yuko Imanishi. They also have a large selection of Italian lines: Pantanetti, Lemargo, Lemare, Halmanera and many more. Trippen, Fiorentini + Baker, Kork-Ease and Saola are also available all year round.

b. Is the business associated with significant people or events, either now or in the past?

Over the years, Bulo Shoes has had actors, singers, and mayors as patrons. Customers have included Robin Williams, members of the band Metallica, Tom Waits, Mayor London Breed, and others.

c. How does the business demonstrate its commitment to the community?

Over the years, Bulo Shoes has donated to the AIDS Foundation and other nonprofit organizations. The business is also a member of the Hayes Valley Merchants Association and neighborhood cleaning activities.

d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

Years ago, Bulo Shoes was featured in a local small newspaper, a design magazine for the lights and floor of the store, and an industry magazine. Following are some other media references listed from newest to oldest:

Bulo Shoes was recognized for having the “Best Shoes” per San Francisco Magazine’s 2025 Best of the Bay Winners.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If Bulo Shoes were to close, their clientele would lose the experience of shopping for shoes and handbags that are selected from both Europe and the United States. Having a physical store enables shoppers to touch and try on the merchandise. Also, several employees would lose their jobs, including some who have worked there for decades.

The owner is planning to run the business for at least another five years with the possibility of converting the business to employee ownership or passing it on to a family member.

d. What challenges is the business facing today?

The biggest challenge right now is the uncertainty of the duties on imports, which are mostly from Europe. This could have a great impact on the price the business can charge their customers. Also, the level of foreign tourists visiting Hayes Valley has decreased, which has had an impact on sales.

Business Description

Bulo Shoes is a specialty retail store offering footwear and accessories for both men and women, featuring hard-to-find designers known for using high-quality materials in distinctive ways. The majority of Bulo Shoes' customers are local, long-time patrons who have supported the business for decades. The store primarily serves the Hayes Valley, Lower Haight, and Cow Hollow neighborhoods, while also maintaining an online presence that began in the early 2000s. Bulo Shoes' core demographic consists of women aged 25 to 65, who account for approximately 75 percent of sales; the remaining sales come from men within the same age range.

Bulo Shoes was founded by Enrico Perella on December 3, 1994, at 437-A Hayes Street in San Francisco's Hayes Valley neighborhood. Armed with an MBA in Business and Marketing and extensive customer service experience, Enrico opened the store with a carefully curated selection of Italian footwear sourced through close relationships with friends and industry contacts in Italy. The unique and fashion-forward assortment

quickly resonated with San Francisco customers. As Hayes Valley evolved into a prominent shopping destination, Enrico adapted the store's collections to match the neighborhood's changing character. He was among the first retailers to carry CYDWOQ shoes and introduced several brands to the United States, including Alberto Fermani, Officine Creative, Lemargo, and Pantanetti.

On December 6, 1996, Bulo Shoes expanded with a second Hayes Valley location at 418 Hayes Street. This expansion allowed the business to separate women's and men's footwear and provided a basement space to accommodate additional inventory for online sales. In January 2000, Bulo Shoes became a limited liability company, and Mauro Giuli joined as co-owner. At the time, Mauro owned approximately 60 stores in Italy under the Mauro Giuli brand and was a key supplier to Bulo Shoes. Enrico and Mauro had previously collaborated prior to 1994, working with American brands that Mauro distributed in Italy.

On November 1, 2000, Bulo Shoes opened a third location at 3044 Fillmore Street in the Pacific Heights neighborhood to reach a broader segment of San Francisco customers. However, due to high rent, the Fillmore Street location closed on July 31, 2005, at the end of its five-year lease. During the Great Recession, the original Hayes Valley location at 437-A Hayes Street closed on June 15, 2009, leaving the store at 418 Hayes Street as Bulo Shoes' sole remaining location, where it continues to operate today.

In 2010, amid ongoing economic challenges, Enrico Perella bought out Mauro Giuli and resumed sole ownership of the business. Sales had slowed during the recession, and differences in vision regarding operations and product selection ultimately led to the separation. Despite these challenges, Bulo Shoes endured, maintaining its reputation for quality, craftsmanship, and distinctive footwear.

Staff Analysis

Review Criteria

1. When was business founded?

The business was founded in 1994.

2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Bulo Shoes qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Bulo Shoes has operated continuously in San Francisco for 31 years.
- b. Bulo Shoes has contributed to the history and identity of the Western Addition neighborhood and San Francisco.
- c. Bulo Shoes is committed to maintaining the physical features and traditions that define the organization.

3. Is the business associated with a culturally significant art, craft, cuisine, or tradition?

Yes. The business is associated with the retail of fashionable footwear of high quality and craftsmanship.

4. Is the business or its building associated with significant events, persons, and/or architecture?

Yes. Over the years, Bulo Shoes has had actors, singers, and mayors as patrons. Customers have included Robin Williams, members of the band Metallica, Tom Waits, Mayor London Breed, and others.

5. Is the property associated with the business listed on a local, state, or federal historic resource registry?

Yes, the site is listed as Category A – Historic Resource Present building and is within the Hayes Valley Residential Historic District, listed within the California Register of Historical Resources and eligible for the National Register of Historic Places.

6. Is the business mentioned in a local historic context statement?

No, not as of the date of this Executive Summary.

7. Has the business been cited in published literature, newspapers, journals, etc.?

Yes. There have been a number of features and articles featuring Bulo Shoes, including: “The 10 Best Shoe Stores in SF” by SFist in March 2017; “Where to Buy Summer Sandals in the Bay Area” by Racked San Francisco in June 2015; “The Eleven Best Shoe Stores in San Francisco” by Racked San Francisco in April 2014; “San Francisco’s Valley of the Designs” by Washington Post in June 2004; and “The Hip Haven of Hayes/Cool shoes, Belgian Frites and ‘Aloha Fridays’ in Hayes Valley” by SFGATE on November, 2001.

Racial and Social Equity Analysis

On July 15, 2020 the San Francisco Historic Preservation Commission adopted [Resolution No. 1127](#) centering Preservation Planning on racial and social equity. Understanding the benefits, burdens, and opportunities to advance racial and social equity that proposed Preservation Planning documents provide is part of the Department’s Racial and Social Equity Initiative. This is also consistent with the Mayor’s Citywide Strategic Initiatives for equity and accountability and with the Office of Racial Equity, which required all Departments to conduct this analysis.

The Legacy Business Program is deeply intertwined with these goals. One of the primary purposes of the Legacy Business Program is to maintain San Francisco’s cultural fabric and to foster civic engagement and pride by assisting long-operating businesses remain in the city. The Legacy Business Registry was established to recognize longstanding, community-serving businesses that are valuable cultural assets of the city. These businesses, ranging from restaurants to art galleries to tire shops to community shelters, are key to sustaining the racial and social diversity in San Francisco and adding to the identity and character of our city and the many communities within it.

WHEREAS, in accordance with Administrative Code Section 2A.242, the Office of Small Business maintains a registry of Legacy Businesses in San Francisco (the "Registry") to recognize that longstanding, community-serving businesses can be valuable cultural assets of the City and to be a tool for providing educational and promotional assistance to Legacy Businesses to encourage their continued viability and success; and

WHEREAS, the subject business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years; and

WHEREAS, the subject business has contributed to the City's history and identity; and

WHEREAS, the subject business is committed to maintaining the traditions that define the business; and

WHEREAS, at a duly noticed public hearing held on January 7, 2026, the Historic Preservation Commission reviewed documents, correspondence and heard oral testimony on the Legacy Business Registry nomination.

THEREFORE, BE IT RESOLVED that the **Historic Preservation Commission hereby recommends** that Bulo Shoes qualifies for the Legacy Business Registry under Administrative Code Section 2A.242(b)(2) as it has operated for 30 or more years and has continued to contribute to the community.

BE IT FURTHER RESOLVED that the **Historic Preservation Commission hereby recommends** safeguarding of the below listed physical features and traditions for Bulo Shoes.
