

Introduction

a. Describe the business. What does it sell or provide?

Family Billiards is one of the last remaining pool halls in San Francisco, offering 17 pool tables and a welcoming space for both casual and competitive players. As one of the few places in the city dedicated to billiards, it provides an essential gathering spot where patrons can enjoy food, beverages, and entertainment. With the decline of similar venues, Family Billiards plays a crucial role in preserving a beloved piece of San Francisco's recreational culture.

b. Describe whom the business serves.

Located in the Richmond District of San Francisco, Family Billiards attracts patrons from surrounding neighborhoods, as well as from across the city and the wider Bay Area. The customer base is diverse, spanning a wide range of ages, backgrounds, and skill levels. While the majority of customers are male, there is a dedicated community of female players. Players range from novices to professionals, creating an inclusive atmosphere that caters to all genders, ethnic groups, and cultures. This dynamic mix of players fosters a vibrant and engaging environment, making Family Billiards a popular destination for both casual visitors and competitive pool enthusiasts alike.

Best pool hall in San Francisco.

a. Provide a short history of the business, including locations and owners.

Family Billiards has a rich history that spans decades. The business was founded in 1965 by Masao Akagaki and George Y. Takaoka at 3624 Geary Blvd. in the Laurel Heights neighborhood.

Under the ownership of Mas and George, the business remained in the original location for 10 years, then moved to 3210 Geary Blvd. in 1975.

Mas and George sold the business to Delbert Wong Jr., who took over the business on November 1, 1986.

In February 1992, Family Billiards relocated to 2807 Geary Blvd. after having done construction on the space from August 1, 1991, until February 21, 1992.

b. Provide the ownership history of the business in a consolidated year-to-year format.

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

Family Billiards was closed due to COVID-19 restrictions from March 2020 to September 2021.

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Family Billiards has played a significant role in shaping the identity of San Francisco's recreational culture, serving as one of the few remaining pool halls in the city. Since its founding in 1965, it has been a gathering spot for both casual players and competitive pool enthusiasts. The venue has been a hub for social interaction, drawing in locals and visitors alike. Its longstanding presence has helped preserve the spirit of community engagement, providing a rare space for people to connect over a game of pool, food, and drinks. As one of the last of its kind in San Francisco, Family Billiards is a cherished part of the city's cultural fabric, holding a place in the history of both the neighborhood and the broader recreational business sector. This history reflects the enduring spirit of Family Billiards and its deep connection to the San Francisco community.

b. Is the business associated with significant people or events, either now or in the past?

Family Billiards is associated with many Bay Area up-and-coming players as well as professional pool players who regularly practice daily at the pool hall. Over the years, it has become a key spot for serious pool enthusiasts, attracting notable talent and fostering a competitive yet welcoming environment. The presence of U.S. and international professional players when they are in town further highlights the business' significance within the billiards community. These

connections to high-level players and the venue's role as a gathering spot for both locals and professionals make it an integral part of the city's cultural and sporting landscape.

c. How does the business demonstrate its commitment to the community?

Family Billiards shows its commitment to the community by hosting free weekly and annual tournaments. These events provide local players with opportunities to compete, improve their skills, and connect with fellow enthusiasts. By offering these tournaments at no cost, the business fosters a welcoming and inclusive atmosphere, ensuring that everyone, regardless of experience or financial background, can enjoy the sport and be part of the vibrant pool community.

f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If Family Billiards were to close, the community would lose a beloved gathering spot that has been a staple of San Francisco's recreational culture for decades. As one of the few remaining pool halls in the city, its closure would leave a significant void for both casual and competitive players. The neighborhood would lose an essential community hub where people of all ages, genders, ethnic groups, and cultures come together to socialize, compete, and unwind. Beyond the loss of a cultural landmark, a number of employees would be left without work, and customers who have relied on the venue for daily socializing would have nowhere else to participate. The closure would sever a vital community connection, leaving locals without a

place to gather, play pool, and foster friendships. For many, Family Billiards is not just a business, but a social and recreational hub that has supported both personal and professional growth in the billiards community. San Francisco would lose a unique piece of its local history, diminishing the diversity of recreational spaces that define the city's vibrant culture.

Family Billiards is defined by its unique interior, particularly the 18 well-maintained pool tables that are annually recovered, ensuring the space remains a top destination for pool enthusiasts. The collection of high-quality tables and the inviting atmosphere inside are key physical features that contribute to its identity. The care and attention put into maintaining the tables and equipment reflect the business' dedication to providing a premier, authentic billiards experience, making it a standout in the San Francisco community.

b. In a few words, describe the main business activity you commit to maintaining.

Keeping billiards alive in San Francisco.

c. What is the plan to keep the business open in the long term beyond the current ownership?

The plan is to keep Family Billiards in the family and pass it on to the next generation. This approach ensures that the legacy of the business, along with its cultural significance in the community, will continue for years to come. By maintaining family ownership, the business will remain true to its roots, preserving the tradition of providing a welcoming space for billiards enthusiasts and fostering community engagement.

d. What challenges is the business facing today?

Family Billiards, with its rich history in the Richmond District, faces a risk of displacement due to another business purchasing the building. They have plans to turn it into a gym and would be displacing Family Billiards, putting the future of the business at risk. This situation highlights the challenges that long-standing businesses face due to rising property values and gentrification, making it difficult for iconic local establishments to stay in place.



'This is my f***ing home!': Pool hall diehards react to closure news

Family Billiards will have to close in about two years. We broke the news to longtime patrons.

Family Billiards has a vibe that only a 60-year-old pool hall can have.

Vintage movie posters line one wall, as neon signs advertising pool and beer buzz outside. Low lighting illuminates 17 pristine tables clothed in blue felt, most of them nine feet long. Many regulars are old-timers who turned to playing pool in retirement.

It's been this way, more or less, since it opened in 1965. But now, San Francisco's oldest pool hall is in danger of closing.

When The Standard visited Thursday night, even diehard league players hadn't heard the news.

"What?" Cameron Combs exclaimed. "This is my fucking home!"

Sporting a flat cap on his head and an SF tattoo on his neck, Combs said he had been at Family Billiards almost every day for three years. Combs, who collects disability insurance and does not

work, said pool is the biggest thing in his life.

“Everything else in the city costs too much money,” he added.



Convent & Stuart Hall, a Sacred Heart Catholic school, bought the building that houses Family Billiards in July and plans to turn it into a multi-level gym with swimming pool.

At a public meeting about the proposal this month, school president Ann Marie Krejcarek confirmed that the project will force Family Billiards out but said it will be at least two years before construction starts.

Delbert Wong, 70 – who began frequenting Family Billiards in 1969 and acquired the place in 1987 – said at the meeting that he wasn’t sure if he’d try to find a new location for the pool hall.

“The problem is it would take so much money to reopen another one,” he explained, adding that he found out his landlord was selling the building after the fact.

Krejcarek said the school wants to “be a good partner” to Family Billiards and could try to help the business relocate.

Rhys Hughes, a retired IT professional from Wales, first heard about Family Billiards shortly after he moved to San Francisco in 2005. He’s been a regular ever since.

“Great tables, decent prices, good scene,” he said.

“And as you can see,” he added, gesturing to the league veterans and casual shooters playing on nearly every table on a recent weeknight, “plenty of people to play.”

Hughes was dismayed to hear about the sale.

“Not good,” he said. “Pool seems to be dying.”

But he wasn’t shocked. He’d been worried since the closure of the Bank of America next door. (The Dec. 7 meeting took place in the vacant bank, where Convent & Stuart Hall staff set up folding chairs.)



Real estate agent Bert Benisch, who’s been coming to Family Billiards nearly every week for 20 years and helped refurbish the interior when it reopened in 2021, lamented its apparent demise.

“This is really the cornerstone,” he said. “It’ll leave a big hole in the San Francisco scene and the pool community.”

Benisch, who lives in the Richmond, added that there's not much else to do in the neighborhood.

"You can only drink so much coffee," he quipped.

San Francisco native and retired catering manager Julie Garner, 68, used to play at Billiard Palacade in the Mission District but said she prefers the atmosphere at Family.

"I'm sad," she said. "I formed a lot of relationships here. It's a long-established place going under. But that's the nature of change."

Business Description

Family Billiards is one of the last remaining pool halls in San Francisco, offering 17 pool tables in a welcoming space for both casual and competitive players. Founded in 1965, it has long served as a gathering place where people connect over a shared love of billiards, as well as food and drinks. As similar venues have disappeared across the city, Family Billiards has become an essential hub, preserving a vital piece of San Francisco's recreational and social culture.

The business was established in 1965 by Masao Akagaki and George Y. Takaoka at 3624 Geary Boulevard in the inner Richmond/Laurel Heights neighborhood. After operating at that location for ten years, the hall moved to 3210 Geary Boulevard in 1975. On November 1, 1986, ownership transferred to Delbert Wong Jr. Following extensive renovations from August 1991 to February 1992, Family Billiards relocated to its current home at 2807 Geary Boulevard, where it continues to thrive.

Family Billiards serves a diverse customer base spanning a wide range of ages, backgrounds, and skill levels. While most patrons are male, there is also a strong and dedicated community of female players. The hall welcomes everyone, from beginners learning the game to seasoned professionals, creating an inclusive environment that reflects the city's cultural diversity. Its commitment to community is further demonstrated through free weekly and annual tournaments, which provide players with opportunities to compete, develop their skills, and build lasting connections. By offering these events at no cost, Family Billiards ensures that the sport remains accessible and that its vibrant pool community continues to grow.

Staff Analysis

The business was founded in 1965.

- c. Family Billiards is committed to maintaining the physical features and traditions that define the organization.

3. Is the business associated with a culturally significant art / craft / cuisine / tradition?

Yes. The business is associated with the sport of Billiards.

4. Is the business or its building associated with significant events, persons, and / or architecture?

December 15, 2024, the San Francisco Standard published “This is my f***ing home!: Pool hall diehards react to closure news”; and SF Yimby published on February 13, 2025 “Application Filed for Schools of the Sacred Heart Athletics Facility”.

Racial and Social Equity Analysis

ADOPTING FINDINGS RECOMMENDING TO THE SMALL BUSINESS COMMISSION APPROVAL OF THE LEGACY BUSINESS REGISTRY NOMINATION FOR FAMILY BILLIARDS CURRENTLY LOCATED AT 2807 GEARY BOULEVARD, BLOCK 1091/LOT 032.

WHEREAS, in accordance with Administrative Code Section 2A.242, the Office of Small Business maintains a registry of Legacy Businesses in San Francisco (the "Registry") to recognize that longstanding, community-serving businesses can be valuable cultural assets of the City and to be a tool for providing educational and promotional assistance to Legacy Businesses to encourage their continued viability and success; and

WHEREAS, the subject business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years; and

WHEREAS, the subject business has contributed to the City's history and identity; and

WHEREAS, the subject business is committed to maintaining the traditions that define the business; and

WHEREAS, at a duly noticed public hearing held on January 7, 2026, the Historic Preservation Commission reviewed documents, correspondence and heard oral testimony on the Legacy Business Registry nomination.

THEREFORE, BE IT RESOLVED that the Historic Preservation Commission hereby recommends that Family Billiards qualifies for the Legacy Business Registry under Administrative Code Section 2A.242(b)(2) as it has operated for 30 or more years and has continued to contribute to the community.

BE IT FURTHER RESOLVED that the Historic Preservation Commission hereby recommends safeguarding of the below listed physical features and traditions for Family Billiards.
