### INTRODUCTION

### a. Describe the business. What does it sell or provide?

Founded in 1918 as the Presidio Open Air School, Presidio Hill School has grown and flourished over the last century. Its students continue to be caring community members who advocate for themselves, for others, and for what is right; they are intrepid and engaged learners. Presidio Hill staff members have encouraged and captivated students for over 100 years—learning alongside the students, fostering leadership, and inspiring civic engagement. Presidio Hill School, while having changed and grown in structure over the last century, maintains the progressive mission and inclusive values from its founding—values that have made the school an incredibly special and unique place throughout the years.

#### b. Describe whom the business serves.

Presidio Hill School serves students and families from throughout San Francisco and the Bay Area. Statistics about their students:

# CRITERION 1: The business has operated in San Francisco for 30 or more years, with no break in San Francisco operations exceeding two years

### a. Provide a short history of the business, including locations and owners.

In 1918, Helen Salz and Flora Arnstein opened the Presidio Open Air School to San Francisco children and families tired of the rote learning and boring, factory-model pedagogy of the times. The school's pedagogy was anchored in the progressive ideas of John Dewey, and it was the first such school in California. The school opened in a house on a property donated by the Salz family, and Presidio Hill School remains operating at its original location, 3839 Washington Street in the Presidio Heights neighborhood.

In 1968, the school became a membership co-operative including parents, staff, and board.

In the early 1990s, PHS began to move away from the co-op structure to a more mainstream non-profit board structure, and in 1990 PHS became an accredited member of the California Association of Independent Schools.

In 2013, Presidio Hill School purchased 233 Maple Street. This additional building was renovated and became a functioning part of the PHS campus in 2015.

c. Describe any circumstances that required the business to cease operations in San Francisco for any significant length of time.

Presidio Hill School has remained continuously open since its inception in 1918.

# CRITERION 2: The business has contributed to the neighborhood's history and/or the identity of a particular neighborhood or community

a. Describe the business' contribution to the history and/or identity of the neighborhood, community, business sector, or San Francisco as a whole.

Presidio Hill School, the oldest continually operating progressive school in California, has contributed to the history and identity of Presidio Heights and San Francisco. Dedicated to progressive education since 1918, Presidio Hill School challenges young people to imagine, inquire, and create. Their students engage San Francisco and the Presidio as an extended classroom and become empowered learners who are responsible, committed to justice, and optimistic about the future.

### b. Is the business associated with significant people or events, either now or in the past?

During the late 1930s and early '40s, former school director Josephine Whitney Duveneck was active with the American Friends Service Committee, which helped refugees from Hitler's Germany begin their lives anew in San Francisco, and the school was often used as a focal point for such activities. The school was also a locus for protest against the internment camps in which many Japanese Americans were held during World War II.

Just after the war, in 1946, the Williams family joined the Presidio Hill community. Rosalind and Stephanie, young girls at the time they came to the school, were, it is believed, the first African-American students at any independent school in San Francisco. They were welcomed, and they say today that the school was their best educational experience. Stephanie has recently served on the school's Board of Trustees.

A few years later, as intolerance for political activism became mainstream, blacklisted entertainers Paul Robeson and Pete Seeger were invited to sing for the Presidio Hill community, where they found a welcome audience. Seeger was joined by fellow singer-activist Malvina Reynolds for the Sunday sing-along, then popular at the school.

Today, the school carries on the tradition of preparing all students for a democratic society by educating a cross-section of San Francisco life. Approximately 45% of Presidio Hill students are children of color. Approximately 31% receive tuition assistance. Quite a few more come from families who are citizens of countries other than the United States. The curriculum stresses humanity's search for social justice and human rights. A Presidio Hill contingent marches with other independent schools in San Francisco's Pride Parade every year.

### c. How does the business demonstrate its commitment to the community?

The Center for Progressive Education at Presidio Hill School, which opened in the fall of 2015, is building on the school's century-long legacy of progressive education to strengthen and expand the community dedicated to its philosophy and practices.

The CPE@PHS has several overlapping goals:

- To serve as the hub for information sharing and discussion regarding progressive education philosophy and practice among local Bay Area and West Coast educational institutions.
- To partner with like-minded educators in order to learn from each other and expand the depth and reach of progressive practices.
- To support the mission and vision of the Progressive Education Network of which the CPE is a regional affiliate.

In addition to serving their community by providing high-quality progressive education to their students, the school community members are engaged in community service beyond the walls of their school. Examples include:

- Hiring BATTI teachers in training.
- Collecting food for the SF/Marin Food Bank.
- Volunteering with Compass Family Services.
- Hosting community clothing, costume, and book swaps to reduce waste.
- Adopting a drain in the neighborhood to keep clear and prevent flooding during inclement weather.
- Collecting litter from streets and sidewalks in the neighborhood.

### d. Has the business ever been referenced in the media, business trade publication, and/or historical documents?

- Progressive Education Network of which the CPE is a regional affiliate.
- Accredited by the California Association of Independent Schools (CAIS).
- Member of the National Association of Independent Schools (NAIS), Progressive Educators Network (PEN), and People of Color in Independent Schools (POCIS).

### e. Has the business ever received any awards, recognition, or political commendations?

On March 2nd each year, Presidio Hill School celebrates Founders Day because the San Francisco Board of Supervisors declared it to be Presidio Hill School Day on March 2, 2018.

# f. How would the community be diminished if the business were to be sold, relocated, shut down, etc.?

If the school were to close, San Francisco would lose a vital institution with over a century of history rooted in progressive education and civil rights advocacy. Presidio Hill School has been a

cornerstone of the community since 1918, providing a unique learning environment that nurtures critical thinking, creativity, and social responsibility. The Presidio Heights neighborhood would lose a hub of intellectual and cultural enrichment, while families across the city would lose access to a pioneering educational model that prepares students to be thoughtful, engaged citizens. Additionally, the closure would result in the loss of employment for about 50 dedicated faculty and staff and diminish San Francisco's rich tradition of fostering innovative and inclusive educational opportunities.

Presidio Hill School has been a presence on Washington Street since 1918. The concrete seal from when the school was called the "Presidio Open Air School" remains at the entrance to the building.

Providing progressive education.

## c. What is the plan to keep the business open in the long term beyond the current ownership?

Presidio Hill School has a long history of providing quality education under many different Heads of Schools. Through thoughtful strategic planning, an engaged board and family community, and the CAIS accreditation process, they are committed to continuing to provide a progressive education for many generations to come.

### d. What challenges is the business facing today?

As the demographics of San Francisco change to include fewer families with elementary- and middle school-aged children, there is increased competition among independent schools to reach full enrollment.



### **Business Description**

Presidio Hill School is a progressive school located at 3839 Washington Street in the Presidio Heights neighborhood. The school currently serves students from transitional kindergarten to 8<sup>th</sup> grade. The curriculum focuses on social justice and human rights. In terms of the student population, approximately 31% of students receive tuition assistance and 45% of the students are children of color.

The school was founded in 1918 as the Presidio Open Air School at 3839 Washington Street. Founders Helen Salz and Flora Arnstein based the school's pedagogy on John Dewey's progressive ideals and project-based curriculum. In the late 1930s to early 1940s, the school helped refugees from Germany settle into their new home in the United States. The school was also a place for protesting the internment camps where Japanese Americans were held during World War II. The school was the first independent school to serve African American students in 1946. Rosalind and Stephanie Williams were the first African American students to join the school. Stephanie Williams returned to serve on the school's Board of Trustees in recent years.

To expand the progressive education philosophy and practices, the Center for Progressive Education was open in 2015 at the school. Educators receive training and support to serve their own communities. In addition to providing support to educators, the school participates in community service events.

The business was founded in 1918.

### 2. Does the business qualify for listing on the Legacy Business Registry? If so, how?

Yes. Presidio Hill School qualifies for listing on the Legacy Business Registry because it meets all of the eligibility Criteria:

- a. Presidio Hill School has operated continuously in San Francisco for 107 years.
- b. Presidio Hill School has contributed to the history and identity of the Presidio Heights neighborhood and San Francisco.
- c. Presidio Hill School is committed to maintaining the physical features and traditions that define the organization.

### 4. Is the business or its building associated with significant events, persons, and / or architecture?

The Washington Street property is located within the California Register-Eligible Presidio Heights Historic District. The district is eligible under Criterion 3 - Architecture. It is almost exclusively residential and primarily characterized by large, frequently formal, dwellings, typically two to three stories in height over a raised basement. Constructed mainly between 1905 to 1925, the buildings reflect mostly late-Victorian (typically Queen), Shingle (or First Bay Region), Arts & Crafts, Classical Revival, Colonial Revival, Tudor Revival, French Provincial, and Mediterranean Revival design influences.
