ACTION: Upon motion by Commissioner Lopez, the Board voted 5-0 to grant the appeals and overturn the suspension of the licenses on the basis that: (1) the appellants were not afforded due process for the underlying hearing before the Art Commission's Street Artists Program Committee, and (2) there was insufficient evidence to establish the violations.

It was necessary to reschedule these Items because the February 11, 2026 meeting was cancelled due to a lack of a quorum (Vice President Saroyan and Commissioner Lopez absent). On February 18, 2026, it was necessary to reschedule these Items to March 11, 2026 due to a lack of a quorum (Vice President Saroyan recused and Commissioner Lopez absent). On March 11, 2026 it was necessary to reschedule these Items to March 25, 2026 due to a lack of a quorum (Commissioner Abad absent and Vice President Saroyan recused). On March 25, 2026, it was necessary to reschedule these Items to April 15, 2026 due to a lack of a quorum (Commissioner Lopez absent and Vice President Saroyan recused). On April 15, 2026, upon motion by President Trasviña, the Board voted 3-0-2 (Vice President Saroyan and Commissioner Abad absent) to continue these matters to April 29, 2026, so that Commissioner Abad could participate in the vote, with the intention that a motion would be made to grant the appeals and issue the permits on the condition that they be revised to shorten the fence to six feet and to comply with the Building and Planning Code requirements as they pertain to Emergency Escape and Rescue Openings and open space.</p>

MARCO FARINA and GIULIA MAZZA, Appellant(s) vs. DEPT. OF BUILDING INSPECTION, Respondent PLANNING DEPT. APPROVAL	850 Corbett Avenue. Appealing the ISSUANCE on December 4, 2025, to Debra Leong, of an Alteration Permit (Unit #2: correct Notice of Violation Nos. 202545537 and 202545865, legalize an existing 7'7" tall wood fence at the rear terraces at the first floor; correcting unpermitted electrical lighting installed in common areas; fence length 13' 6"). PERMIT NO. 2025/1125/0415. FOR HEARING TODAY. See Note in (5A) above.

ACTION: Upon motion by President Trasviña, the Board voted 4-0-1 (Vice President Saroyan recused) to grant the appeals and issue the permits on the condition that they be revised to shorten the fence to six feet in height and to comply with the Building and Planning Code requirements as they pertain to Emergency Escape and Rescue Openings and open space. This motion was made on the basis that these changes make the project Code compliant.

SPEAKERS: Vice President Saroyan disclosed that she works as a contract attorney for a law firm in San Francisco called the Mitchell Group. She stated that as part of that job, she did work in November 2025 for the firm representing the permit holder in Items 5A and 5B, Patterson & O'Neill. She further stated that after consulting with the City Attorney's Office, she would be recusing herself from hearing these matters.
