(4) JURISDICTION REQUEST NO. 25-4

Subject property at 555 Bryant Street (Bryant and Welsh Street frontages). Letter from The Palms HOA, requestor, asking that the Board take jurisdiction over Street Improvement Permit No. 21IE-00511, which was issued on September 27, 2024. The appeal period ended on October 15, 2024, and the Jurisdiction Request was filed at the Board office on May 8, 2025. Permit Holder: Bryant Partners LLC and Bryant & Welsh LLC. Permit Description: Sidewalk widening on Welsh and Bryant Streets: Remove and reconstruct new (22') driveway curb cut and sidewalks per approved plans, saw-cut 2' of AC gutter and replace with 2" ACWS over 8" concrete base; additional paving as required and directed by SFPW/BSM inspector.

ACTION: Upon motion by Commissioner Swig, the Board voted 3-1-0 (President Trasviña dissented and Commissioner Lopez absent) to deny the request on the basis that the City did not intentionally or inadvertently cause the requestor to be late in filing the appeal. The Board further recommended that SFPW and SFMTA reach out to the requestor and try to address the concerns raised at the hearing.
