RE: Annual update on tree removal permit conditions and mitigations

President Trasviña and Commissioners:

The purpose of this submittal is to provide updates on the permit conditions and mitigations that were subject of previous appeals to Board of Appeals, and this is a follow-up to our May 7<sup>th</sup> updates for both appeals.

Appeal No. 20-081 (198 McAllister) UC Law San Francisco (UC Law SF)

Since our last update on May 7<sup>th</sup>, 2024, leadership with UC Law SF has done a great job continuing to establish the required replacement trees. The trees were planted and in good condition as of the may 7<sup>th</sup> update and they remain so. See attached, the update provided by UC Law SF for this hearing. All trees are planted and accounted for, in good condition, with protective screens in place on most trees. Representatives from UC Law SF have also been very responsive to Mr. John Nulty as well as to Public Works Urban Forestry Inspector, Bryan Ong.

The following update was provided on May 7<sup>th</sup> and still holds true, so we will reference it as part of the overall 2025 annual update.

(a) Adoption of UC Hastings' (now UC Law San Francisco) "Green Community Benefits Plan" to include a minimum of 3 – 1 replacement for the eight (8) street trees removed with 36" box size trees on the frontage of the construction site; remaining trees to be planted off site, on-site and off-site planting number will work in concert with one another;

Status: Completed (25 total trees planted, to meet the 3-1 replacement requirement)

Description: Fourteen (14) street trees, 36" box trees, planted at project site 198 McAllister

UC Law San Francisco also planted eleven (11) street trees in the neighborhood at the following locations. We worked closely with staff to find alternate locations for two sites which had underground utility conflicts. There have been a few changes over the past few months, below are the addresses of the planting sites, which were planted with *Lagunaria pattersonii* trees:

- (1)134 Golden Gate Ave.
- (1)191 Golden Gate Ave.
- (1)350 Golden Gate Ave.
- (2) 121 Jones St.
- (4) Turk/Hyde Mini Park
- (1) 418 Larkin St.
- (1) 499 Turk St.

(b) maintenance of (including replacement if necessary) all planted trees for a minimum of 36

months;

Status: active/ongoing/monitoring

Description: UC Law San Francisco has re-staked and added back protective screening as

necessary; submitted photos with tree protection in place (some trees on Hyde no longer

require tree protection – because they were planted very large). Note: there is a difference

between "tree protection" during any adjacent construction, and just normal support stakes

and crossbraces, and protective screening necessary during establishment, to reduce the

likelihood of trees being damaged from vandalism.

(c) & (d) as practical, new plantings should provide appropriate tree protection to

reduce the incidence of vandalism; plant larger stature trees where possible (at eventual

maturity, large stature trees, that are climate appropriate)

Status: active/ongoing/monitoring

Description: same update as above

(e) provide BUF with list of potential off-site planting sites at 198 McAllister (7 on Hyde,

1 on McAllister)

Status: completed and monitoring establishment

### Appeal No. 22-079 (401 Parnassus) UCSF Medical Center at Parnassus

Below is a status update for the UCSF tree program, as outlined in the permit from Jaclyn Drexler, Associate Director, Community Relations, UCSF Office of Community & Government Relations (April 22, 2025):

- 14 new trees on Parnassus Ave: June 2024 the project team submitted construction
  documents to the City for Parnassus Ave street improvement permit #241E-00249
  currently in plan check review. These trees to be planted in 2029 prior to opening the
  new hospital.
- 42 new trees in the neighborhood: As part of the UCSF Greening Parnassus Heights
   Project, in February 2024 completed planting 42 trees in the neighborhood surrounding
   the Parnassus Campus in coordination with FUF. UCSF will fund three years of tree
   maintenance coordinate by FUF.
- 105 new trees DPW-BUF: February 2023 completed payment of the \$242,000 in lieu fee
   to BUF. Contract and planting update to be provided by Public Works.

Additional feedback from Mike Yarak, Program Director, Friends of the Urban Forest, regarding the community tree planting (April 17, 2024):

"Yes, confirming that we worked with UCSF and the neighboring community to plant 42 street trees in the neighborhood around the Parnassus campus. These trees were planted in February 2024, and as Morgan mentioned, are in the establishment period for approximately the next two years. As for an update on our end, we recently invited the community members back out and hosted a volunteer tree care event here!"

#### Status:

To date, UCSF has completed the portions of the conditions that can be completed at this time. The community tree planting of 42 trees is completed over a year ago, and is in the 2<sup>nd</sup> year of the three year maintenance period. They are actively constructing their building at the project site and will not be planting the on site trees for several more years.

### October, 2025 updates from Public Works, Bureau of Urban Forestry:

Use the funds provided by UCSF (\$242,000) to secure a grant to plant approximately 105
 new plantings sites, with 24" box size trees in high priority sites identified in the Urban
 Forest Plan.

Public Works wishes to thank Josh Klipp for promoting and supporting an idea (developed in the last month or two) to partner with SoMa West Community Benefits Distict (CBD) to plant 25 of the 105 trees within the SoMa West CBD boundaries. Public Works has identified these locations to plant. We have located 36 sites, to make sure we have a buffer, to account for trees that may have below-ground utility conflicts. This list is attached, and will be included in our request for proposals (RFP) to contractors.

By the October 29<sup>th</sup> hearing on this item, Public Works will also have identified the potential 85 additional planting sites within District 10, to reach the goal of 105 trees. We are inspecting 163 sites to make sure that we reach the needed 80 sites to plant.

The update is that our inspection team will be able to give our contract manager the list of potential planting sites by October 29<sup>th</sup>, so that the contracting process may move forward. We

will provide a list of anticipated next steps for the contracting process to begin, and again, we value and appreciate the support of appellant Josh Klipp to identify 25 of the planting locations within the SoMa West CBD boundaries. While Public Works is behind on the delivery of this mitigation, we are excited and enthusiastic about the partnerships we have formed to carry out this aspect of the UCSF mitigations, which required the new leadership of our Superintendent David Moore, and the ongoing advocacy of Josh Klipp.

This year, our Bureau wishes that we were able to make more progress on this important BOA mitigation condition, but we have a large federal grant of \$12,000,000.00 that required our near full attention. We believe with Superintendent Moore's leadership, and support from appellant Josh Klipp, that we have cleared a critical hurdle towards making better progress.

During this agenda item we will also have Urban Forestry Inspector Bryan Ong, on the call, as well as Jon Swae, our Contracts and Grants Manager, who co-wrote San Francisco's Urban Forest Plan when he worked with the San Francisco Planning Department



Dear President Trasviña and Commissioners,

Thank you for your engagement and thoughtful direction during the recent public meeting. In response to President Trasviña's request following public comment, we are providing this written report in advance of the first meeting in August. As requested, we have addressed the relevant matters discussed, including those raised by Commissioner Swig and community member Josh Klipp. Total Trees:

203 new trees will be planted, which include:

- 161 Street Trees (2029 projected completion)
- 42 project-specific trees (Planted/completed)

### Tree Breakdown:

- 14 new street trees on City property (36-inch box)
- 42 new street trees in the neighborhood (15-gallon size)
- 105 new street trees through an in-lieu fee payment to DPW-BUF
- 13 trees on UCSF property within 10 feet of the curb (24-inch box)
- 23 trees on Level 6 All Day Eatery
- 6 trees on Level 8 courtyard

A site plan at the bottom illustrates the location of many of these trees on Parnassus





As soon as the agreement with the Bureau of Urban Forestry was signed, UCSF paid the in-lieu fee of \$242,000.00

The check was hand delivered 2/22/2023 (see attached addendum)

The larger street trees (36" box) are scheduled to be planted in 2029 at the completion of the new Hospital.




### Community Tree Planting Update:

42 new street trees were planted on February 24, 2024, in partnership with Friends of Uban Forest, the Inner Sunset Park Neighbors, and nearly 100 community volunteers. According to Friends of the Urban Forest, only two trees required replanting in 2024. All trees are currently healthy and are in year two of a three-year establishment watering program.

### University of California, San Francisco – Tree Replacement Plan

#### **401 Parnassus Avenue**

### **February 2, 2023**

### I. Introduction

On December 14, 2022, the Board of Appeals ordered the parties to Appeal No. 22-079 to collaborate on a tree replacement plan with regards to Public Works Order No. 207226 and Permit No. 792615 – the permit on appeal in that matter. In response to the Board of Appeals' order, the University of California ("UC"), San Francisco ("UCSF") has prepared this Tree Replacement Plan (the "Plan") in conjunction with the New Hospital at Parnassus Heights at 401 Parnassus Avenue (the "Project"). This Plan aims to equitably mitigate tree removals and other construction impacts required by the Project, notably the removal of twenty-eight (28) street trees adjacent to the Project site.

### II. Goals and Objectives

UCSF recognizes that the collective impacts of removing a mature stand of trees cannot be replicated merely by their replacement with an equivalent number of young trees. Therefore, the Plan describes a hybrid mitigation strategy that prioritizes multi-functional, community-based solutions to current challenges that will support ongoing environmental resilience for UCSF and the surrounding neighborhoods, as well as other areas of the City in greatest need of new trees. The Plan comprises:

- A. An integrated tree planting and care program.
- B. Immediate green space benefits in the Parnassus Heights neighborhood.
- C. Initiation of and investment of funds by way of in-lieu tree fee payments to DPW-BUF; and
- D. Reliance on community partners in decision-making.

The following sections outline the implementation processes for each component of the Plan, including roles and timeframes, with the goal of contributing to greener, healthier neighborhoods.

### III. Tree Program

- 42 new street trees in Neighborhood 15 gallon
- 105 new street trees (in-lieu fee payment to DPW-BUF)
- 13 new trees on UCSF property within 10ft (24in box)

- A. A total of fifty-six (56) new street trees will be planted to mitigate removal of the twenty-eight (28) street trees. An additional in-lieu fee payment in the amount of \$242,000 will be provided by UC to the Department of Public Works, Bureau of Urban Forestry ("DPW-BUF") for the planting of an additional 105 street trees (\$242,000 ÷ \$2,302 [DPW-BUF's 2023 in-lieu fee]).
  - 1. Along the Project's frontage on Parnassus Avenue, at least fourteen (14) street trees will be planted. If physically possible, up to an additional 4 trees will be planted if the site allows.
    - (a) Site Selection: UCSF and DPW-BUF.
    - (b) <u>Species Selection</u>: UCSF, chosen from DPW-BUF's Recommended Street Trees list.
    - (c) Tree Size: 36" box trees.
    - (d) Tree Planting: UCSF.
    - (e) <u>Timeframe</u>: At completion of Project construction, anticipated 2030.
    - (f) <u>Funding</u>: UCSF.
  - 2. At least 42 trees will be planted in the Parnassus Heights community at locations selected through a community survey and RFP process.
    - (a) <u>Site Selection</u>: Community members through a survey have ranked a green connection to the Inner Sunset (Westbound Parnassus Avenue / Judah and/or Irving) as the preferred location for new street trees, in coordination with DPW-BUF.
    - (b) <u>Species Selection</u>: UCSF in consultation with community organization selected pursuant to the RFP process, chosen from DPW-BUF's Recommended Street Trees list.
    - (c) Tree Size: minimum 15-gallon.
    - (d) <u>Tree Planting</u>: Community organization chosen pursuant to the RFP process.

The selected organization will be able to demonstrate a strong ability to partner with UCSF, the City and County of San Francisco, and most importantly, the community to identify location(s) for trees, organize a community tree-planting celebration event, and maintain the trees for three years.

UCSF is deeply committed to partnering with the community to make these and other enhancements to the neighborhoods we work and live in. As part of UCSF's Comprehensive Parnassus Heights Plan (CPHP) to revitalize our flagship campus over the next thirty years, the University aspires to foster a "Park to Peak" green connection through its campus between Golden Gate Park and Mount Sutro. Through the *Greening Parnassus Heights* initiative, UCSF will plant trees along select neighborhood streets surrounding UCSF's Parnassus Heights campus.

In 2021, UCSF and the City and County of San Francisco signed a Memorandum of Understanding (MOU) associated with our plans to build a new hospital at Parnassus Heights. The MOU outlines UCSF's commitment to the vibrancy of the neighborhood. Community investments include housing, workforce development, nature and the environment, public transportation, pedestrian safety, bike improvements, and many more items. Each spring, UCSF prepares an annual report to share our progress towards meeting these commitments. The *Greening Parnassus Heights initiative* is an integral part of the MOU.

#### 5.0 BACKGROUND INFORMATION



#### New Hospital at Parnassus Heights

On May 19, 2022, the UC Board of Regents approved the construction of the Helen Diller Medical Center at UCSF at Parnassus Heights. The new hospital is a critical part of UCSF's plan to increase capacity to serve more patients, ensure UCSF provides high-quality health care, and continues to advance medical research. UCSF is currently preparing the site for construction and is committed to offsetting any potential impacts.

#### **Greening Parnassus Heights**

Streetscape and construction plans necessitate the removal of 28 street trees within the next few months. San Francisco requires a 1:1 replacement of trees removed. Through UCSF's *Greening Parnassus Heights* initiative, UCSF plans to exceed the City of San Francisco's requirement by replanting trees at 2:1 ratio, totaling 56 trees new trees. A minimum of 14 trees will be re-planted along Parnassus Avenue upon completion of the new hospital, which means 42 trees will be planted over the next few months in the surrounding streets.

#### **UCSF Community Engagement Process**


UCSF introduced the *Greening Parnassus Heights* initiative to the community for feedback in UCSF-hosted community meetings and at street fairs and nearby farmers

markets in June, July, August, and September 2022. UCSF is deeply committed to transparent community engagement and to regularly informing the community about upcoming activities, potential impacts, and mitigations.

Guided by San Francisco's Bureau of Urban Forestry (BUF) data, UCSF outlined four approximate areas where trees could be planted in the neighborhoods adjacent to the Parnassus Heights campus. A survey was heavily promoted (electronically and through postal mail) throughout the surrounding neighborhoods to encourage community members to identify where they would like to prioritize tree planting. The areas surveyed by the neighbors in order of ranking are:

- 1. Connection to Inner Sunset
- 2. Connection to Golden Gate Park
- 3. Connection to Cole Valley
- 4. Hillway Avenue

#### 6.0 SCOPE OF WORK

The Scope of Work includes three sections:

#### Section I: Collaboration, Communication and Coordination

- Collaborate with the Community:
  - Conduct outreach to engage as many neighbors as possible.
  - Identify preferred location of trees. UCSF's survey results indicate the Inner Sunset as the preferred location; however, there may be enough trees to plant in other locations as well. Some neighbors have done their own assessment about tree location and preferences.
  - Work with community, City and UCSF to identify species of trees.
  - Request permission of property owners to plant trees in front of their homes.
  - Plan a community tree-planting celebration. Conduct outreach, plan, and execute the event. Include neighbors, community leaders, organizational partners, UCSF and City of San Francisco staff, and more. Partner with UCSF to ensure mutual goals are met.
  - Over the course of the 3-year contract, maintain communication and/or provide engagement opportunities with the community.

- Collaborate with the City and County of San Francisco Bureau of Urban Forestry (BUF) and Department of Public Works (DPW)
  - Identify open tree wells in the Parnassus Heights surrounding neighborhoods.
  - Acquire planting permits.
- Collaborate with UCSF:
  - o Ensure the location and number of tree wells matches the stated goal.
  - Involve UCSF in aspects of the tree-planting celebration and other engagement opportunities.
  - o Be available to present at community meetings.

#### Section II: Plant the Trees

- o Tree Well Cutting:
  - As part of permitting before digging, call 811 for Utility Service ("USA Dig") to ensure safe concrete demolition
  - Cut concrete well and dispose of material properly. (Concrete box refuse box will be available at UCSF's Parnassus Heights Campus). Purchase trees, planting material, and tree water bags
  - Dispose of trash and concrete appropriately
- Plant 42 trees respecting the ANSI A300 standard:
  - Minimum 15-gallon tree, the City's standard
  - 2 stake system
  - Natural mulch (provided by UCSF Grounds)
  - One water bag

#### Section III: Maintain health of trees over 3 years:

- Weekly watering service
- o Fertilization (rain season, 30-0-10, nitrogen shouldn't be lower than 30%)
- Stakes adjustments, as needed
- Structural pruning at Year 2
- Stake removal at the end of Year 3
- Notify UCSF if the tree is dead and needs to be replaced.
- Reserve funding to replace five trees over the three-year period of the contract. If more than five trees need to be replaced, inform UCSF and propose a solution.

#### 1. Documentation, reporting and additional communication:

- ➤ Provide a written annual report about the health and maintenance of the newly planted trees for 3 years.
- ➤ Provide UCSF with regular updates and annual reports on the status of outreach, engagement and collaboration with the neighbors and City.

➤ UCSF will use these updates and reports to inform the Bureau of Urban Forestry (BUF) and the community about the progress of this initiative. Updates will also be shared at the Parnassus Heights Quarterly Construction Meeting.

PRESENT: President John Trasviña, Vice President J.R. Eppler, Commissioner Rick Swig, and Commissioner Jose Lopez.

Jesse Mainardi, Deputy City Attorney, Office of the City Attorney (CAT); Corey Teague, Zoning Administrator, Planning Department (PD); Joseph Ospital, Senior Building Inspector, Department of Building Inspection (DBI); Chris Buck, Urban Forester, San Francisco Public Works, Bureau of Urban Forestry (SFPW-BUF); Julie Lamarre, Executive Director; Alec Longaway, Legal Assistant.

#### (1) PUBLIC COMMENT

At this time, members of the public may address the Board on items of interest to the public that are within the subject matter jurisdiction of the Board except agenda items. With respect to agenda items, your opportunity to address the Board will be afforded when the item is reached in the meeting with one exception. When the agenda item has already been reviewed in a public hearing at which members of the public were allowed to testify and the Board has closed the public hearing, your opportunity to address the Board must be exercised during the Public Comment portion of the calendar. Each member of the public may address the Board for up to three minutes. At the discretion of the Board President, public comment and remote public participation may be limited to two minutes per person. If it is demonstrated that public comment and remote public participation will cumulatively exceed 15 minutes, the President may continue Public Comment and/or remote public participation to another time during the meeting.

SPEAKERS: None.

#### (2) COMMISSIONER COMMENTS & QUESTIONS

SPEAKERS: President Trasviña welcomed everyone to the hearing and stated that it was always good to see a large crowd in the audience. He noted that the Board had an obligation to everyone in San Francisco and stated that they would do their best to fulfill their responsibilities. He further stated that they looked forward to hearing the four very important items on the agenda.

PUBLIC COMMENT: None.

#### (3) ADOPTION OF MINUTES

Discussion and possible adoption of April 30, 2025 minutes.

ACTION: Upon motion by President Trasviña, the Board vote 4-0 to adopt the April 30, 2025 minutes as amended by President Trasviña.

PUBLIC COMMENT: None.

#### (4) SPECIAL ITEM

The Bureau of Urban Forestry ("BUF") will give an update on two appeals that were previously heard by the Board of Appeals:

- (a) Appeal No. 20-081 at 198 McAllister Street (UC Law) decided on January 13, 2021 (the Board denied the appeal and upheld the order on the basis that it was properly issued), and
- (b) Appeal No. 22-079 at 401 Parnassus Avenue (UCSF) decided on February 8, 2023 (the Board granted the appeal and issued the order on the condition it be revised to require the adoption of the Tree Replacement Plan, dated February 2, 2023, that was submitted for the hearing. The motion was made based on UCSF's commitment to plant trees for the City. The Board further requested that BUF report back to the Board annually about the progress of the planting until the completion of the project).

SPEAKERS: Chris Buck, SFPW-BUF: Regarding Appeal No. 20-081 at 198 McAllister, Mr. Buck stated that the permit requirements have been completed. He noted that the permit required 3 for 1 replacement trees both at the frontage of the property (36-inch box size trees) as well as other plantings in the community. He acknowledged that the timeline took longer than anticipated. Regarding Appeal No. 22-079 at 401 Parnassus Ave., Mr. Buck reminded the commissioners that the appeal involved the removal of very large Monterey Cypress trees as part of the renovations for UCSF's new building. He stated that UCSF completed the community planting with the neighborhood and the Friends of the Urban Forest. He stated that UCSF has been engaged with all of the City agencies on the planting of replacement trees on the frontage of Parnassus Avenue which won't occur until 2029. He stated that UCSF paid Public Works to plant 105 new trees but acknowledged that the planting has not yet been completed. He indicated that the delay was the result of contracting taking longer than anticipated.

President Trasviña referenced the Parnassus permit and noted that in the Department's 2024 report, it was estimated that it would take until August of 2024 for the contracting to commence. He asked if Mr. Buck had a new replacement date for August 2024. Mr. Buck estimated 6-8 months (from the date of the hearing) to get the contract issued and thereafter 1-4 months for actual tree planting. With respect to 198 McAllister Street, President Trasviña noted that public comment submitted by John Nulty raised approximately twelve different items. President Trasviña asked Mr. Buck if he had contacted Mr. Nulty about his concerns. Mr. Buck assured the Board that the department would reach out to Mr. Nulty to give him an update about the case and to respond to the twelve items he raised.

Vice President Eppler asked Mr. Buck to elaborate on the site selection for the 105 street trees to be planted as part of the UCSF grant. Mr. Buck stated that the department received a significant amount of funding to plant trees in communities with the greatest need and noted that there were areas in the Mission, the Tenderloin and the Bayview that already had dedicated funding. Mr. Buck stated that they would be targeting high priority planting sites as established in the Urban Forest Plan, but that they wanted to be careful not to duplicate efforts with existing grants.

Vice President Eppler noted that the Bayview was recently identified by the Mission Local as the neighborhood with the least amount of tree canopy. He further stated that he hoped that the funding BUF was going to dedicate to the Bayview was commensurate with the need.

Commissioner Swig stated that the delays in securing contracts [for planting the trees associated with the UCSF grant] concerned him greatly. He asked Mr. Buck what could be done by the Board to expedite the contracts to plant the trees. Mr. Buck stated that Commissioner Swig had the Department's full attention, and that Mr. Buck had all he needed to carry it forward. Mr. Buck stated that part of the delay was caused by the fact that he thought planting sites had to be fully vetted before entering into a contract. He stated that he recently learned that the contract can require the contractor to do that marking. Mr. Buck stated that he was going to eliminate any delay from the department's end that he could control and put the matter in the hands of the contracting team. Commissioner Swig stated that he wanted to agendize this item again.

PUBLIC COMMENT: John Nulty showed photographs of trees planted in conjunction with the 198 McAllister appeal and noted some issues with these trees.

Josh Klipp stated that UCSF only gave money (nearly a quarter of a million dollars) to plant 105 trees because of his appeal. He stated that he had specifically requested that these trees be planted in the southeastern part of the City as a matter of environmental justice. He referenced the Mission Local article which described the pathetic tree canopy in the Bayview. He noted the delays in planting the trees and stated that they did not get any new timeline [from BUF] in writing. He stated that Public Works needs to keep its word.

Kasey Rios, an environmental justice worker in the Tenderloin, stated that she was the co-author of the Green Community Benefits Plan in collaboration with UC Hastings (now UC College of the Law). She stated that even though the exact number of trees were planted, the spirit of the Plan was not adhered to.

Michael Nulty stated that he had been involved in the Tenderloin for over 30 years. He stated that UC Law has come up short by planting the trees at the last minute and that there was poor planning. He further stated that they did not implement the plan in a correct way. He stated that the public had to do all the work (not DPW) to figure out what is going on in the community. He stated that it was the same with UCSF. He stated that he would like to see both of these items re-agendized.

Rhiannon Bailard (COO of UC Law San Francisco) made a few clarifications: the BUF permit was related to replacement of trees at a 3 to 1 ratio. She stated that the La Cocina green space parklet became a nuisance for drug dealing and drug use and therefore the SFPD asked them to remove it. She noted that the trees in that location were not part of the tree replacement schedule or permit. She stated that in terms of community engagement, they worked with multiple community partners on site selection, species, as well as watering and maintenance. Ms. Bailard stated that she believed UC Law met the letter of the plan as well as the intent.

[Subsequent to public comment] President Trasviña stated that he thought it was important to agendize these matters for the first meeting in August. He further asked BUF for a written report and stated that if BUF indicated that other city agencies were responsible for implementation, that those agencies be present at the hearing. He stated that UCSF should be invited to provide a report 15 days prior to the hearing. Commissioner Swig stated that he wanted to supplement President Trasviña's request with the requirement that BUF address the items brought up by Josh Klipp.

#### (5) JURISDICTION REQUEST NO. 25-2

**Subject property at 111 Taylor Street.** Letter from Chandra Laborde, requestor, asking that the Board take jurisdiction over Letter of Determination No. 2024-010623ZAD, which was issued on January 28, 2025. The appeal period ended on February 27, 2025, and the Jurisdiction Request was filed at the Board office on April 21, 2025. **Determination Holder**: GEO Reentry Services . **Determination Description**: The Zoning Administrator determined that the legal use of the property is legal noncomplying Group Housing.

ACTION: Upon a motion by President Trasviña, the Board voted 4-0 to grant the request on the basis that the City inadvertently caused the requestor to be late in filing the appeal.

**Public Works Order No: 203887** 

The Director of Public Works held a Public Hearing on Thursday, November 12, 2020, commencing at 5:30 p.m. via teleconference to consider several items related to tree removals. In accordance with Gov. Gavin Newson's statewide order for all residents to shelter in place and the numerous local and state proclamations, the hearing was held through videoconferencing to allow remote public comment.

The hearing was to consider Order No. 203796 which supersedes Public Works order 203791 - To consider removal of eight (8) street trees with replacement at 198 McAllister St. Staff approved two (2) removals and the public has protested. Staff denied the removal of six (6) street trees and the applicant has appealed.

#### Findings:

The Department's presentation was made by Susan Nawbary, Bureau of Urban Forestry. In summary, BUF has recommended the removal of two (2) street trees and denied the removal of an additional six (6). The recommendations for removal are that one tree is leaning into the street and the other tree is lacking in size and would be replaced by a tree of equal or larger size. The recommendation for denial of the remaining trees is based on the fact that trees are difficult to establish in the Tenderloin and these six trees have done so.

In its appeal, UC Hastings proposed replacement of the eight (8) street trees with replacement of sixteen (16) street trees, along with a robust community greening benefit.

#### **Public Testimony:**

Justin Zucker, from Ruben, Junius & Rose, representing Hasting noted that the construction would be a several year project, including building below grade for the foundation. SFMTA requires that three lanes of traffic remain open on Hyde Street. However, if the trees were required to remain, construction would only allow two lanes to remain open.

Mr. Eric Quinn, project engineer from Build Group, responding to questions about potential conflicts between the proposed replacement street trees and site conditions. Mr. Quinn noted that streets vaults and other exiting conditions may limit the number of replacement trees along the frontage of the new construction to 13-14.

Mr. Roy Leggett, a consulting arborist, noted the difficult conditions in the Tenderloin, but stated that the new street trees would be supported by appropriate planting medium and irrigation.

M.s Rhionnon Bailard, Executive Director of Operations at UC Hastings, spoke to the Green Community Benefits Plan to mitigate the loss of the existing street trees. In summary, UC Hastings committed to a 3-1 replacement for the trees that would be removed, including 36" box trees surrounding the new construction and trees that would be appropriate and site specific in the community. Ms. Bailard committed to engaging with the community on the project. She also committed that UC Hastings would maintain, including replacement (if necessary) for all trees which are planted under the program for 36 months.

Simon, the Executive Director of the Tenderloin Community Benefit District, spoke in support of Hasting's proposal.

Mr. Joshua Klipp noted that the existing trees had only been planted a few years ago and that initially, the care of the trees was the responsibility of UC Hastings. He noted that trees struggle in the Tenderloin and that these trees were surviving and questioned removing them. He stated that any new planting should have appropriate protection to enhance their ability to survive.

Mr. John Nulty noted that there was no posting on the trees for removal, that the website did not contain adequate information and questioned Hasting's follow through.

#### Recommendation

After consideration of correspondence and testimony provided, the decision is to approve staff recommendation for the removal of two street trees with replacement, and approve the applicant's appeal and approve the removal of the additional 6 street trees with replacement, conditional upon:

- a. Adoption of UC Hastings' "Green Community Benefits Plan" to include a minimum of 3-1 replacement for the 8 street trees removed with 36" box trees on the frontage of the construction site. Per UC Hasting's plans and assessments, 14 trees are feasible at the construction site. Remaining trees to be planted off-site. On-site and off-site planting number will work in concert with one another.
- b. Maintenance of (including replacement, if necessary) of all planted trees for a minimum of 36 months.
- As practical, new plantings should provide appropriate tree protection to reduce the incident of vandalism
- d. Plant larger stature, climate appropriate trees where feasible per BUF Staff recommendations.
- e. Provide BUF with list of potential off-site planting sites.

#### UC HASTINGS GREEN COMMUNITY BENEFITS PLAN - WORK PLAN

December 29, 2020

#### INTRODUCTION

UC Hastings College of the Law ("UC Hastings") has adopted a Green Community Benefits Plan ("GCBP" attached as <u>Exhibit A</u>). in conjunction with the student housing project at 198 McAllister Street (the "Project"). The GCBP aims to equitably mitigate tree removals and other construction impacts required by the Project, notably the removal of eight (8) street trees adjacent to the campus. The Department of Public Works ("DPW") approved removal of the eight (8) street trees in Public Works Order No. 203887 and Permit No. 785005. This document describes the proposed implementation of the GCBP ("Work Plan").

#### GOALS & OBJECTIVES

UC Hastings recognizes that the collective impacts of a mature stand of trees can't be replicated merely by their replacement with an equivalent number of young trees and that construction impacts are overlaid upon the current pandemic crisis, the effects of climate change, and the trauma of generational environmental justice in our community. Therefore, the GCBP describes a hybrid mitigation strategy that prioritizes multi-functional, community-based solutions to current challenges that will support ongoing resilience for UC Hastings and the surrounding neighborhoods. The GCBP comprises:

- An integrated tree planting and care program.
- Immediate green space benefits in the La Cocina Marketplace Green.
- Initiation of and investment in the Green Community Benefits Fund; and
- Reliance on community design partners in decision-making.

The following sections outline the implementation processes for each component of the GCBP, including roles, sources of funding, and timeframes pursuant to contributing to a greener, healthier neighborhood.

#### I. TREE PROGRAM OBJECTIVES

Healthy, mature street trees offer myriad benefits to the Tenderloin Mid-Market neighborhood including ecosystem services such as carbon capture, storm water retention, mitigation of Urban Heat Island Effect and biodiverse habitat; as well as public health services such as cooling, access to nature in the city and the perception of calm. Street trees are an important organizing element of the healthy streetscape environment, highly critical for the Tenderloin Mid-Market neighborhood, where, due to traffic, vandalism and population density street tree survival is challenging.

The successful GCBP Tree Program will:

- Increase the replacement ratio of new, young trees to established, mature trees removed by a factor of three (3) trees.
- Rigorously select tree species and location for maximum stature, shade, hardiness, and cultural factors; and
- Engage in robust maintenance program both on and off-campus that includes replacement of damaged or dead trees as needed within thirty-six (36) months of initiation.

Through the GCBP Tree Program, UC Hastings aims to directly enhance the local urban forest canopy and model effective green stewardship that will maximize environmental benefit to the Tenderloin community over time.

#### 1. Expanded Replacement Ratio: Three -to- one, minimum

Twenty-four (24) new street trees will be planted to mitigate removal of eight (8) existing street trees in the following program.

- a. Along Project's frontages on Golden Gate Avenue, Hyde Street and McAllister Street: Plant fourteen (14) street trees <sup>1</sup>.
  - i. Site Selection: UC Hastings.
  - ii. <u>Species Selection:</u> UC Hastings, chosen from DPW's Bureau of Urban Forestry's ("**BUF**") Recommended Street Trees list.
  - iii. Tree Size: 36" box trees.
  - iv. Permitting: UC Hastings.
    - 1. Approval: DPW.
  - v. Tree Planting: UC Hastings.
  - vi. <u>Timeframe:</u> At completion of Project construction, anticipated Summer 2023.
  - vii. Funding: UC Hastings.

<sup>&</sup>lt;sup>1</sup> In the event site constraints limit the number of street trees that can be planted on-campus to below fourteen (14), there will be a corresponding increase in the number of street trees planted within the Tenderloin community resultant in a total of twenty-four (24) street trees being planted.

- b. Tenderloin community: Ten (10) street trees.
  - i. <u>Site Selection:</u> UC Hastings in consultation with Tenderloin community partners (*see* Section IV, below) and BUF; prioritizing sites with south-southwest exposure, proximity to the UC Hastings campus, La Cocina Marketplace Green and avoiding Municipal Transportation Agency "daylighting" (pedestrian safety) zones.
  - ii. <u>Species Selection:</u> UC Hastings in consultation with Tenderloin community partners, chosen from BUF's Recommended Street Trees list with focus on faster growing trees.
  - iii. <u>Tree Size:</u> 15-gallon, minimum, larger stature where feasible based on consultation with BUF.
  - iv. Permitting: UC Hastings.
    - 1. Approval: DPW.
  - v. Tree Planting: BUF.
  - vi. <u>Timeframe:</u> Within thirty-six (36) months of removal of eight (8) street trees adjacent to the Project.
  - vii. Funding: UC Hastings.
  - viii. <u>Community Engagement:</u> Develop and validate tree planting plan with community partners (as outlined in Section IV, below).

#### 2. Maintenance of Newly Planted Trees

- a. An effective watering and maintenance regime for newly planted trees is critical to establish and increase long-term viability.
  - i. <u>Responsible Party:</u> TBD, based on consultation with community design partners.
  - ii. <u>Timeframe:</u> For thirty-six (36) months from planting.
  - iii. Funding: UC Hastings.
  - iv. <u>Community Engagement:</u> Validate with community partners (as outlined in Section IV, below) tree maintenance plan and that trees are adequately maintained according to plan.

#### 3. Lost Trees Replacement

- a. In the event of loss of any trees planted pursuant to this GCBP, comparable replacement tree(s) will be planted.
  - i. Responsible Party: UC Hastings.
  - ii. <u>Timeframe:</u> Within thirty-six (36) months from original planting.
  - iii. Funding & Permitting: UC Hastings.
  - iv. <u>Community Engagement:</u> Validate with community partners (as outlined in Section IV, below) that any trees needing to be replaced are replaced according to plan.

#### II. LA COCINA MARKETPLACE GREEN OBJECTIVES

Understanding that the tree planting program benefits will accrue over time, but construction impacts upon the community are immediate, UC Hastings will invest in the La Cocina Marketplace Green. The La Cocina Marketplace Green will open to the public in January 2021 at the corner of Hyde Street and Golden Gate Avenue adjacent to the UC Hastings campus. The Marketplace Green plan includes a parklet and a bike corral integrated in a street frontage landscape designed to welcome patrons and visitors, enhance neighborhood greenspace and encourage healthy behaviors in an historically troubled corridor.

A successful La Cocina Marketplace Green will frame the Marketplace in a lively, appealing streetscape that welcomes patronage and enhances healthy neighborhood interactions through increased access to the growing world and the perception of calmness and safety.

#### 1. Green Streetscape

- a. Design and installation.
  - i. Responsable Party: La Cocina.
  - ii. <u>Project Management and Spatial Program Design:</u> Demonstration Gardens.
  - iii. Timeframe: January 2021 March 2022.
  - iv. <u>Funding:</u> La Cocina and UC Hastings; Community Challenge Grant (SF City & County), additional Foundation grants.
  - v. Permitting: La Cocina.
    - 1. Approval: DPW.
  - vi. <u>Community Engagement:</u> Demonstration Gardens / Tenderloin Peoples Congress, as outlined in Section IV below.

#### **b.** Activation.

Foster healthy street atmosphere through green stewardship.

- i. Responsable Party: La Cocina.
- ii. <u>Project Management & Activation Program Design:</u> Demonstration Gardens.
- iii. <u>Timeframe:</u> February 2021 June 2022.
- iv. Funding: La Cocina and UC Hastings.
- v. <u>Permitting:</u> La Cocina.
  - 1. Approval: DPW (as needed).
- vi. <u>Community Engagement</u>: Demonstration Gardens / Tenderloin Peoples Congress, as outlined in Section IV.

#### III. GREEN COMMUNITY BENEFITS FUND OBJECTIVES

UC Hastings recognizes that grassroots beautification projects can enhance immediate engagement in green stewardship. Therefore, the College will initiate and contribute to a fund designed to support microgrants that residents may apply toward small-scale greening and beautification projects.

A successful Green Community Benefits Fund will help ground green stewardship in resident initiative contributing to greater neighborhood resilience over time.

#### 1. Microgrants Fund

- a. Establishment of fund.
  - i. Responsible party: UC Hastings.
  - ii. Grant Administration: TBD.
  - iii. <u>Community Engagement Awards:</u> Tenderloin People's Congress and as outlined in Section IV below.
  - iv. Funding: UC Hastings one-time initial award, designed to expand.
  - v. <u>Timeframe:</u> Spring 2021 TBD.
- b. Ceremonial tree planting at Boeddeker Park.

Boeddeker Park is the heart of Tenderloin green space. This year a beloved tree at its entrance was lost to disease. In consultation with Friends of Boeddeker and the San Francisco Recreation & Parks Department ("**R&PD**"), the GCBF will be kicked off with a new tree planting and dedication party at the park.

- i. Responsible Parties: UC Hastings.
- ii. <u>Species Selection:</u> UC Hastings in consultation with Tenderloin community partners (*see* Section IV, below) and R&PD.
- iii. <u>Tree Size:</u> 15-gallon minimum, larger stature if feasible based on consultation with R&PD.
- iv. <u>Permitting:</u> UC Hastings.
  - 2. Approval: R&PD.
- v. <u>Tree Planting:</u> R&PD and/or BUF.
- vi. <u>Timeframe:</u> Spring 2021 (health orders dependent).
- vii. Funding: UC Hastings.
- viii. <u>Community Engagement:</u> Friends of Boeddeker Park, the YMCA (Boeddeker Park anchor tenants), and as outlined in Section IV below.

#### IV. COMMUNITY DESIGN PROGRAM

Each component of the GCBP outlined above is designed to begin modestly to address historic inequity in environmental justice in the community surrounding UC Hastings by recognizing grassroots organizing and residents' leadership toward a healthier neighborhood. The GCBP will engage community partners in a consultatory role to help design, validate, implement, and evaluate each component of the plan.

#### 1. Structure

- a. Increase equitability in determining quality of public life in the Tenderloin through co-design.
  - i. Responsible Party: UC Hastings.
  - ii. <u>Conveners:</u> Tenderloin Peoples Congress (Environmental Justice Committee).
  - iii. <u>Participants:</u> Inclusively open to Tenderloin residents, community-based organizations, such as the Tenderloin CBD, Faithful Fools, Glide, Healing Well, block safety groups; with agency support from the Office of District 6 Supervisor, City Planning, and BUF.
  - iv. <u>Timeframes:</u> Touchpoints and milestones as identified within each component. Overall, January 2021 January 2024.
  - v. Funding: TBD voluntary participation.

#### 2. Evaluation

For the duration of the implementation of the GCBP, measures of the GCBP will primarily be qualitative: How do residents, students and workers in the neighborhood feel about our streetscape? Is there a sense of ongoing improvement? A perception of increased safety and beauty? Of satisfaction with opportunities for resident input in decision-making?

Some relevant quantitative measures at the local neighborhood scale over time may include: increased biomass, reduced street temperatures, reduced tree mortality, improved stormwater retention, higher rate of biodiversity, sustained cleanliness and healthy activation. These effects are likely to become evident beyond the scope of the GCBP timeframes. However, the improvements introduced through this framework will offer the GCBP as a model, demonstrating in its trajectory and momentum the potential for a more environmentally healthy neighborhood for residents, students and workers.

#### **OUTCOMES**

UC Hastings aspires to be the greenest urban campus by 2025. UC Hastings understands that integration of green infrastructure on the requisite scale to support both campus and the Tenderloin community requires sustained commitment to environmental health and justice through design, implementation, and authentic community engagement.

The Green Community Benefits Plan has been prepared to guide UC Hastings contributions to our urban forest canopy, green spaces and stewardship, aimed toward building a more resilient Tenderloin community.

Dear President Lopez and Commissioners:

I write to update you on implementation of UC Law San Francisco's Green Community Benefits Plan ("GCBP"). The GCBP was established to equitably mitigate impacts from removal of eight (8) street trees necessary for construction of the 656-unit student housing mixed-use project at 198 McAllister Street. Recognizing the collective impacts from loss of mature trees cannot be addressed by replacement with an equivalent number, the GCBP calls for a three-to-one replacement ratio.

**Twenty-four (24) new street trees** are to be planted both on-campus, i.e., adjacent to 198 McAllister Street, and off-campus within the Tenderloin. In July 2023, **thirteen (13) new on-campus street trees** were planted, maximizing the amount on-campus trees (photos of planted trees attached as Exhibit A). The College is working to finalize the final community agreements for the remaining **eleven (11) off-campus street trees** within the Tenderloin neighborhood.

Two key components of the GCBP's street tree planting include:

- Reliance on community design partners in decision-making; and
- An integrated tree planting and care program.

The GCBP calls for engaging with community partners to help design, validate, implement and evaluate off-campus street tree site selection. Since approval of the GCBP, we have engaged with Tenderloin residents, community-based organizations, block safety groups, City Planning, and the Bureau of Urban Forestry to determine locations of the eleven (11) off-campus street trees. While this engagement took longer than anticipated to accomplish, it has resulted in a community-driven planting program benefiting numerous neighbors and the broader community. Specifically, we have identified the following **off-campus street tree locations in the Tenderloin**. All the planting locations below are final except for the last two (underlined) bullet-pointed locations (with their final approval pending an 11/09/24 meeting with the Golden Gate Greenway Coalition):

- Turk & Hyde Mini Park (201 Hyde St.): 4 trees
- Curry Senior Center (333 Turk St.): 2 trees
- 111 Jones Senior Housing (111 Jones St.): 1 tree
- Vera Haile Senior Housing (129 Golden Gate Ave.): 1 tree
- Larkin Street Youth Services (134 Golden Gate Ave.): 1 tree
- Madonna Residences Senior Housing (350 Golden Gate Ave.): 1 tree
- **112 Hyde St.:** 1 tree



As to the second component, the College has established a **robust maintenance program** for street trees planted through the GCBP. For off-campus street trees, the College has partnered with local community members located proximate to the trees who have committed to watering the trees. For example, the Curry Senior Center gardening club will water the trees planted near them. The Tenderloin Community Benefit District will assist with watering the trees at the Turk & Hyde Mini Park. St. Anthony's Foundation will assist with watering the trees outside 111 Jones, Vera Haile, and Larkin Street Youth Services. The College will water the trees outside the Madonna Residences and 112 Hyde Street. However, the College is committed to these trees and their success even if our partners are unable to continue to water them. Specifically, for both on- and off- campus street trees planted, UC Law SF will monitor, maintain, and replace damaged or dead trees as needed within thirty-six (36) months of planting. In the approximately eighteen (18) months since planting the oncampus trees, they are thriving and none have been lost to damage/vandalism, likely due to selection of more robust species and size of trees.

In addition to street tree plantings, the GCBP included two other components to help uplift **small-scale greening and beautification projects** in the Tenderloin, one at Boeddeker Park and another at the former La Cocina Marketplace. In consultation with San Francisco Recreation & Parks Department, the College planted a tree at Boeddeker Park on October 14, 2021, in partnership with multiple community organizations to add shading and beautify the park to make it more appealing for use by families and children.

The College also helped La Cocina Marketplace establish a parklet and bike corral, the La Cocina Marketplace Green at the corner of Hyde Street and Golden Gate Avenue adjacent to the campus. The parklet framed the Marketplace in a lively, appealing streetscape that sought to welcome patronage and enhance healthy neighborhood interactions. Unfortunately, while the La Cocina Marketplace Green was successfully implemented in April 2021, it was subsequently decommissioned at the end of summer 2023 at the request of the San Francisco Police Department given its potential to provide cover for negative activity including drug dealing, use, and stolen goods vending.

The College understands that integration of green infrastructure on the requisite scale to support both its campus and the Tenderloin community requires sustained commitment to environmental health and justice through design, implementation, and community engagement. The College has worked to grow the urban canopy, green spaces and stewardship, aimed toward building a more resilient Tenderloin community. To demonstrate our commitment to the GCBP and the broader community, **UC Law SF commits to planting the eleven (11) remaining off-campus street trees by December 31, 2024**. The College will report back to the Board of Appeals before year end with an update on the status of planting the off-campus street trees. President Trasviña and Commissioners:

The purpose of this submittal is to provide updates on the permit conditions and mitigations that were subject of previous appeals to Board of Appeals.

Appeal No. 20-081 (198 McAllister) UC Law San Francisco

(a) Adoption of UC Hastings' (now UC Law San Francisco) "Green Community Benefits Plan" to include a minimum of 3 – 1 replacement for the eight (8) street trees removed with 36" box size trees on the frontage of the construction site; remaining trees to be planted off site, on-site and off-site planting number will work in concert with one another;

Status: Completed (25 total trees planted, to meet the 3-1 replacement requirement)

Description: Fourteen (14) street trees, 36" box trees, planted at project site 198 McAllister.

UC Law San Francisco also planted eleven (11) street rees in the neighborhood at the following

locations. We worked closely with staff to find alternate locations for two sites which had

underground utility conflicts. There have been a few changes over the past few months, below

are the addresses of the planting sites, which were planted with Lagunaria pattersonii trees:

• (1)134 Golden Gate Ave.

• (1)191 Golden Gate Ave.

• (1)350 Golden Gate Ave.

• (2) 121 Jones St.

• (4) Turk/Hyde Mini Park

• (1) 418 Larkin St.

• (1) 499 Turk St.

(b) maintenance of (including replacement if necessary) all planted trees for a minimum of 36

months;

Status: active/ongoing/monitoring

Description: UC Law San Francisco has re-staked and added back protective screening as

necessary; submitted photos with tree protection in place (some trees on Hyde no longer

require tree protection – because they were planted very large).

Additional feedback from Mike Yarak, Program Director, Friends of the Urban Forest, regarding the community tree planting (April 17, 2024):

"Yes, confirming that we worked with UCSF and the neighboring community to plant 42 street trees in the neighborhood around the Parnassus campus. These trees were planted in February 2024, and as Morgan mentioned, are in the establishment period for approximately the next two years. As for an update on our end, we recently invited the community members back out and hosted a volunteer tree care event here!"

#### Status:

To date, UCSF has completed the portions of the conditions that can be completed at this time. The community tree planting of 42 trees is completed over a year ago, and is in the 2<sup>nd</sup> year of the three year maintenance period. They are actively constructing their building at the project site and will not be planting the on site trees for several more years.

The other condition to the permit is that San Francisco Public Works, Bureau of Urban Forestry, use the funds provided by UCSF (\$242,000) to secure a grant to plant approximately 105 new plantings sites, with 24" box size trees in high priority sites identified in the Urban Forest Plan.

#### Update:

Anticipating the time required to identify the potential plantings sites and entering the contracting process that is now overseen by the Public Works Commission, our buffer of three

years to complete this planting was prescient. Three years from the date of the BOA Notice of Decision places the deadline at February 22, 2026. We believe we can still meet this goal of having the trees planted by this date. We will provide additional information and updates in person at the May 7<sup>th</sup> hearing on this item.

#### Update on Cause of Delay in Meeting 12/31/24 Commitment for GCBP by UC Law SF

May 2, 2025

As part of the development of 656-campus housing units at the 198 McAllister Street project, UC Law San Francisco committed to a Green Community Benefits Plan. This plan had a number of elements, but most relevant to the Bureau of Urban Forestry (BUF) was the commitment to plant 3 trees for each tree removed, for 24 trees total. The College planted 13 trees surrounding the 198 McAllister building footprint and thus committed to plant 11 additional trees in the surrounding neighborhood by December 31, 2024. The College worked hard to meet this deadline; however, several issues were encountered resulting in the planting of 7 trees by December 2024, and the final 4 trees planted by April 25, 2025. The complicating factors were:

- The College's landscaping consultant's project manager left mid-process, without clear notice to the College, delaying coordination.
- Several sites that were originally selected and coordinated with community stakeholders were ruled out due to conflicting underground utilities. New sites needed to be selected and assessed, which required coordination over again.
- Saw cutting of select sites required coordination between multiple vendors and the City, which extended the timeline.
- The College used standard stakes for the 7 trees planted in December 2024, which were not effective in protecting the trees, leading to vandalism.
- The College then inadvertently wasted time trying to procure metal stakes to better protect the trees, but the landscaping company's vendor had difficulty sourcing them and providing a timely quote.
- Ultimately after consulting with BUF and Friends of the Urban Forest (FUF), the College shifted to an easier to procure and implement wire caging model and sourced the final replacement planting sites with BUF.

All remaining trees were successfully planted, and the project was completed in April 2025. Although the College did not meet the deadline, they maintained open communication with BUF and FUF, keeping them informed of progress and setbacks. The College now has a much better sense of how to streamline the process for any future plantings, including the commitment to replace any trees that are lost or damaged within a 3-year term following these plantings. The College appreciates BUF and the Board of Appeals understanding as they navigated this project.

The Bureau of Urban Forestry will give an update on Appeal No. 22-079 at 401 Parnassus (UCSF) which was decided by the Board on February 8, 2023

#### I. Introduction

On December 14, 2022, the Board of Appeals ordered the parties to Appeal No. 22-079 to collaborate on a tree replacement plan with regards to Public Works Order No. 207226 and Permit No. 792615 – the permit on appeal in that matter. In response to the Board of Appeals' order, the University of California ("UC"), San Francisco ("UCSF") has prepared this Tree Replacement Plan (the "Plan") in conjunction with the New Hospital at Parnassus Heights at 401 Parnassus Avenue (the "Project"). This Plan aims to equitably mitigate tree removals and other construction impacts required by the Project, notably the removal of twenty-eight (28) street trees adjacent to the Project site.

#### II. Goals and Objectives

UCSF recognizes that the collective impacts of removing a mature stand of trees cannot be replicated merely by their replacement with an equivalent number of young trees. Therefore, the Plan describes a hybrid mitigation strategy that prioritizes multi-functional, community-based solutions to current challenges that will support ongoing environmental resilience for UCSF and the surrounding neighborhoods, as well as other areas of the City in greatest need of new trees. The Plan comprises:

- A. An integrated tree planting and care program.
- B. Immediate green space benefits in the Parnassus Heights neighborhood.
- C. Initiation of and investment of funds by way of in-lieu tree fee payments to DPW-BUF; and
- D. Reliance on community partners in decision-making.

The following sections outline the implementation processes for each component of the Plan, including roles and timeframes, with the goal of contributing to greener, healthier neighborhoods.

## III. Tree Program

#### Hi all,

We are developing a plan for new cut sites in disadvantaged census tracts that are **outside** of the IRA Grant areas (purple with no blue outline) and outside of CNRA (all blue).

This also involves coordinating around Friends of the Urban Forest projects in Portero Hill and Bayview in the next 2 months.

This plan operates under the assumption that the IRA grant **will** still be distributed. If the IRA grant is canceled, our options for finding the sites in disadvantaged census tracts **increase**.

I understand that not all areas that **should** receive new trees appear here. For example, streets next to freeways in SOMA tend to have low population density, so those won't show up as disadvantaged census tracts, but could still be valuable planting locations. So, we may seek flexibility on the locations that don't meet disadvantaged census tracts criteria but still suffer from pollution impacts and low canopy. We welcome input on **areas not highlighted on this map** that could benefit from trees.




Step 2) send work scope to contracts team

The inspection team is small and has experienced various adjustments in the last two years. We are working through several time sensitive assignments before turning our attention toward canvassing for sites. We appreciate Josh's patience, as well as the Board's.

The Bureau of Urban Forestry within Public Works and permit holder

UCSF/Parnassus Heights committed to providing an annual update to the Board of Appeals regarding the tree removal mitigations that were a condition of the Notice of Decision on Appeal 22-079, filed by Josh Klipp. Attached is a copy of the Notice of Decision issued on 2/22/2023 by Board of Appeals and a copy of Tree Removal permit no. 792615 issued by Public Works to UCSF on 2/27/2023.

During public comment last month, Mr. Klipp noted that the first year was coming to a close and that it was time for the annual update on the mitigations. Enclosed is our update for this year. I have included within the body of this letter, the email update Public Works received from UCSF. Both Public Works and UCSF are on track with meeting the tree removal mitigations.

We have received the following update from UCSF this month:

• In lieu fee: \$242,000 was paid to Public Works on 2/16/2023

• **42 neighborhood street trees**: Over the summer 2023, Friends of the Urban Forest was the community organization chosen to lead the Greening Parnassus Heights Initiative, which will plant 42 street trees in the neighborhoods surrounding the Parnassus Campus. Since then, they

have been working with the neighborhood to identify viable tree basin locations and a community meeting was held on 1/11/2024 outlining the process and plans for the tree plantings. The tree planting day is set for 2/24/2024. After the trees are planted, UCSF will be

paying for the first three years of tree maintenance.

• 14 Parnassus Ave street trees: In February the project team will be submitting 100% Design Documents for NHPH Site Improvement Permit for Parnassus Avenue, these plans include the 14

#### I. Introduction

On December 14, 2022, the Board of Appeals ordered the parties to Appeal No. 22-079 to collaborate on a tree replacement plan with regards to Public Works Order No. 207226 and Permit No. 792615 – the permit on appeal in that matter. In response to the Board of Appeals' order, the University of California ("UC"), San Francisco ("UCSF") has prepared this Tree Replacement Plan (the "Plan") in conjunction with the New Hospital at Parnassus Heights at 401 Parnassus Avenue (the "Project"). This Plan aims to equitably mitigate tree removals and other construction impacts required by the Project, notably the removal of twenty-eight (28) street trees adjacent to the Project site.

#### II. Goals and Objectives

UCSF recognizes that the collective impacts of removing a mature stand of trees cannot be replicated merely by their replacement with an equivalent number of young trees. Therefore, the Plan describes a hybrid mitigation strategy that prioritizes multi-functional, community-based solutions to current challenges that will support ongoing environmental resilience for UCSF and the surrounding neighborhoods, as well as other areas of the City in greatest need of new trees. The Plan comprises:

- A. An integrated tree planting and care program.
- B. Immediate green space benefits in the Parnassus Heights neighborhood.
- C. Initiation of and investment of funds by way of in-lieu tree fee payments to DPW-BUF; and
- D. Reliance on community partners in decision-making.

The following sections outline the implementation processes for each component of the Plan, including roles and timeframes, with the goal of contributing to greener, healthier neighborhoods.

#### III. Tree Program

- 14 new street trees on City property (36in box)
- 42 new street trees in Neighborhood 15 gallon
- 105 new street trees (in-lieu fee payment to DPW-BUF)
- 13 new trees on UCSF property within 10ft (24in box)

- 6 trees on Level 8 courtyard

- A. A total of fifty-six (56) new street trees will be planted to mitigate removal of the twenty-eight (28) street trees. An additional in-lieu fee payment in the amount of \$242,000 will be provided by UC to the Department of Public Works, Bureau of Urban Forestry ("DPW-BUF") for the planting of an additional 105 street trees (\$242,000 ÷ \$2,302 [DPW-BUF's 2023 in-lieu fee]).

President Trasviña and Commissioners:

The purpose of this submittal is to provide updates on the permit conditions and mitigations that were subject of previous appeals to Board of Appeals.

Appeal No. 20-081 (198 McAllister) UC Law San Francisco

(a) Adoption of UC Hastings' (now UC Law San Francisco) "Green Community Benefits Plan" to include a minimum of 3 – 1 replacement for the eight (8) street trees removed with 36" box size trees on the frontage of the construction site; remaining trees to be planted off site, on-site and off-site planting number will work in concert with one another;

Status: Completed (25 total trees planted, to meet the 3-1 replacement requirement)

Description: Fourteen (14) street trees, 36" box trees, planted at project site 198 McAllister.

UC Law San Francisco also planted eleven (11) street rees in the neighborhood at the following

locations. We worked closely with staff to find alternate locations for two sites which had

underground utility conflicts. There have been a few changes over the past few months, below

are the addresses of the planting sites, which were planted with Lagunaria pattersonii trees:

Additional feedback from Mike Yarak, Program Director, Friends of the Urban Forest, regarding the community tree planting (April 17, 2024):

"Yes, confirming that we worked with UCSF and the neighboring community to plant 42 street trees in the neighborhood around the Parnassus campus. These trees were planted in February 2024, and as Morgan mentioned, are in the establishment period for approximately the next two years. As for an update on our end, we recently invited the community members back out and hosted a volunteer tree care event here!"

#### Status:

To date, UCSF has completed the portions of the conditions that can be completed at this time. The community tree planting of 42 trees is completed over a year ago, and is in the 2<sup>nd</sup> year of the three year maintenance period. They are actively constructing their building at the project site and will not be planting the on site trees for several more years.

The other condition to the permit is that San Francisco Public Works, Bureau of Urban Forestry, use the funds provided by UCSF (\$242,000) to secure a grant to plant approximately 105 new plantings sites, with 24" box size trees in high priority sites identified in the Urban Forest Plan.

#### Update:

Anticipating the time required to identify the potential plantings sites and entering the contracting process that is now overseen by the Public Works Commission, our buffer of three

years to complete this planting was prescient. Three years from the date of the BOA Notice of Decision places the deadline at February 22, 2026. We believe we can still meet this goal of having the trees planted by this date. We will provide additional information and updates in person at the May 7<sup>th</sup> hearing on this item.
