

## Summary of Complaints Received in January 2025


The Department of Police Accountability received a total of **65** cases in **January 2025**, **61** SFPD complaints and **4** SFSO complaints. Compared with a total of **67** cases, **65** SFPD complaints and **2** SFSO complaint, in the same period last year, the **January 2025** case total is **5%** higher than the five-year average and is **3%** lower than the previous year.

Currently, DPA has a total of **262** pending cases, **222** SFPD and **40** SFSO.

In January, DPA <u>received</u> a total of **0** referral(s) from SF Sheriff's Office and <u>referred</u> a total of **1** case(s) to SFSO.



# Year to Date Monthly Count of Cases Received (SFPD+SFSO)




