Architect Jay Wilson shared that the building design is mostly the same as before, with some refinements. Wilson mentioned the office space has grown from four to five floors, but the footprint remains the same. Wilson noted the design separates the warehouse and office areas, using different shapes and materials to add interest—glass sections pop out in the office area, and translucent panels bring light into the warehouse.

Materials include white metal panels, clear glass, and polycarbonate. The landscape design reuses existing airport plants, with some added trees and shrubs. Commissioners supported the improvements, noting the building's clean design and good use of light and texture.

Commissioner Shiota, seconded by Commissioner Rothschild moved to approve SFO Westfield Campus: Bldg 626. – Phase 2 Review.
