The Police Commission of the City and County of San Francisco met in Room 400, City Hall, #1 Dr. Carlton B. Goodlett Place, San Francisco 5:33 p.m.

Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Acting Chief Yep, reported on crime trends YTD: Violent Crime down 20 percent; homicide down 29 percent; rape down 28 percent; robbery down 27 percent; assault down 13 percent; human trafficking up 86 percent. Property Crimes down 29 percent; burglary down 25 percent; motor vehicle theft down 44 percent; arson down 24 percent; larceny theft down 26 percent. Gun violence is down 20% compared to 2024; One non-fatal shooting incident this week; total 52 fire-arm related incidents resulting in 63 victims YTD. One homicide for the week; there is a total of 12 homicides YTD with 10 resulting from a firearm; 155% overall clearance.

- Announced Promotion of Captain Hector Jusino to Commander of Night Investigations, highlighted his responsibilities.
- Thanked Commissioner Benedicto and Paulette Brown for attendance at Juneteenth Parade, thanked Officers for Justice organization for allowing him to walk with them at the Juneteenth parade, thanked Pride Alliance and Sergeant Kathryn Winters for attendance and work at Pride Parade, thanked Commissioner Leung for attending Chinese Chamber Board Lunch.
- 6/25/25 – hosted 28th Annual Law Enforcement Torch Run with Sheriff's Office for the Special Olympics
- Provided updates to the Commissioners and public from last Commission Meeting:

Significant Incident: Sideshow activity and Battery incident, 6/21/25, 17:12, Taraval, 42nd Ave and Lawton, approximately 20-40 vehicles, approximately 100 spectators reported to be participating in a sideshow event, reports of fireworks and water balloons thrown at motorists and people in the area, Officers arrived and participants fled in different directions, victim of a physical assault by one of the participants, was able to provide video of the incident, victim treated at scene, further investigation being conducted. Seizure of illegal gambling machines, narcotics and firearm in Tenderloin from a liquor store, 6/24/25, Tenderloin Station and DMACC executed a search warrant, 200 block of Taylor Street, seized items, search came after a month-long investigation into business that was suspected of operating an illegal gambling facility and selling tobacco products without a permit. Homicide, 7/5/25 00:08, 100 block of Harbor, Bayview, several victims located with gunshot wounds, one

homicide, four non-fatal injuries, victims transported, two with life threaten injuries, three with non-life-threatening injuries, one succumbed to injuries, no arrests. 7/5/25, 17:00, Serious traffic collision, Pier 39 garage, motorcycle stopped at a red light and proceed at their green light, a scooter at the same time crossed their red light and was struck by motorcycle and both sustained series injuries and were transported.

Significant arrest: Homicide, 6/21/25 15:58, Bayview, 100 block of Oakdale, Officers located victim suffering from gunshot wounds, victim succumbed at the scene, suspect located and booked. 6/25/25 - 97 arrests made in a one-day fugitive enforcement operation. Hot prowls suspect arrested, series of burglaries cases, 5/28/25 incident date, Officers responded to 1500 block of Funston Ave regarding hot prowls burglaries, possible suspect located and detained, due to knowledge of several hot prowls burglaries occurring in the area and surrounding areas, similar M.O., suspect description and video surveillance, probable cause was developed to arrest suspect on multiple counts, through investigation 13 hot prowls burglaries attributed to suspect.

Strategies: Fourth of July, San Francisco Civil Grand Jury Report from May 2024, weaponization of fireworks was addressed, devastating impact to city, potential trauma, damage and injuries, finding no. 4 – if city fails to control the deployment of illegal fireworks in the public's presence it results in dangerous situations. SFPD prepared for 4th of July, with other agencies, all Officers working, citywide – 47 B Priority explosions, 395 C Priority disturbances, DEM fire calls for service data – 7/4/25, 2130-0000, one working building fire – fireworks related, 25 grassfires, 23 trash fires, 31 other fireworks related calls, 10 fireworks related injuries, one fall from a roof, 5 shooting victims mentioned earlier. Movement of people in and out coordinated well, Mission District intersections were problematic-posed danger to public – 26th St and Treat Ave, fireworks and crowd control, about 150 people were blocking intersection and launching commercial grade, felony violation fireworks, also blocking pedestrian and vehicle traffic, despite repeated warnings crowd did not stop and became hostile towards citizens and police, multiple dispersal orders given via loudspeaker, platoon of Officers – redeployed from other parts of the city- moved towards the crowd, additional fireworks launched at Officers' platoon, tactical members deployed less than lethal projectiles used to disperse crowd, no reported injuries, force documented and report generated. 21st Street and Bryant Street – 100+ crowd, fireworks and glass bottles thrown at Officers, crowd dispersed after multiple orders, no further action by SFPD. Hampshire and 20th, 00:21, 40-50 people launching fireworks, fireworks and glass bottles thrown at Officers, 18-year-old suspect arrested and rebooked by DA's Office. Folsom and 26th, 23:30, firearm arrest by Gang Task Force, GTF spotted suspect, suspect fled on foot, foot pursuit occurred, taken into custody on Cesar Chavez Street where Officers located a firearm, narcotics seized.

Executive Director Henderson reported the following: In the year 2025: 496 cases opened; 497 closed; 94 pending; 22 cases sustained; 10 cases past 270-day; 4 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting)**: 66. Central, 7. Southern, 5. Bayview, 6. Mission, 8. Northern, 2. Park, 1. Richmond, 2. Ingleside, 4. Taraval, 0. Tenderloin, 7. Airport, 1. Not Applicable, 8. Out of Jurisdiction, 2. Pending, 13. Allegation Summary: Conduct Unbecoming an Officer The officer behaved or spoke inappropriately-22%. Neglect of Duty The officer failed to take required action- 10%. Neglect of Duty The officer failed to properly investigate- 10%. Unwarranted Action The officer engaged in unwarranted action- 9%. Unwarranted Action The officer conducted an improper search or seizure- 7%.

Audits: The Association of Local Government Auditors featured DPA's audit of SFPD's stop data in its 2025 Summer Quarterly. The edition focuses on "Police and Law Enforcement", and it highlights innovative audits from across the country. DPA's work appears alongside pieces from oversight agencies in Washington, Chicago, Pasadena, and Seattle, covering topics such as body-worn camera compliance, jail conditions, and use-of-force investigations.


