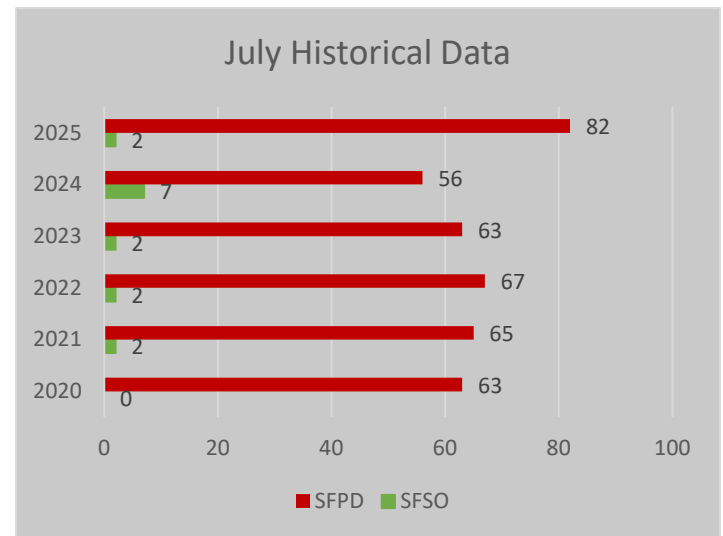
Re: San Francisco Department of Police Accountability July 2025 Monthly Statistical Report

Summary of Complaints Received in July 2025

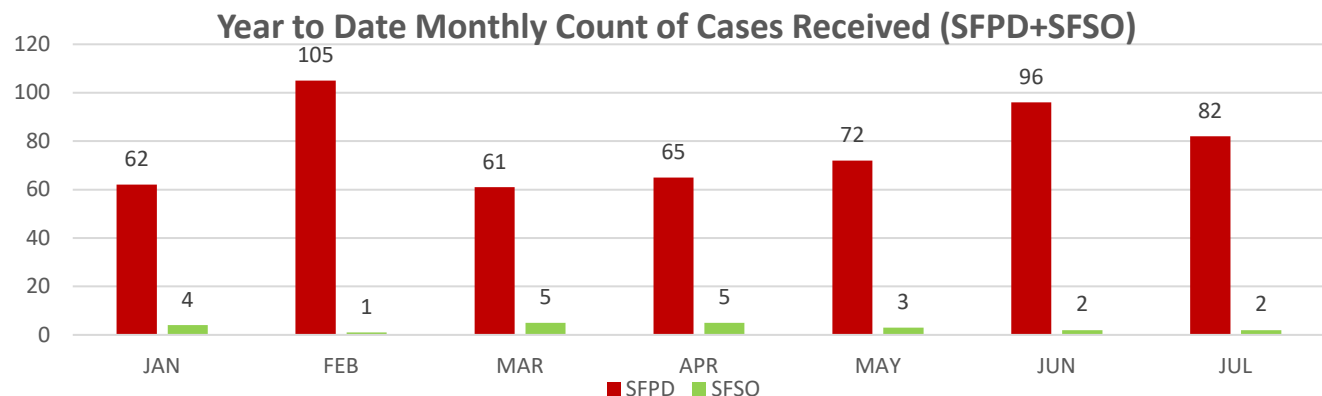
The Department of Police Accountability received a total of **84** cases in **July 2025**, **82** SFPD complaints and **2** SFSO complaints. Compared with a total of **63** cases, **56** SFPD complaints and **7** SFSO complaint, in the same period last year, the **July 2025** case total is **29%** higher than the five-year average and is **33%** higher than the previous year.

From January through July, the DPA received a total of **565** new cases, **543** SFPD complaints and **22** SFSO complaints. Compared with the **450** cases filed during the same period in 2024, **425** SFPD complaints and **25** SFSO complaint. The July year to date case total represents an **26%** increase in new complaints over last year.



Currently, DPA has a total of **266** pending cases, **228** SFPD and **38** SFSO.

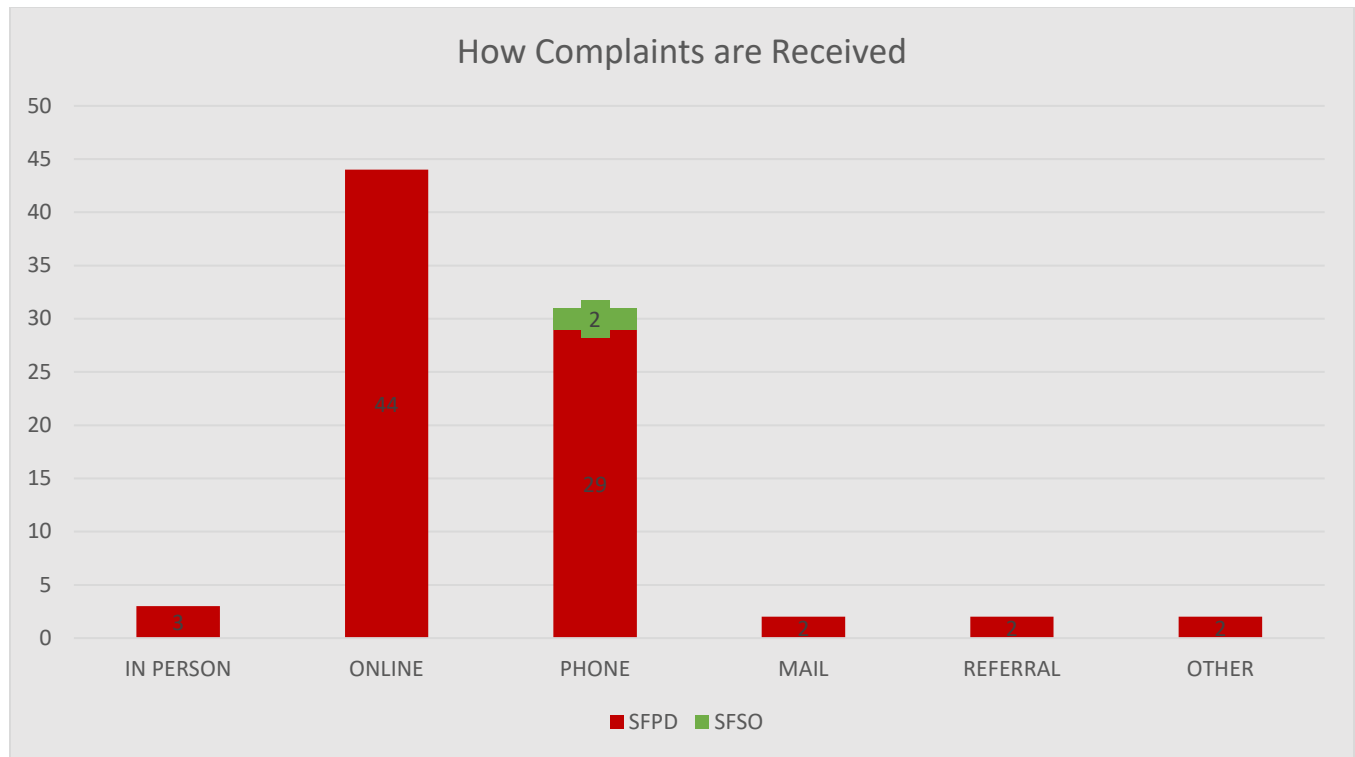
In June, DPA received a total of **0** referral(s) from SF Sheriff's Office and referred a total of **2** case(s) to SFSO.
