Commissioner Ferras began the meeting by reading the Arts Commission's land acknowledgement statement.

3. General Public Comment

(6:38)

Public Comment(s)

Geoffrey Grier, SF Recovery Theatre

Grier spoke against changes to funding that he said was originally intended for the Black theater community. Grier expressed concerns about recent grant eligibility requirements and funding policies. Grier stated that the changes make it more difficult for artists and arts organizations to access support. Grier urged the Arts Commission to advocate more strongly on behalf of artists.

Lindsey White, Artist

White discussed the challenges artists face due to rising costs, funding cuts, and the closure of local arts institutions. White expressed concern about artists leaving San Francisco because of a lack of support and opportunities. White encouraged the City to consider programs that provide direct financial assistance to artists. White asked the Arts Commission to take a leadership role in supporting the local arts community.

Meg Shiffler, Artist Space Trust

Shiffler spoke in support of the SFAC Galleries Program and highlighted its long history of serving artists and the public. Shiffler described the galleries as one of the Arts Commission's most visible and impactful programs. Shiffler expressed concern that staffing reductions would limit public programming and artist opportunities. Shiffler urged the Commission to restore staffing and funding for the galleries.

Juana Alicia Araiza, Muralist

Araiza praised the professionalism and expertise of Arts Commission staff

based on his experience working on public art projects. Araiza expressed concern about proposed staffing and budget reductions. Araiza stated that cuts would weaken public arts programs and reduce services for artists and the community. Araiza encouraged the Commission to advocate for preserving these resources.

Woody Hanson, SOMArts Cultural Center

Hanson discussed financial challenges facing cultural centers and arts organizations. Hanson requested increased funding to help organizations continue serving artists and the public. Hanson also raised concerns about reimbursement-based grant policies and the cash-flow burdens they create. Hanson encouraged continued investment in San Francisco's arts infrastructure.

Cece Carpio, Artist

Carpio spoke about the important role the galleries program plays in supporting artists and engaging the public. Carpio described the galleries as a key entry point for people to learn about the work of the Arts Commission. Carpio expressed concern about staffing reductions and their impact on artists and programs. Carpio also called for transparency regarding budget and staffing decisions.

Lian Ladia, Curatorial and Organizational Director at 500 Capp Street

Ladia spoke in support of Arts Commission staff and emphasized the importance of their work. Ladia noted the challenges facing arts organizations and cultural workers across the city. Ladia expressed concern about the loss of staff positions that support public programs and artist services. Ladia urged the Commission to protect staff positions and invest in the people who sustain San Francisco's arts community.

Rachelle Axel, ABBA

Ms. Axel criticized new grant payment and reimbursement policies, stating they impose hardships on artists and small arts organizations. She called for

suspension of the policies and greater engagement with affected stakeholders before implementation.

Joe Kreidler, Artist

Kreidler discussed challenges artists face under revised grant administration requirements and reimbursement procedures. Kreidler urged the Commission to place greater trust in artists and reduce administrative burdens associated with grants.

Jenifer Wofford, Artist

Wofford expressed concern about staffing reductions at the Arts Commission, particularly within the galleries program. Wofford spoke about the positive impact Arts Commission programs have had on their career and the broader arts community. Wofford questioned whether budget reductions to such a small program would provide meaningful savings. Wofford urged continued support for arts programming and staff.

Kim Arteche, Executive Director, Brava

Arteche discussed how the SFAC Galleries Program has supported artists and strengthened the local arts community. Arteche shared her own experiences participating in gallery programs and public events. Arteche expressed concern about the loss of gallery staff and the impact on future opportunities for artists. Arteche asked the Commission to advocate for restoring staffing and funding.

Ace Washington, Fillmore Corridor Ambassador

Washington requested a review of his application, which he states was denied because of an address-related issue. Washington stated that he has a long history of community work and involvement with City programs. Washington asked the Commission to investigate the matter and reconsider his proposal. Washington also expressed frustration with the application process.

Maria Jensen, Executive Director, SOMArts Cultural Center

Jensen spoke against reductions to cultural center funding and raised concerns about administrative costs. Jensen questioned budget decisions that she believes reduce resources available for community arts programming. Jensen encouraged commissioners to take a more active role in advocating for artists and cultural organizations. Jensen also expressed concerns about grant repayment policies.

Vinay Patel, Executive Director, Asian Pacific Islander Cultural Center

Patel encouraged the Commission to advocate more strongly for arts funding and staffing. Patel emphasized the importance of restoring support for arts programs and maintaining resources for artists and cultural organizations. Patel noted that arts funding contributes to the city's identity, economy, and quality of life. Patel urged continued collaboration between the Commission and the arts community.

There was no additional public comment.

4. Committee Reports and Committee Matters

4.1 Civic Design Review Report

(46:17)

Commissioner Brenzel reported that the Civic Design Review Committee approved updates to the San Francisco International Airport Terminal 3 West Project, including the addition of a second level to the United Airlines Club. Commissioners discussed the design changes, passenger experience, and future opportunities for public art. The Committee also approved the Phase 3 design for Harvey Milk Plaza, which includes accessibility improvements, public gathering spaces,

landscaping, lighting, and memorial elements. Commissioners praised the project and noted strong community support for the long-awaited improvements.

There was no public comment.

4.2 Visual Arts Committee Report (49:04)

Commissioner Beltran reported that the Visual Arts Committee reviewed and approved updates to the Civic Art Collection and Public Art Program policies and guidelines. The Committee also approved several public art projects, including artworks for San Francisco International Airport, Treasure Island, the Art on Market Street poster series, and a temporary sculpture installation in Civic Center Plaza. The projects feature a variety of artistic mediums and themes and will be presented at public sites throughout San Francisco. All items were approved by the Committee and forwarded for consideration on the Consent Calendar.

There was no public comment.

4.3 Executive Committee Report (54:14)

Vice President Shiota reported that the Executive Committee approved Cultural Center grants for FY 2026–27, including an 8.8% funding increase to support operations and programming. Commissioners discussed the importance of sustaining cultural centers despite ongoing budget challenges. The Committee also approved a two-year funding agreement with the San Francisco Symphony for FY 2025–26 and FY 2026–27. Both items were approved unanimously and forwarded to the Consent Calendar for final approval.

There was no public comment.

6. SFAC Galleries Program Updates

(1:00:15)

Acting Director of Galleries Jackie Im provided updates on recent and upcoming gallery exhibitions, public programs, and artist residency activities. Im highlighted the successful closing of Dream Jungle, the extension of Moving San Francisco, and the opening of the new exhibition I Split the Ground So It Would Not Close Over Me. Im also presented the upcoming Fall 2026 exhibition, Excavating Uranus*, A Psalm for Nyota Uhura, featuring works by several contemporary artists. During the presentation, Im noted that the elimination of a

Galleries position that may affect the gallery's ability to continue offering certain public programs and community engagement activities.

Public Comment(s)

Shirin Makaremi, Curator

Makaremi spoke about the importance of the SFAC Galleries Program in supporting emerging artists and curators. Makaremi highlighted the value of public programs, workshops, screenings, and artist talks in connecting artists with the community. Makaremi urged the Commission to reconsider staffing reductions, noting that public programming is essential to the success of gallery exhibitions.

Lindsey White, Artist

White shared her experiences working with the SFAC Galleries Program and emphasized the importance of public programs in supporting artists and educating the public. White spoke in support of the Galleries position and urged the Commission to protect gallery staffing and resources.

Elisabeth Nicula, Artist, Writer, and Publisher

Nakula spoke in support of the SFAC Galleries Program as an important public space for artists and ideas. Nicula encouraged the Arts Commission to increase support for the galleries and preserve public arts infrastructure.

Jordan Stein, Cushion Works

Stein described the galleries as an important platform for emerging artists, established artists, and artist legacy projects. Stein highlighted the role of public programs in building community and preserving local arts history. Stein urged the Commission to support gallery staffing and programs.

Angela Berry, Former Art Professor

Berry spoke about the galleries' significant impact despite representing a small portion of the Arts Commission budget. Berry expressed concern about staffing cuts and encouraged the City to protect public sector arts positions and services.

Maggie Haas, Artist and Community Member

Haas spoke in support of the SFAC Galleries Program and expressed concern about the elimination of staff positions. Haas highlighted the importance of education, public programs, and artist residency opportunities for artists and community members.

Taylor Snowberger, Root Division, SFUSD

Snowberger spoke about the importance of arts education and public programming. Snowberger expressed concern about staffing reductions and encouraged continued investment in programs that help the public engage with contemporary art.

Rachelle Axel, ABBA

Axel described the galleries as a key entry point for artists within the Arts Commission. Axel expressed concern that staffing reductions would weaken artist development opportunities and urged commissioners to advocate for preserving the galleries program.

Sunny Angulo, Board Member, Arts for a Better Bay Area

Angulo spoke about the galleries' role in supporting artists and providing opportunities for emerging arts professionals. Angulo raised concerns about budget transparency and leadership decisions and encouraged commissioners to advocate for the arts community.

Meg Shiffler, Director, Artist Space Trust

Shiffler emphasized the importance of public programs in supporting artists across many disciplines and connecting the community with exhibitions. Shiffler expressed concern that eliminating key staff

positions would reduce programming and place additional burdens on artists and curators. Shiffler encouraged the Commission to continue investing in the galleries and their public-facing work.

7. Cultural Center Presentation – Asian Pacific Islander Cultural Center (1:35:50)

Executive Director Vinay Patel and Artistic Director Melanie Bennett presented an overview of the Asian Pacific Islander Cultural Center (APICC), which is celebrating its 30th anniversary. They explained that APICC is one of the City's virtual cultural centers, created to serve communities that do not have a dedicated cultural center building. APICC supports artists through its annual United States of Asian America Festival, fiscal sponsorship services, professional development workshops, accessibility resources, and community-based arts programming throughout San Francisco.

The presenters highlighted the impact of APICC's programs, which support hundreds of artists and thousands of attendees each year. They discussed the challenges of operating without a permanent facility, the importance of advocacy for arts funding, and APICC's efforts to bring arts programming directly into neighborhoods through partnerships with community organizations. Commissioners thanked APICC for its leadership, community service, and continued support of artists and cultural programming across the city.

9. Shaping Legacy Program Updates

(2:05:28)

Senior Program Manager Angela Carrier provided an update on the Shaping Legacy initiative, a project funded by the Mellon Foundation that examines San Francisco's monuments and memorials and explores new ways to tell community stories through public art. Carrier worked with community organizations, historians, and artists to lead public discussions and create artistic projects related to monuments honoring figures. These projects included performances, murals, films, sculptures, workshops, and community events that reflected a wider range of perspectives and histories.

Carrier also shared updates on five temporary public art commissions that will be installed throughout the city in 2026. The projects will honor immigrant communities, workers, refugees, migration stories, and local history through sculptures, textile installations, community art activities, and large-scale public artworks. Upcoming public programs will provide additional opportunities for the public to learn about and engage with the Shaping Legacy initiative.

There was no public comment.

10. Artist Certification Update

(2:16:30)

Deputy Director of Programs Eban Glenn, Capital Project Manager George Lee, and Director of Community Investments Denise Pate provided an update on the Arts Commission's new Artist Certification Program. The program was created to certify artists for affordable housing opportunities and will be used for the upcoming 1687 Market Street artist housing project, which will provide more than 90 affordable housing units. Artists may qualify through income

earned from their artistic practice, receipt of an arts grant or award, or submission of artistic work samples.

Staff explained that artists will apply through an online process, and trained reviewers will evaluate applications using a standard rubric. Certified artists will receive a certification number that can be used to claim artist preference in the City's housing lottery process. Staff emphasized that artist certification does not guarantee housing but provides priority consideration for artist-designated affordable housing opportunities.

Public Comment(s)

Randall Klein, Artists Hub on Market

Klein provided additional information about the Artist Hub on Market affordable housing project at 1687 Market Street. Klein explained that the project is intended to create affordable housing opportunities for artists and that the Artist Certification Program will help identify artists eligible for priority consideration in the housing lottery. Klein noted that the project is supported through private philanthropy and is intended to serve as a model for future artist housing developments in San Francisco.

Meg Shiffler, Artist Space Trust

Shiffler spoke about Artist Space Trust's work to create affordable homeownership and housing opportunities for artists. Shiffler explained that the Artist Certification Program could be useful beyond the 1687 Market Street project by helping artists verify their eligibility for other artist housing initiatives. Shiffler emphasized that multiple housing models are needed to address artists' housing needs and expressed support for the certification program as a tool to expand access to artist housing.

**11. Update on Charter reform proposals pertaining to the Arts Commission
(2:44:18)**

Deputy Director of Finance and Administration Sarah Hollenbeck provided an update on two separate charter reform efforts that could affect the Arts Commission. She reported that the Board of Supervisors' proposed charter amendment, which grew out of the Commission Streamlining Task Force process, does not make any changes to the charter section that establishes the Arts Commission or outlines its powers and duties. The proposal does, however, include changes related to the Street Artists and Crafts Examiners Advisory Committee.

Staff also discussed a separate charter reform proposal supported by the Mayor and Board President that would give the Mayor greater authority to reorganize City departments and appoint or remove department heads. Hollenbeck noted that both measures are still moving through their respective approval processes and that additional updates will be provided as they develop.

5. Persons unable to attend an Arts Commission meeting may submit correspondence to the Arts Commission in connection with an agenda item. The Commission Secretary will post these documents adjacent

to the agenda if they are one page in length. If they are longer than one page, the Arts Commission will make such documents available for public inspection and copying. Please note, correspondence submitted to the Arts Commission will NOT be read aloud during the meeting. Names and addresses included in these submittals will be public.
