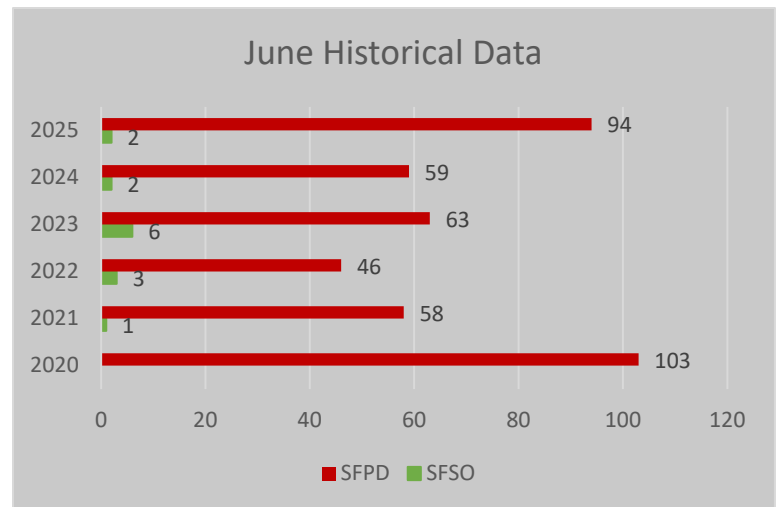

Summary of Complaints Received in June 2025

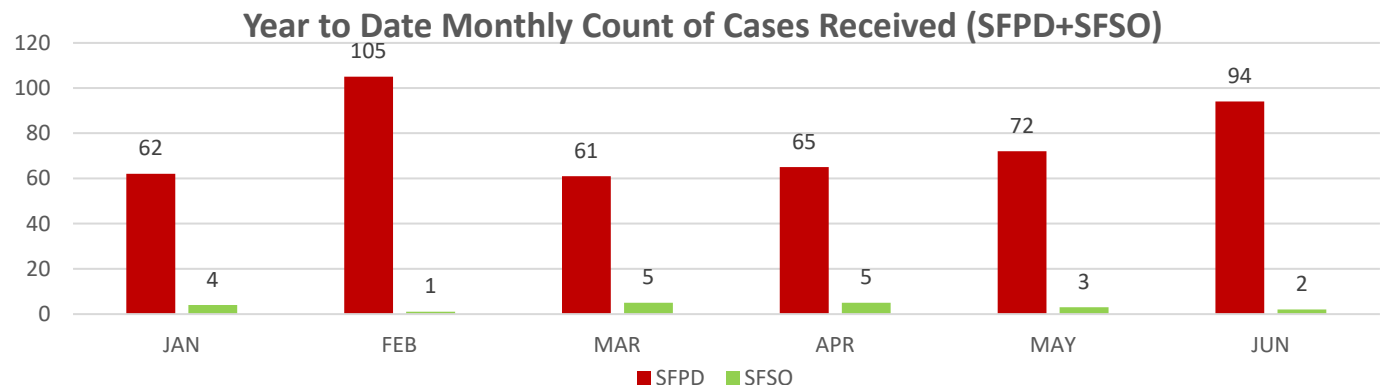
The Department of Police Accountability received a total of **96** cases in **June 2025**, **94** SFPD complaints and **2** SFSO complaints. Compared with a total of **61** cases, **59** SFPD complaints and **2** SFSO complaint, in the same period last year, the **June 2025** case total is **41%** higher than the five-year average and is **57%** higher than the previous year.

From January through June, the DPA received a total of **479** new cases, **459** SFPD complaints and **20** SFSO complaints. Compared with the **387** cases filed during the same period in 2024, **368** SFPD complaints and **19** SFSO complaint. The June year to date case total represents an **24%** increase in new complaints over last year.



Currently, DPA has a total of **264** pending cases, **225** SFPD and **39** SFSO.

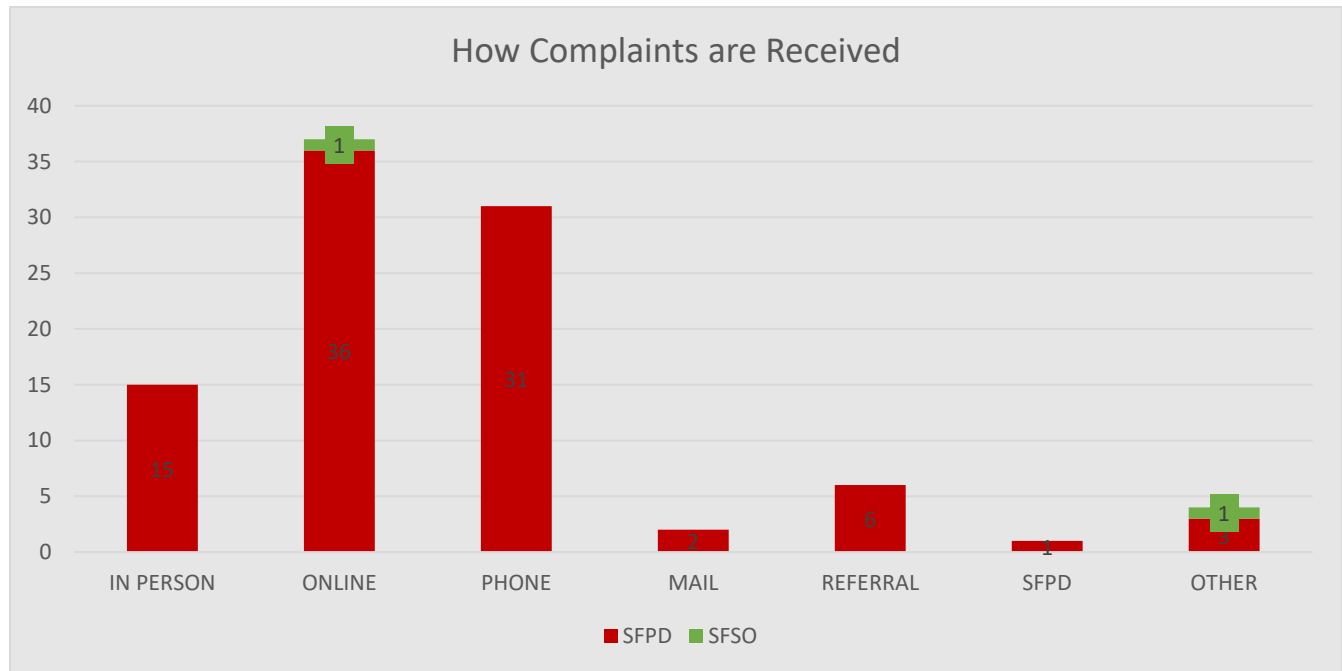
In June, DPA received a total of **0** referral(s) from SF Sheriff's Office and referred a total of **4** case(s) to SFSO.
