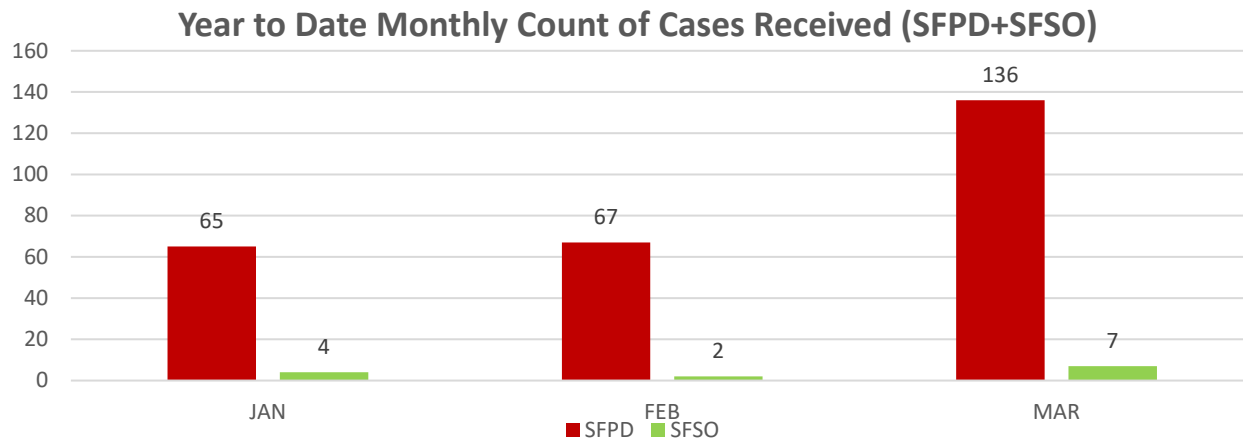
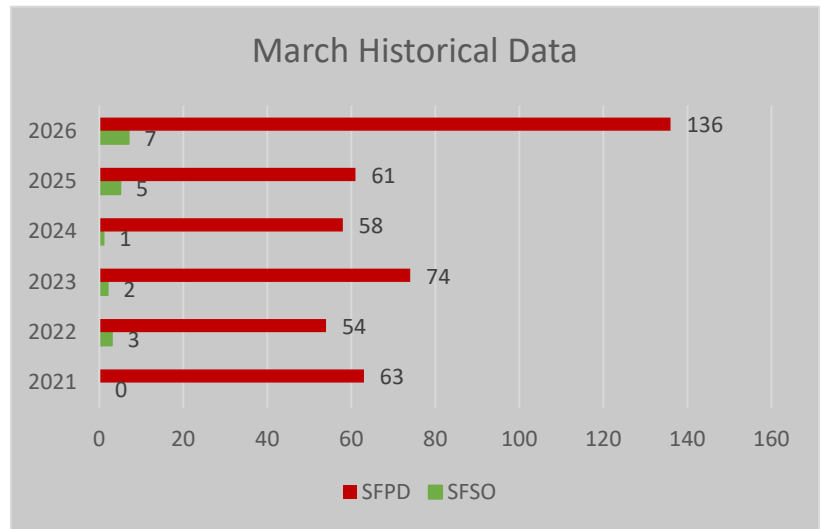
Dear President C. Don Clay and San Francisco Police Commissioners:

Summary of Complaints Received in March 2026

The Department of Police Accountability (DPA) received **143 cases in March 2026—136 SFPD and 7 SFSO**. This represents a 117% **increase** over March 2025 (66 cases) and is **123% higher than the five-year March average (64.2 cases)**. As of March 31, DPA's **pending caseload is 239 cases** (196 SFPD; 43 SFSO). DPA did not receive case referrals from the SF Sheriff's Office in March and referred 10 cases to SFSO.

Currently, DPA has a total of **239** pending cases, **196 SFPD** and **43 SFSO**.

In March, DPA received no referral(s) from SF Sheriff's Office and referred a total of **10** case(s) to SFSO.

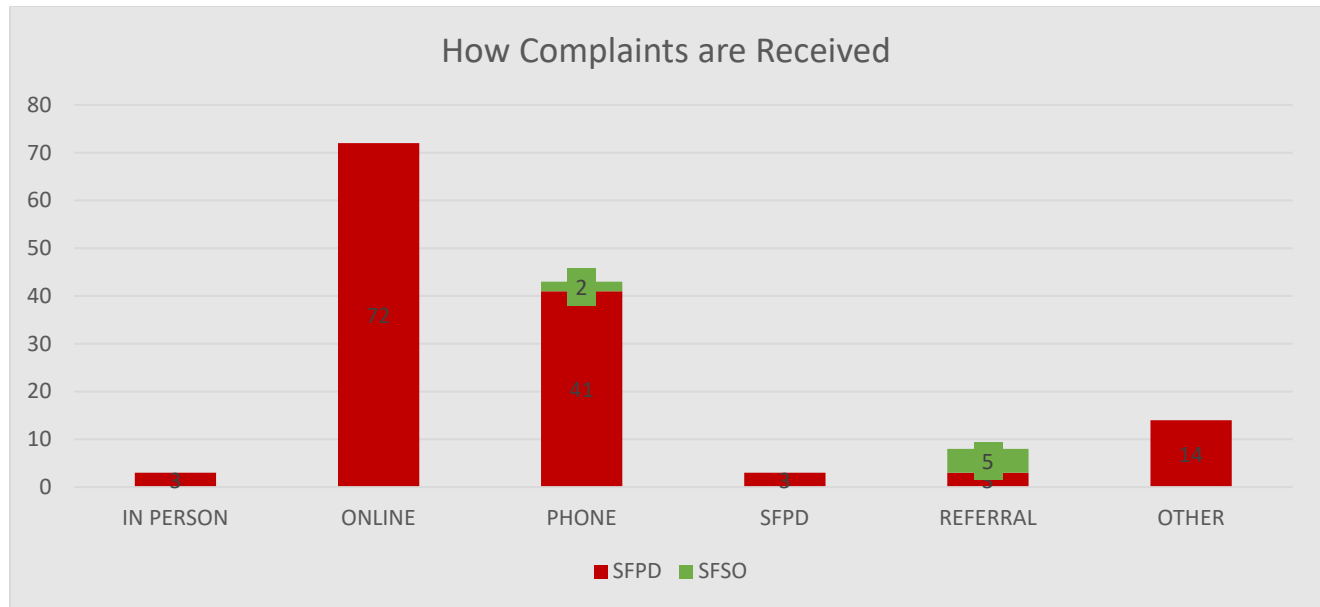


Note: In March, the DPA received more than 40 complaints regarding ICE agents' activity at SFO.
