President Collins announced the public meeting instructions

Commission Secretary Dhaliwal announced the public meeting instructions.

Commissioner Ferras began the meeting by reading the Arts Commission's land acknowledgement statement.

2. Approval of Minutes

(6:00)

Commissioner Beltran, seconded by Commissioner Walker moved to approve April 6, 2026, minutes.

There was no additional public comment.

3. General Public Comment **(7:16)**

Public Comment(s)

Jen Atwood, San Francisco Arts Commission

Raised concerns about reduced arts funding despite increased revenue, as well as staff cuts, new reimbursement policies, and lack of visible leadership. She questioned how these decisions would impact artists and staff, and urged the Commission to examine internal leadership effectiveness.

Jackie von Treskow, San Francisco Arts Commission

Spoke about low staff morale, layoffs, and the strain caused by a leadership vacuum during a time of merger and charter reform. She emphasized that staff are carrying the agency's work under difficult conditions and asked Commissioners to advocate for them and ensure decisions are made transparently and with full understanding of impacts.

Vinay Patel, Executive Director, Asian Pacific Islander Cultural Center

Expressed appreciation for Arts Commission staff and highlighted community support for their work. He opposed charter reform that could weaken the Commission and raised concerns about policies that could force artists into financial hardship, urging more collaboration and thoughtful policy development.

Masako Takahashi

Urged the Commission to review Public Works' plans for Osaka Way, stating that Ruth Asawa's original design may not be properly restored. They expressed concern that the Arts Commission's oversight role is being bypassed and emphasized the importance of protecting the city's public art legacy.

There was no additional public comment.

4. Committee Reports and Committee Matters (19:35)

4.1 Visual Arts Committee Report (19:41)

Commissioner Farris presented the report from the April 15, 2026 meeting. The Committee reviewed public art projects, including the Harvey Milk Plaza Improvement Project, which will incorporate a new artwork celebrating inclusivity and social justice. Staff also provided an update on the Vaillancourt Fountain, noting that legal challenges to its removal were denied, allowing disassembly to proceed due to safety concerns. Initial work revealed more extensive structural deterioration than anticipated, and additional security measures have been implemented at the site.

There was no public comment.

4.2 Community Investment Committee Report (25:03)

Commissioner Walker presented the report on behalf of the Community Investments Committee, summarizing the FY26 grant cycle. Staff provided an overview of applicant and grantee data, expanded outreach efforts, and funding recommendations. The Committee reviewed and recommended approval of Arts Impact Endowment Fund grants and Artistic Legacy Grants totaling approximately \$7.3 million, noting that demand far exceeded available funding. Updates were also provided on grant guidelines, eligibility changes, and upcoming revisions for future cycles.

The Committee discussed key policy issues, including the impact of reimbursement-based payment structures on artists—particularly individuals with limited financial capacity—and the need to distinguish between individual and organizational grantees. Commissioners expressed concern about declining application numbers, potential barriers created by eligibility rules, and broader economic pressures affecting artists in San Francisco.

Staff also presented on the Cultural Centers Program, including legal obligations, facility management, and partnerships. The Committee reviewed and approved novation agreements supporting the Mission Cultural Center for Latino Arts and discussed ongoing efforts to refine policies, improve equity, and better support the arts community amid changing conditions.

Vinay Patel (Executive Director, Asian Pacific Islander Cultural Center)

Emphasized the importance of maintaining advance payments for individual artists, noting that current grant structures have been effective for many years. Patel cautioned that changes to reimbursement policies could create unintended financial burdens and urged the Commission to rely on arts professionals and community expertise when developing policy changes.

There was no additional public comment.

**5. Cultural Center Presentation – Ruth Williams (Bayview) Opera House
(45:00)**

Director Theo Ellington presented an overview of the Bayview Opera House, highlighting its historic significance and recent transformation under new leadership. The organization has expanded its programming to include live

performances, community events, and partnerships while maintaining a strong focus on serving the Bayview neighborhood. During the pandemic, the center adapted to meet community needs and has since re-centered its mission on providing accessible, high-quality arts and cultural programming.

A key focus of the presentation was workforce development through the “Tools of the Trade” program, which provides training in technical production skills and creates pathways to employment in the arts sector. The Opera House has also adopted a social enterprise model, generating revenue through event production services and partnerships across the city. These efforts aim to diversify funding sources while supporting artists and creating job opportunities.

The presentation also emphasized the center’s role in fostering cultural connection and innovation through diverse programming, including performances, festivals, and new media initiatives. Commissioners commended the organization for its community impact, successful partnerships, and efforts to combine arts programming with economic opportunity and workforce development.

There was no public comment.

6. Consent Calendar

Commissioner Beltran disclosed a personal, non-financial relationship with grant recipient Taraneh Hemami, noting they are longtime colleagues and have worked together professionally, but has no financial interest. Beltran also disclosed being a paying member of the San Francisco Writers Grotto, which is receiving funding, and confirmed she has no financial benefit from the grant. Additionally, she commented on the importance of community

involvement in public art selection processes.

Commissioner Walker, seconded by Commissioner Beltran moved to approve all consent calendar items.

Meeting Procedures

1. Agenda items will normally be heard in order. Please note, that on occasion a special circumstance may necessitate that an agenda item be taken out of order. To ensure that an agenda item is not missed, it is advised to arrive at the beginning of the meeting. All agenda changes will be announced by the Chair at the top of the meeting.

2. Public comment will be taken before or during the Committee's consideration of each agenda item. Each speaker will be allowed to speak for the time allotted by the Chair at the top of the meeting or up to three (3) minutes.

3. During General Public Comment, members of the public may address the Commissioners on matters that are within the Arts Commission's jurisdiction and are not on the agenda.

4. Persons who spoke during the public comment period at a meeting of the Arts Commission may supply a brief written summary of the comments to be included in the minutes if it is 150 words or less. The Arts Commission may reject the summary if it exceeds the prescribed word limit or is not an accurate summary of the speaker's public comment.

5. Persons unable to attend an Arts Commission meeting may submit correspondence to the Arts Commission in connection with an agenda item. The Commission Secretary will post these documents adjacent to the agenda if they are one page in length. If they are longer than one page, the Arts Commission will make such documents available for public inspection and copying. Please note, correspondence submitted to the Arts Commission will NOT be read aloud during the meeting. Names and addresses included in these submittals will be public. Submittals may be

made anonymously. Written comments pertaining to this meeting should be submitted to art-info@sfgov.org.

Public Comment

Public comment in regard to specific agenda items will be taken before or during consideration of the item. Each speaker may speak for up to three minutes per agenda item, unless the Chair has announced a different length of time at the beginning of the meeting. Speakers may not transfer their time to another person. Any person speaking during a public comment period may supply a written summary of their comments to be included in the minutes if it is 150 words or less.

NOTE: The San Francisco Arts Commission is discontinuing remote public comment for all public meetings starting in December 2023. Public comment will be taken in-person, with remote access provided for those who require an ADA accommodation. Requests for accommodation must be made at least 48 hours in advance of the meeting, pursuant to Administrative Code Section 97.7. Late requests will be honored if possible.
