For an argument submitted on behalf of an organization, the "Individual" section must also be completed by a principal officer of the organization who must be a registered San Francisco voter.

If an argument states that an individual or organization other than the author supports or opposes the ballot measure, or agrees with or endorses the argument, a completed and signed Consent Form is required.

	Mayor Daniel Lurie knows that the current Board of Supervisors refuses to enact his core priorities—to cut the deficit, trim bureaucracy, centralize contracting and hold department heads accountable. However Lurie, instead of challenging head-on the far-left socialists and obstructionist ideologues of his own party to get pragmatist Supervisors elected, treats the system of checks and balances itself as the enemy. He raised millions for paid signature gatherers to rewrite the City Charter and concentrate power in his hands. This is the authoritarian temptation. Fearing radicals inside their own coalition, leaders turn against institutional constraints that limit their personal power. SPUR stated the impulse with chilling clarity: a mayor should- "resolve issues through leadership rather than at the ballot"—translation: by mayoral decree. Democratic procedure just gets in the way. That same impulse drives presidents who prefer executive orders to the harder work of defeating "in name only" members of their own party who block their agenda. One measure expands City Administrator authority, raising the dollar threshold for Supervisor approval of major contracts. Another revives deputy mayors—a patronage system exposed by Quentin Kopp and abolished by voters in 1991—while amplifying the mayor's power to hire, fire and reorganize. The third quadruples the signature requirement for citizen initiatives, after Lurie himself used the low bar he now seeks to close, locking the door behind him. Most of what Lurie claims these changes would deliver could be achieved through legislation and regular order if he led his own party toward fiscal discipline, drove the most ideological members off the Board and fought the increasing far-left extremism infecting Democrat leadership. Instead, he flirts with the same breed of authoritarianism. Don't be a piker. Vote No on D, E, and F. Larry S. Marso, Esq.

1. The list of Supporters / Opponents shall not exceed 125 characters in length. The Department will not publish beyond the 125th character.
2. An associate, nonprofit organization, business, or individual shall not be listed unless they have also completed a Control Sheet for the corresponding Ballot Argument.
3. A Supporter / Opponent shall not be listed if the Supporter / Opponent is a political party or is representing a political party.
4. If this form is not submitted, the Department will print "None submitted" for the corresponding Official Ballot Argument.
