

Summary of Complaints Received in November 2025


The Department of Police Accountability received a total of 65 cases in November 2025, 65 SFPD complaints and 0 SFSO complaints. Compared with a total of 49 cases, 43 SFPD complaints, and 6 SFSO complaints in the same period last year, the November 2025 case total is 27% higher than the five-year average and is 33% higher than the previous year.

From January through November, the DPA received a total of **875** new cases, **843** SFPD complaints and **32** SFSO complaints. Compared with the **718** cases filed during the same period in 2024, **672** SFPD complaints and **46** SFSO complaints. The October year-to-date case total represents a **22%** increase in new complaints over last year.



Currently, DPA has a total of 243 pending cases, 200 SFPD and 43 SFSO.

In November, DPA <u>received</u> a total of **0** referrals from the SF Sheriff's Office and referred a total of **1** cases to SFSO.




