Radhika Mehlotra, Homelessness Policy Specialist at the SF Controller's Office (CON), provided an [OCOH FY24-25 Actual Revenue Update](#). She noted that the information was prepared by the Budget and Analysis Division (BAD) at CON.

2025 Homelessness Needs Assessment

Homelessness Policy Specialist Mehlotra engaged the Committee in a discussion about the draft of the 2025 Homelessness Needs Assessment and recommendation letter.

Data Officer Walton urged the Committee to review and carefully consider certain portions of the assessment/report. He highlighted specific trends and results within the assessment and thanked the departments for their work in compiling the information.

Member Friedenbach asked questions about the current draft of the assessment/report. She provided some suggestions on how certain areas of the report could be improved for clarity (from the public's perspective). Sarah Locher, Deputy Director of Planning, Performance, and Strategy at the SF Department of Homelessness and Supportive Housing (HSH), provided some context on how HSH's portion of the data is represented within the report. Kelly Kirkpatrick, Director of Administration and Operations, Mental Health SF at the SF Department of Public Health (DPH), addressed Member Friedenbach's concerns about the behavioral health-related data that is represented within the report.

There was discussion between Homelessness Policy Specialist Mehlotra and the Committee about the recommendation letter that will accompany the 2025 Needs Assessment. The Committee made various suggestions on what information should be included in the updated letter.

Vice Chair D'Antonio opened public comment. There were no in-person or over-the-phone public comments on this agenda item.
