

Following approval of the item by ISCOTT, the CEQA determination is subject to appeal within the time frame specified in S.F. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
