**Chief's Report**

- **Weekly crime trends**
- **Major/Significant Incidents**

Acting Chief Yep, reported on crime trends YTD: Violent Crime down 18 percent; homicide down 25 percent; rape down 15 percent; robbery down 24 percent; assault down 14 percent; human trafficking up 100 percent. Property Crimes down 28 percent; burglary down 29 percent; motor vehicle theft down 45 percent; arson down 21 percent; larceny theft down 23 percent. Gun violence is down 24% compared to 2024; One non-fatal shooting incident this week; total 74 fire-arm related incidents resulting in 93 victims YTD. No homicides for the week; total of 18 homicides YTD with 14 resulting from a firearm; 139% overall clearance.

**Updates:** Department Notice regarding law enforcement and face masks (DN 25-092) post to website, staff still reviewing Senate Bill 805 legislation. Human Trafficking staffing, 5 full members, one Acting Lieutenant, three Sergeants and one Officer, previously only one member assigned to unit.

**Significant Incident:** Read News Release for 9/26/25 homicide at Larkin and Grove Streets, in front of Main Library, shooting, gunshot wounds, victim transported, suspected located and detained by SFPD and SF Sheriff, suspect booked, on 9/30/25 victim succumbed to injuries. 9/25/25, solo fatal traffic

collision, 01:58, vehicle traveling westbound on 2100 block of Mariposa, toward Harrison St in the Mission, vehicle crashed into lobby of building, medics arrived, victim pronounce deceased at scene.

**Significant arrest:** 9/27/25 09:50, Myrtle Alley between Larkin and Polk Streets, physical altercation between victim and suspect, victim sustained stab wounds, transported in stable condition, short time later call received about person bleeding in area of Ellis and South Van Ness, reviewing footage from RTIC, determined this was suspect from earlier stabbing, place under arrest.

**Strategies:** On 9/21/25 coordinated effort focusing on illegal dirt bike activities was conducted by city wide plain clothes team, RTIC, drones and stunt driving response unit, during operation vehicles seized and arrests made. October is Domestic Violence Awareness month, numerous events. Hardly Strictly Bluegrass Oct 5-7 at Golden Gate Park, Castro Street Fair Oct 5<sup>th</sup>, Fleet Week to start Oct 5 through October 13.

Executive Director Henderson reported the following: In the year 2025: 710 cases opened; 718 closed; 83 pending; 29 cases sustained; 12 cases past 270-day; 9 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting DPA Report)**: 37. Central, 3. Southern, 6. Bayview, 2. Mission, 1. Northern, 1. Park, 0. Richmond, 2. Ingleside, 0. Taraval, 4. Tenderloin, 1. Airport, 1. Not Applicable, 7. Out of Jurisdiction, 1. Pending, 8. Allegation Summary: Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-23%. Neglect of Duty-The officer failed to take required action-21%. Unwarranted Action-The officer engaged in unwarranted action-12%. Neglect of Duty-The officer failed to properly investigate-12%.

**Outstanding Issues:** Report Reenvisioning Project Update -DPA has completed an inventory of all its reports and the data points contained within them. This effort is the first step in identifying opportunities to provide more timely, accurate, accessible, relevant, and useful information to the Commission, the SFPD, community stakeholders, and the public. - DPA is developing a survey to gather commissioners' input on reporting priorities, including key data points and preferred formats. Members of the working group plan to reach out to commissioners before the end of the year for feedback

**Outreach:** Automated Notifications to Complainants - The DPA has developed automated notifications to keep complainants informed about the investigation process and to introduce mediation as an alternative resolution option. - The case confirmation notification informs complainants that their complaint has been received. It outlines what to expect at each stage of the investigation, and provides links to frequently asked questions, the case look-up portal to track the

status of cases using an issued PIN, and available resources. - The mediation notification offers an overview of the program, including eligibility requirements, benefits, and a step-by-step explanation of the process. It also includes a link to an informational video.


