Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Moment of Silence in remembrance of Officer Jason Gallagher, services were held today.

Acting Chief Yep, reported on crime trends YTD: Violent Crime down 18 percent; homicide down 21 percent; rape down 14 percent; robbery down 24 percent; assault down 13 percent; human trafficking up 100 percent. Property Crimes down 28 percent; burglary down 28 percent; motor vehicle theft down 45 percent; arson down 23 percent; larceny theft down 23 percent. Gun violence is down 20% compared to 2024; Five non-fatal shooting incidents this week; total 79 fire-arm related incidents resulting in 98 victims YTD. One homicide for the week; there is a total of 19 homicides YTD with 15 resulting from a firearm; 139% overall clearance.

Updates: Addressed Paulette Brown, Chief spoke to Media Unit, mainly spoke about social media post, remembered SFPD did talk with Ms. Brown about developing a Flyer for legislation passed.

Significant Incident: Five shooting incidents resulting in injuries to 5 victims. Shooting 9/30 10:19, 16th and San Bruno, Mission, no arrest. Shooting 9/30/25, 20:35, 1900 block of Mission, no arrest. Shooting 9/30 22:17, unknown location, victim came into San Francisco for treatment for a gunshot wound, unclear where shooting occurred. Shooting 10/1 23:33, unit block of Maxwell, no arrest. Shooting, 10/4 21:10, 1000 block of Mission, Southern, no arrests. Fatal hit and run on 10/4, 02:11, Cortland and Anderson, community meeting held with Supervisor and District Station Captain, Commander McCray, investigator and TCIU. Hit and run with serious injuries, 10/3 21:15, Haight and Lyon, Park District, no arrests made. Arson mental health crisis, 10/5, Officers from Tenderloin responded to 300 block of Turk Street to assist with resident in an apartment who had started a fire, subject blocked door to prevent emergency responders from entering, once fire personnel were inside subject began to violently fight with them, SFPD personnel entered room without respirators due to physical violent altercation, Officers able to handcuff suspect who continued to fight with them, subject transported for burns, multiple Officers treated on scene for smoke inhalation, two Officers transported.

Significant arrest: One reported homicide, last week's report, 9/26 16:41, shooting, 100 block of Larkin, Main Library suspect arrested. Arrest of suspect in attempted murder case, incident occurred 9/21 01:15, shooting occurred in the area of 24th and York Streets, victim sustained life threatening injuries during a altercation, suspect shooting multiple rounds at victim, investigation identified suspect, on 10/3 suspect arrested at residence in Oakland, booked on multiple charges. Recovery of stolen property from 5/18, Richmond Station and investigations unit made arrest involving drugs and stolen vehicles. Arrest resulting from a Narcotics Unit investigation, 10/1, 180 grams of Fentanyl, 57 grams of meth, 16 grams of cocaine seized as well as \$25,000, fentanyl press and scales, ghost gun.

Stabbing attempted homicide, 10/5, on a Muni LRV, 4th and Channel, Southern, arrest made. 10/2, Critical Incident domestic violence, 21:19, 200 block of Eddy.

Strategies: Park District, led by Captain Angela Wilhelm, operational effort, saw surge in garage burglaries, loss was typically bicycles, e-bikes and scooters, under guidance of Lt. Adrian Payne and Sergeant Josh Nazzal, Park Station ran a bait bike operation, 10/2, result of operation made 4 felony arrests in 3 locations in Park District, one operation – e-scooter placed on Fulton and Masonic with surveillance Officers nearby, a van pulled up next to the scooter, subject exited passenger side and attempted to place scooter in van, as vehicle attempted to leave, multiple marked units arrived, took two occupants into custody. Large scale events, 25th Annual Hardly Strictly Bluegrass, Fleet Week, Italian Heritage Festival, Dreamforce Event.

Paullette Brown: Spoke about son, Aubrey Abrakasa, Jr., other families suffering in silence like her. Discussed facial recognition discussed in a healing circle with others. Provided information from her son's case and visuals of victims from unsolved cases. Asking for flyer to be made for legislation.

Director Henderson reported the following: In the year 2025: 719 cases opened; 727 closed; 83 pending; 29 cases sustained; 12 cases past 270-day; 9 cases mediated. Allegation Summary: Conduct Unbecoming an Officer-The officer drove a City vehicle in a reckless manner-16%. Neglect of Duty-The officer failed to take-required action-16%. Unwarranted Action-The officer prepared an inaccurate incident report-8%. Neglect of Duty-The officer failed to properly investigate-8%. Unwarranted Action-The officer made an arrest without cause-8%.

Audits: The Use of Force draft report has been sent to the Controller's Officer and is undergoing independent review.

Outstanding Issues: Report Reenvisioning Project Update: DPA is finishing up Commissioner input survey and hope to have it out ahead of schedule in early November.

Outreach: DPA is currently onboarding four interns for our Fall term. They will be joining us from S.F. State, U.C. Berkeley and Stanford.


