
**Re: San Francisco Department of Police Accountability October 2025 Monthly Statistical Report**

Dear President C. Don Clay and San Francisco Police Commissioners:

**Summary of Complaints Received in October 2025**


The Department of Police Accountability received a total of **72** cases in **October 2025**, **69** SFPD complaints and **3** SFSO complaints. Compared with a total of **87** cases, **84** SFPD complaints, and **3** SFSO complaints in the same period last year, the **October 2025** case total is **6%** higher than the five-year average and is **17%** lower than the previous year.

From January through October, the DPA received a total of **809** new cases, **777** SFPD complaints and **32** SFSO complaints. Compared with the **666** cases filed during the same period in 2024, **629** SFPD complaints and **37** SFSO complaints. The year-to-date case total for October represents a **21%** increase in new complaints over last year.



Currently, DPA has a total of **256** pending cases, **210** SFPD and **46** SFSO.


In October, DPA received a total of **0** referrals from the SF Sheriff's Office and referred a total of **0** cases to SFSO.
