# Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ♦ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ♦ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ♦ An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

# Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on the police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Southern Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Southern Station has beat officers assigned to the Mission Street corridor from 4th St to 9th St and on 6th St between Mission St and Howard St.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Southern Station sends out newsletter updates to residents in the district that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the district station.
- Twitter: Southern Station's Twitter sends out the updates on upcoming community events, notable arrests and crime alerts.



# Crime Definition

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery - (Misdemeanor battery)** is any willful and unlawful touching of another.  
**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

**Assault** is when a person swings their arm and **battery** is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

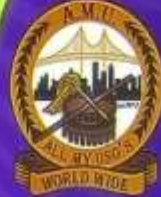

# Addressing Crime / Safety tips

With the Covid-19 restrictions lifting in phases and many of us are starting to venture out again, here are some Package Theft Prevention Guide from SFSafe to help prevent your packages from being stolen.



## PACKAGE THEFT PREVENTION GUIDE

### WON'T BE HOME?

Use the "Hold Package" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

### CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

### USE SPECIAL SERVICES

Use USPS special services like *Signature Confirmation* or *Registered Mail* to add a layer of security.

### DELIVER TO SECURE LOCATIONS

Send packages to secure locations such as Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

### REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

### USE MODERN ALTERNATIVES

Take advantage of contemporary options like smart lockers, lockboxes, cameras, motion detection lighting, alarms like Package Guard, and services like Doorman.

### NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

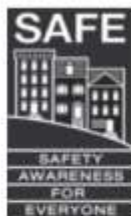
### PORCH AREA VISIBILITY

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.





# Addressing Crime / Safety tips



## PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.



### ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



### INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



### REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



### DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



### INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



### TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



### INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



### SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



### HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.



### INSTALL INTERIOR MAIL SLOT HOOD COVER

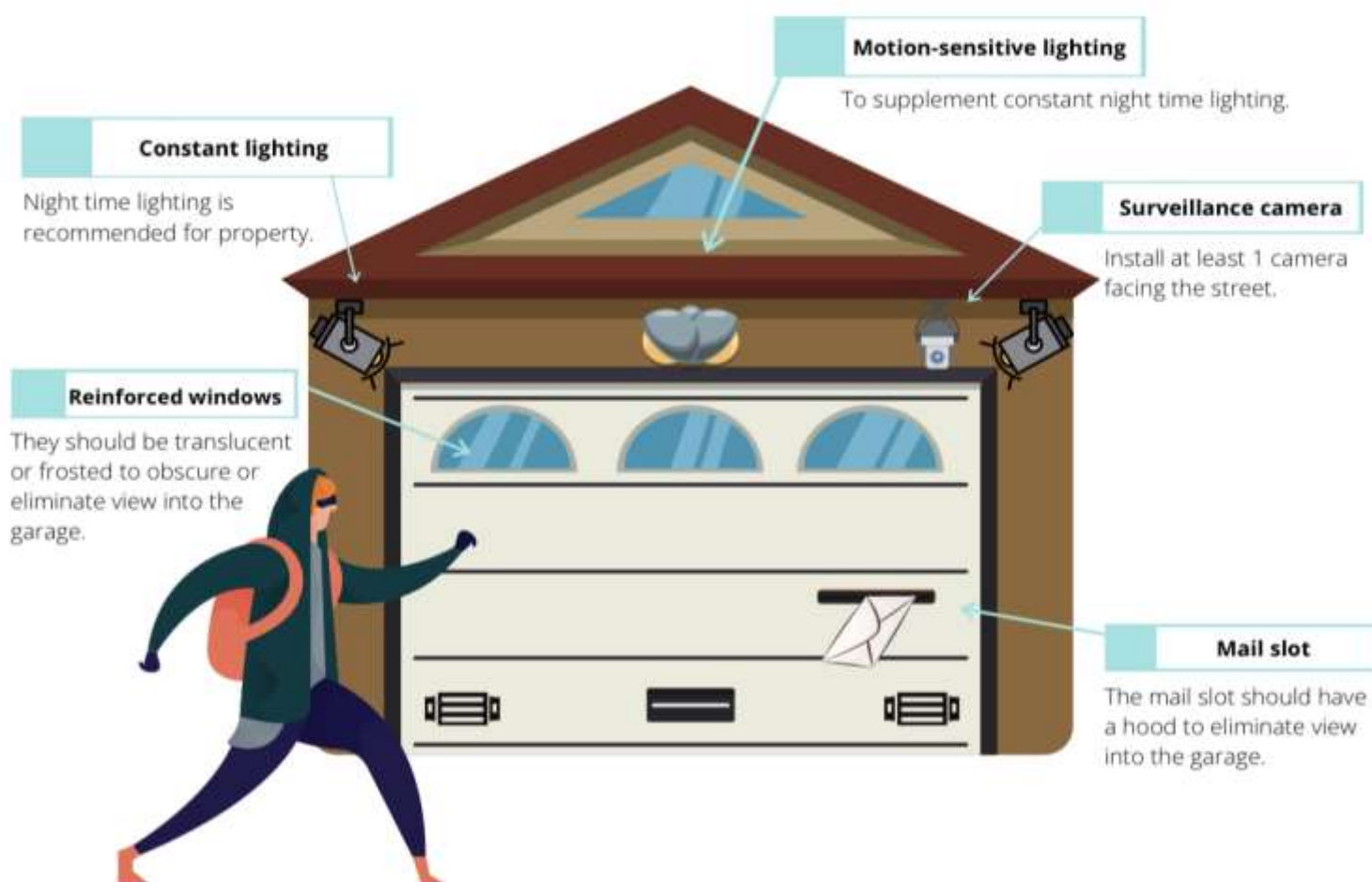
If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

## PREVENT THEFT FROM YOUR VEHICLE

Remember when parking your vehicle to ensure it is properly secured before walking away. Be sure that your windows are up, and your doors are locked. ### Turn off the ignition

# Addressing Crime / Safety Tips



## SHARING THE ROAD WITH CYCLISTS

When it comes to safely sharing the road with cyclists, it's paramount for drivers to learn how to coexist.

### ➡ Share the Road

When out and about, drivers need to be ever-mindful of sharing the road with cyclists.

### ➡ Stay Off the Horn

Sudden honking might startle a cyclist and can cause them to swerve into traffic or off the road.

### ➡ Follow the 3 Foot Rule

Maintain a distance of 36 inches from cyclists whenever passing them. If possible, keep an even wider berth if there's bad weather or if in a higher speed limit zone.

### ➡ Mind Your Blind Spots

Drivers should double-check their mirrors when changing lanes, making turns, and especially before opening their car door after parking.

### ➡ Be Cautious with Kids

Kids can be unpredictable since their motor skills and decision-making faculties aren't fully developed. Be on alert when driving near schools and residential areas.

### ➡ Be Patient

Don't tailgate a cyclist. When you need to pass one, patiently wait until it's safe to do so.

# Addressing Crime / Safety Tips



In an effort to improve vehicular and pedestrian safety Citywide, [TransBASEsf.org](http://TransBASEsf.org) has identified dangerous intersections in the Southern District. We have implemented the “**Focus on the Five**” traffic safety initiative. Southern Station Officers will be engaging in increased traffic enforcement at these intersections and other locations in the district. Refer to the [TransBASEsf.org](http://TransBASEsf.org) for more detailed information.

## Focus on the Five Dangerous Intersections

- Mission St @ 8th St
- 5th St @ Bryant St
- Howard St @ 6th St.
- 6<sup>th</sup> St @ Harrison
- 10<sup>th</sup> St @ Mission St

**22450(a) CVC:** The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection

**21453 (a) CVC:** A driver facing a steady circular red signal alone shall stop at a marked limit line, but if none, before entering the crosswalk on the near side of the intersection, and shall remain stopped until an indication to proceed is shown.

**22350 CVC:** No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

**21950(a) CVC:** The driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection, except as otherwise provided in this chapter.

**22107 CVC:** No person shall turn a vehicle from a direct course or move right or left upon a roadway until such movement can be made with reasonable safety and then only after the giving of an

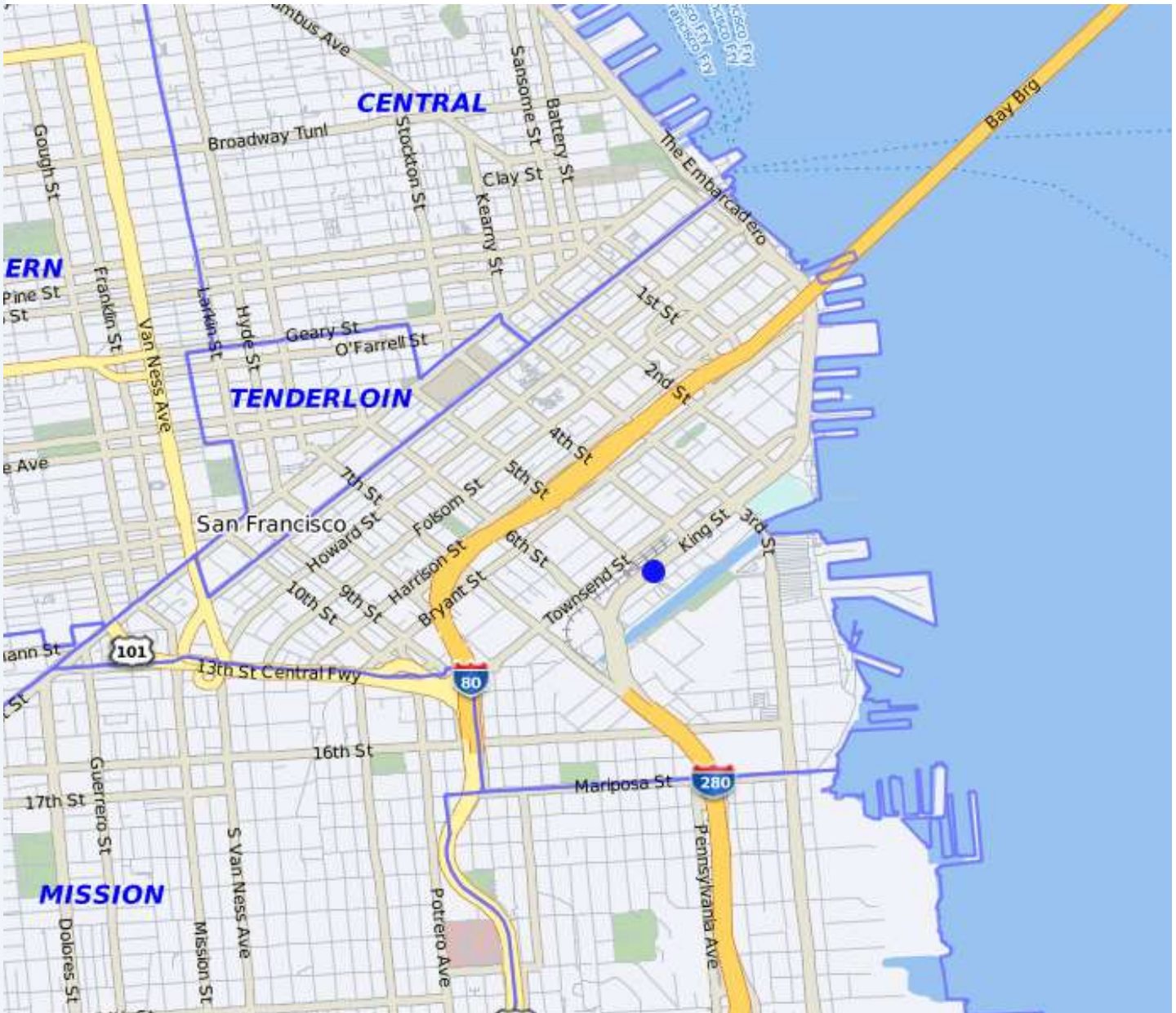

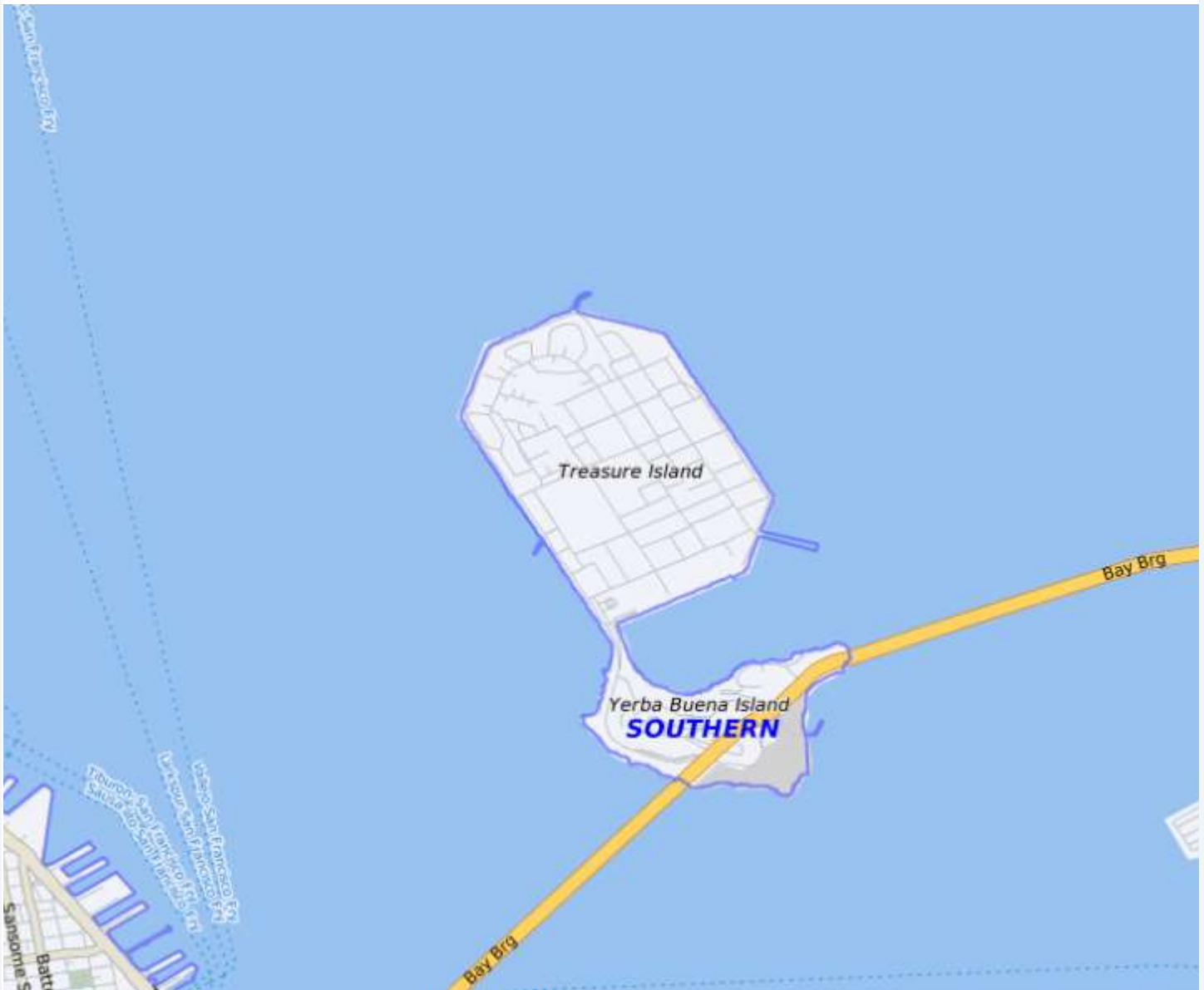
# Crime Data Map (Week)

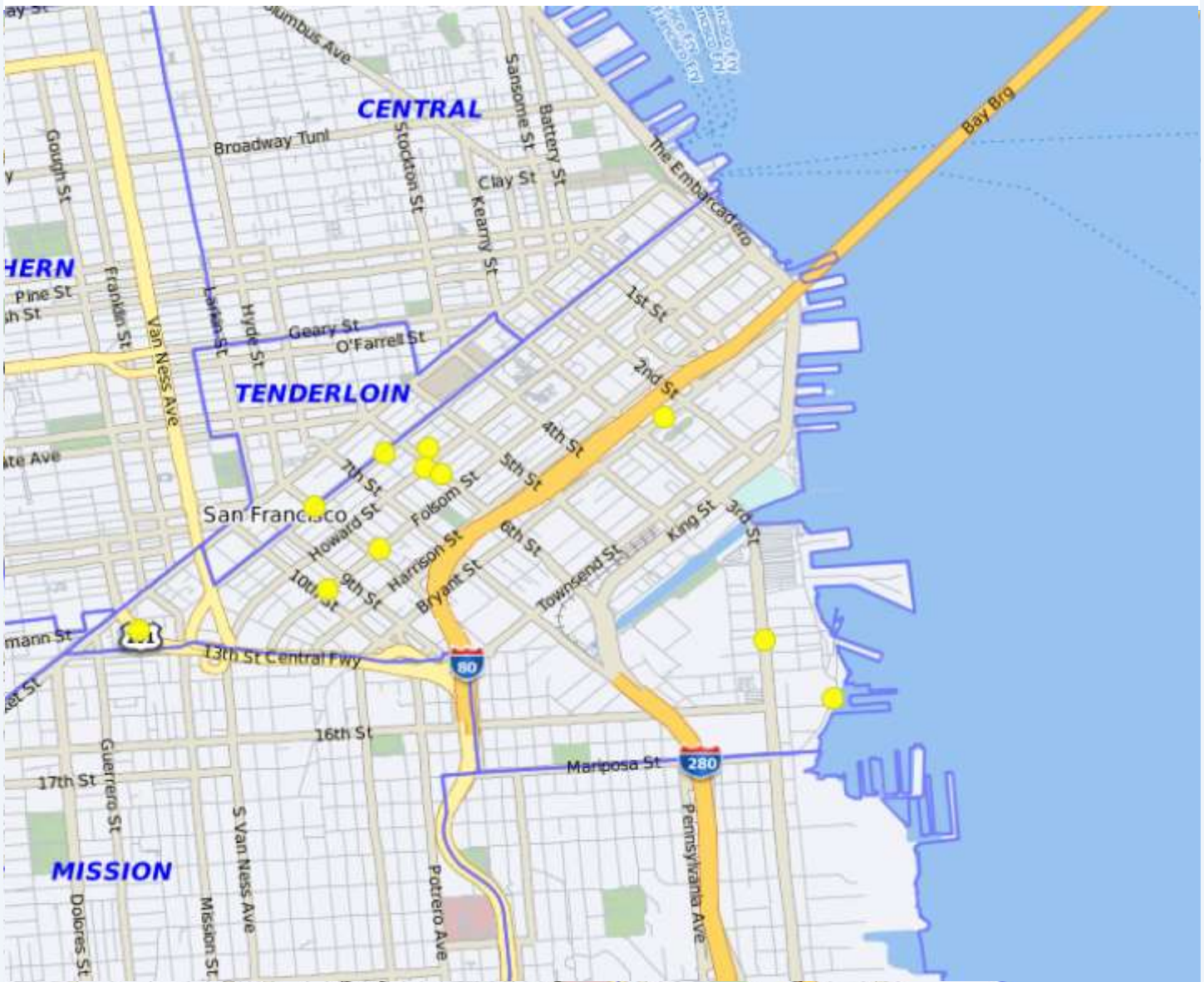

## ASSAULTS / SOUTH OF MARKET

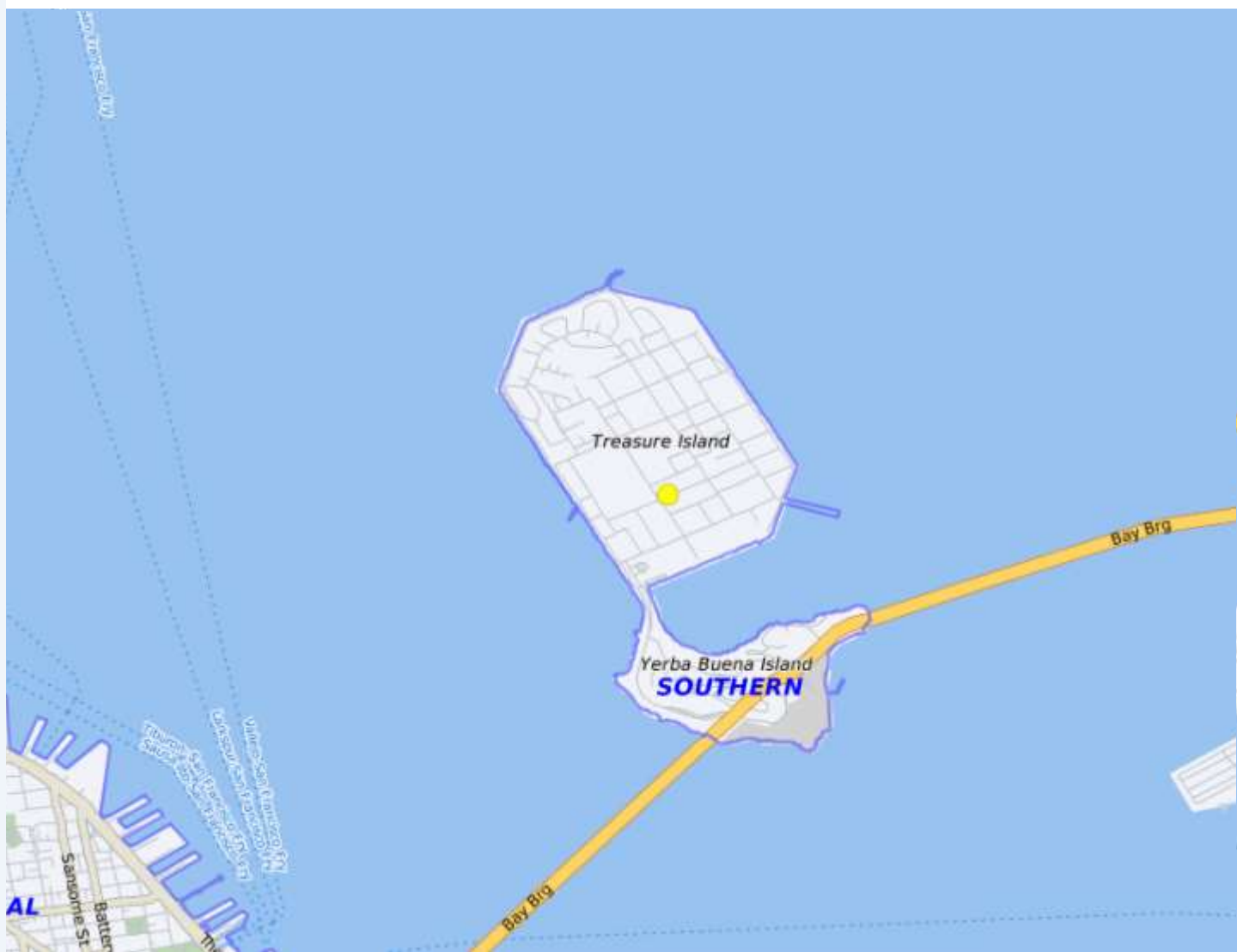

## ASSAULTS / TREASURE ISLAND & YBI

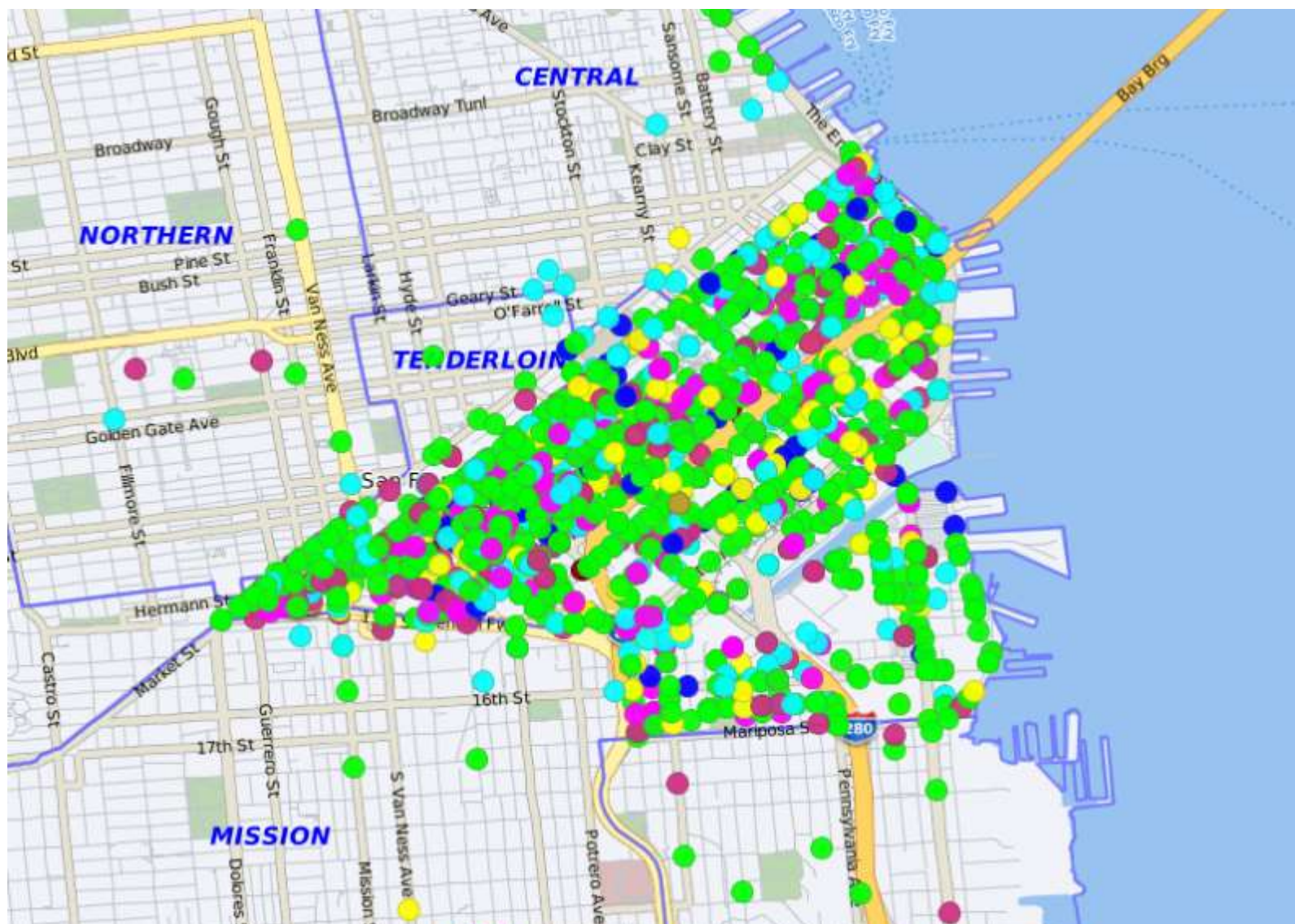

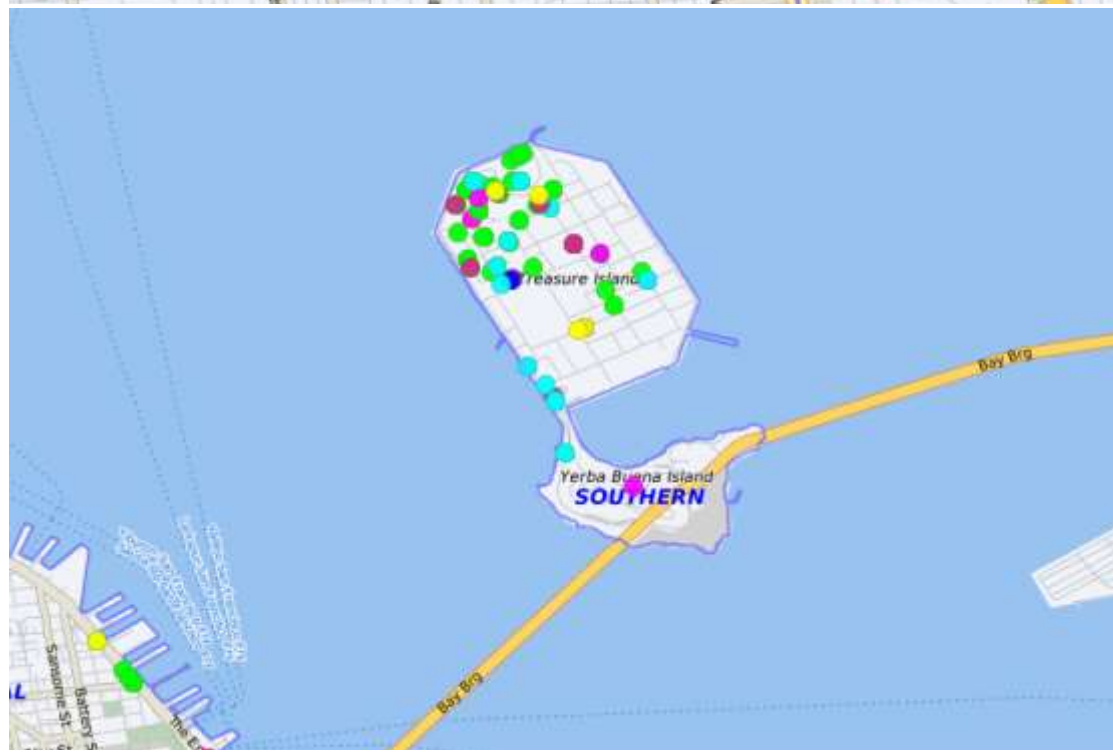
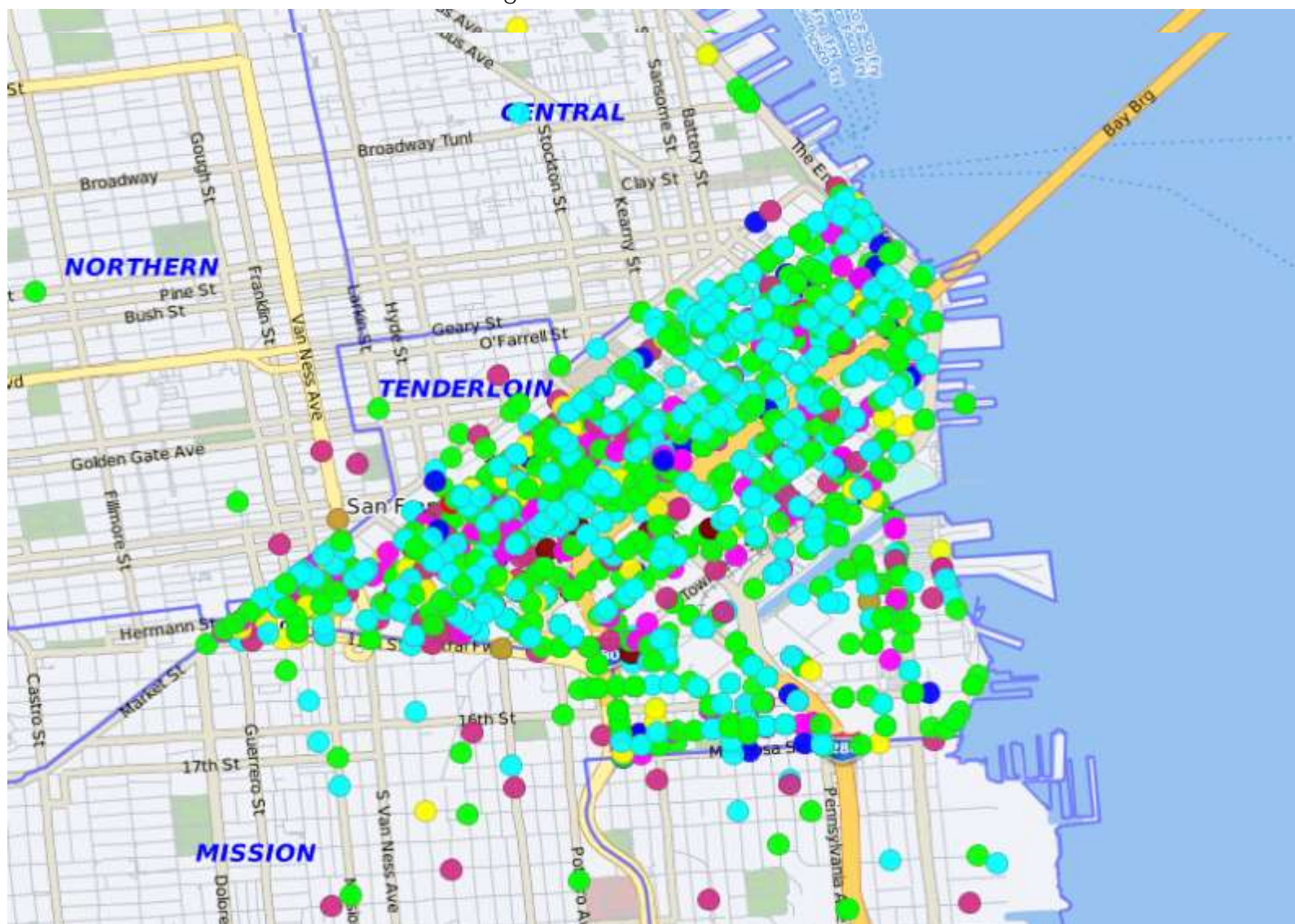

# Summaries of Supreme Courts Case Laws

(Released Every 3 Months-First Week January, April, July, October )

## **Kansas v. Glover (2020) 140 S.Ct. 1183.**

A Kansas deputy sheriff ran a license plate check on a truck and discovered that the registered owner had a revoked driver's license. The deputy assumed the registered owner was driving the vehicle and pulled it over. The registered owner, Glover, was in fact driving and charged with being a habitual offender. Thereafter, Glover moved to suppress the evidence, claiming that the deputy lacked reasonable suspicion to detain him.

The United States Supreme Court held that, "when the officer lacks information negating an inference that the owner is the driver of the vehicle, the stop is reasonable." The Court noted that the Fourth Amendment permits an officer to detain an individual when that officer has a "particularized and objective basis for suspecting the particular person stopped of criminal activity." Officers must be permitted to make commonsense judgments and inferences regarding human behavior. The Court found that prior to pulling the vehicle over, the deputy observed an individual operating the vehicle, he knew the registered owner had a revoked license, and the model of the vehicle matched what he observed. From these facts the deputy drew the commonsense inference that the driver was the registered owner and the Court found that provided more than reasonable suspicion to initiate the traffic stop.

## **People v. Henderson (2020) 9 Cal.5th 1013**

Henderson was convicted of first degree murder with special circumstances, the personal use of a deadly weapon, and sentenced to death which triggered an automatic appeal to the California Supreme Court. Following his arrest, and during a custodial interrogation, Henderson initially waived his Miranda rights. When asked if he was present at the scene of the crime, Henderson stated, "Uhm, there's some things that I, uhm, want uh ..." He was again asked if he was present and Henderson continued, "[want] uh, want to speak to an attorney first, because I, I take responsibility for me, but there's other people that..."

Under established Miranda law, officers must terminate a custodial interrogation of a suspect when that individual invokes their right to counsel or to be silent. That being said, "various cases have held that a suspect's use of equivocal words or phrases does not constitute a clear request for counsel." A suspect must unambiguously assert his right to counsel or to remain silent. Courts objectively look to whether the suspect expressed their desire for counsel with sufficient clarity "that a reasonable police officer in the circumstances would understand the statement to be a request for an attorney." Courts have found the following statements to be equivocal and not an invocation: "maybe I should talk to a lawyer;" "[i]f you can bring me a lawyer;" "I think it'd probably be a good idea for me to get an attorney." In this case the court found that by stating, "[I] want to, speak to an attorney first," Henderson did not use equivocal language and the California Supreme Court found this was a violation of the Fifth Amendment.

### **SFPD Arrests Suspects in Shooting Investigations, Seizing Multiple Firearms**

*Members of SFPD's Crime Gun Investigations Center (CGIC) link suspects to multiple shootings that occurred in 2021 and 2022, seizing several firearms including one assault pistol and two assault rifles. Six of the recovered firearms were "Ghost Guns"*

On September 29, 2022, investigators from the San Francisco Police Department's Crime Gun Investigations Center (CGIC) served search warrants at three residences on the 100 block of Northridge Road in San Francisco. The warrants stemmed from multiple shooting investigations beginning in March 2021 and continuing through September of 2022. The shootings occurred in the area of Northridge Road and Harbor Road.

Through the course of the investigation, officers identified three adult males who were believed to be related to the shootings.

As officers were preparing to serve the search warrants they observed one of the suspects, 28-year-old San Francisco resident Faalavelave Ulavale, outside his residence. Following a brief struggle, officers were able to take Ulavale into custody. Officers conducted a search of Ulavale and they located a firearm on his person. Ulavale was later transported to San Francisco County Jail and booked on one charge of felon in possession of a firearm (29800(a)(1) PC).

Investigators served the search warrant on Ulavale's residence, on the 100 block of Northridge Road, which lead to the discovery of ammunition and a loaded magazine.

Investigators served a second search warrant on a residence on the 100 block of Northridge Road. Upon entering the residence, officers located and detained 30-year-old San Francisco resident Arturo Osorio.

The search of Osorio's residence yielded three handguns, an assault pistol, one rifle and two loaded assault rifles. Officers also located more than 15 high-capacity firearm magazines and

several firearm accessories including a scope and flashlight. Additionally, an unfinished privately manufactured firearm or "Ghost Gun" was recovered. Osorio was later transported to San Francisco County Jail and booked on charges of being a felon in possession of a firearm (29800(a)(1) PC) and possession of an assault weapon in California (30605(a) PC).

The search warrant for the third suspect's residence, also on the 100 block of Northridge Road, did not yield any additional evidence.

Two of the assault weapons recovered in this investigation were equipped with suppressors or silencers and six of the recovered firearms were "Ghost Guns."

The San Francisco Police Department Crime Gun Investigations Center (CGIC) was developed in 2017 with a mission to disrupt gun violence through the consistent production of timely, precise, and actionable information. Through collaboration with the Crime Lab and Property Control Unit, CGIC provides valuable information for investigations, focusing its resources on the most violent connected firearms offenders.

So far in 2022, SFPD has seized a total of 805 firearms, with 107 of those seizures being in the month of September.

## **District Attorney Brooke Jenkins Announces Jury Convicts Patrick Jackson of First-Degree Murder**

*A jury convicted Patrick Jackson of first-degree murder for killing man in a 2019 shooting-*

**San Francisco, CA** – Today, San Francisco District Attorney Brooke Jenkins announced that her office secured a first-degree murder conviction of Patrick Jackson after trial by jury. Jackson shot and killed an unarmed Richard Ponce in the South of Market neighborhood on July 7, 2019. The victim was shot twice and left to die on Bonifacio Street. Despite life-saving efforts at the scene by paramedics Ponce died on the street. Jackson was arrested on September 11, 2019, following an investigation into the July 7 murder. The jury reached a guilty verdict on October 4, 2022. The jury also found true an allegation that a gun was used during the course of the murder.

“We thank the jury for their attention and thoughtfulness in this case and our team for their hard work to help deliver justice for Mr. Ponce’s family,” said District Attorney Brooke Jenkins. “We have lost far too many lives as a result of gun violence, and we are committed to seeking justice for our victim’s families. This verdict affirms our community’s commitment to holding our most dangerous offenders accountable.”

The case against Jackson was successfully prosecuted by Assistant District Attorneys Sean Connolly and Courtney Burris. Investigators from the San Francisco Police Department’s Homicide Unit led the investigation and worked with the prosecutors to develop the case against Jackson.

“There are no winners in cases like these,” said Assistant District Attorney Sean Connolly. “I am grateful to the jury for holding the defendant accountable for Mr. Ponce’s death. I am hopeful that the verdict will bring some degree of closure to his family and send a message that senseless gun violence will not be tolerated.”

“Richard Ponce, just four days shy of his 21st birthday, did not deserve to die,” said Assistant District Attorney Courtney Burris. “I am grateful for the jurors who accepted the duty to serve on this trial and for their thoughtful deliberation which allowed justice to prevail. Although, the

guilty verdict will not bring Mr. Ponce back, it is my hope that this verdict will offer some degree of comfort to his family as they continue to endure his painful loss.”

Jackson has been in custody since his arrest. He will be sentenced at a future date not yet set. He faces a sentence of fifty years to life imprisonment.

# CPAB– Project Updates

August 2022

Community Police Advisory Board (CPAB) “CPABs” are community-oriented police advisory boards for each police district. Each CPAB, led by the District Captain for that police district, is comprised of approximately 10 to 15 committed volunteer community members and a representative from the Community Engagement Division of the SFPD. District Captains may choose more members if they wish to accomplish specific tasks. Each district’s Board members live and/or work in the communities within that district, where a community may be either a neighborhood with specific needs or a specific demographic. Each member thus represents the diversity of their community. In addition to the district CPABs, there will also be a City-wide CPAB Steering Committee facilitated by SF Safety Awareness For Everyone (SAFE). Two representatives from each Community Police Advisory Board shall be selected to participate in this Committee, with the purpose of sharing information across districts.

Captain Falvey held his monthly CPAB meeting on 08/10. Time was spent debriefing this year National Night Out and discussing the Citywide CPAB meeting.

Next months meeting is scheduled for Wednesday, 09/14 at 6:00pm.

# Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ♦ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ♦ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ♦ An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

# Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on the police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Southern Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Southern Station has beat officers assigned to the Mission Street corridor from 4th St to 9th St and on 6th St between Mission St and Howard St.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Southern Station sends out newsletter updates to residents in the district that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the district station.

# Crime Definition

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery - (Misdemeanor battery)** is any willful and unlawful touching of another.  
**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

**Assault** is when a person swings their arm and **battery** is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

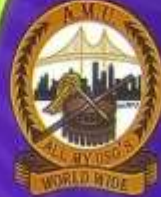

## PACKAGE THEFT PREVENTION GUIDE

### WON'T BE HOME?

Use the "Hold Package" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

### CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

### USE SPECIAL SERVICES

Use USPS special services like *Signature Confirmation* or *Registered Mail* to add a layer of security.

### DELIVER TO SECURE LOCATIONS

Send packages to secure locations such as Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

### REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

### USE MODERN ALTERNATIVES

Take advantage of contemporary options like smart lockers, lockboxes, cameras, motion detection lighting, alarms like Package Guard, and services like Doorman.

### NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

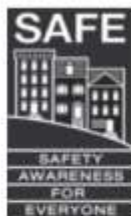
### PORCH AREA VISIBILITY

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.

## PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.



### ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



### INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



### REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



### DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



### INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



### TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



### INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



### SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



### HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.



### INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

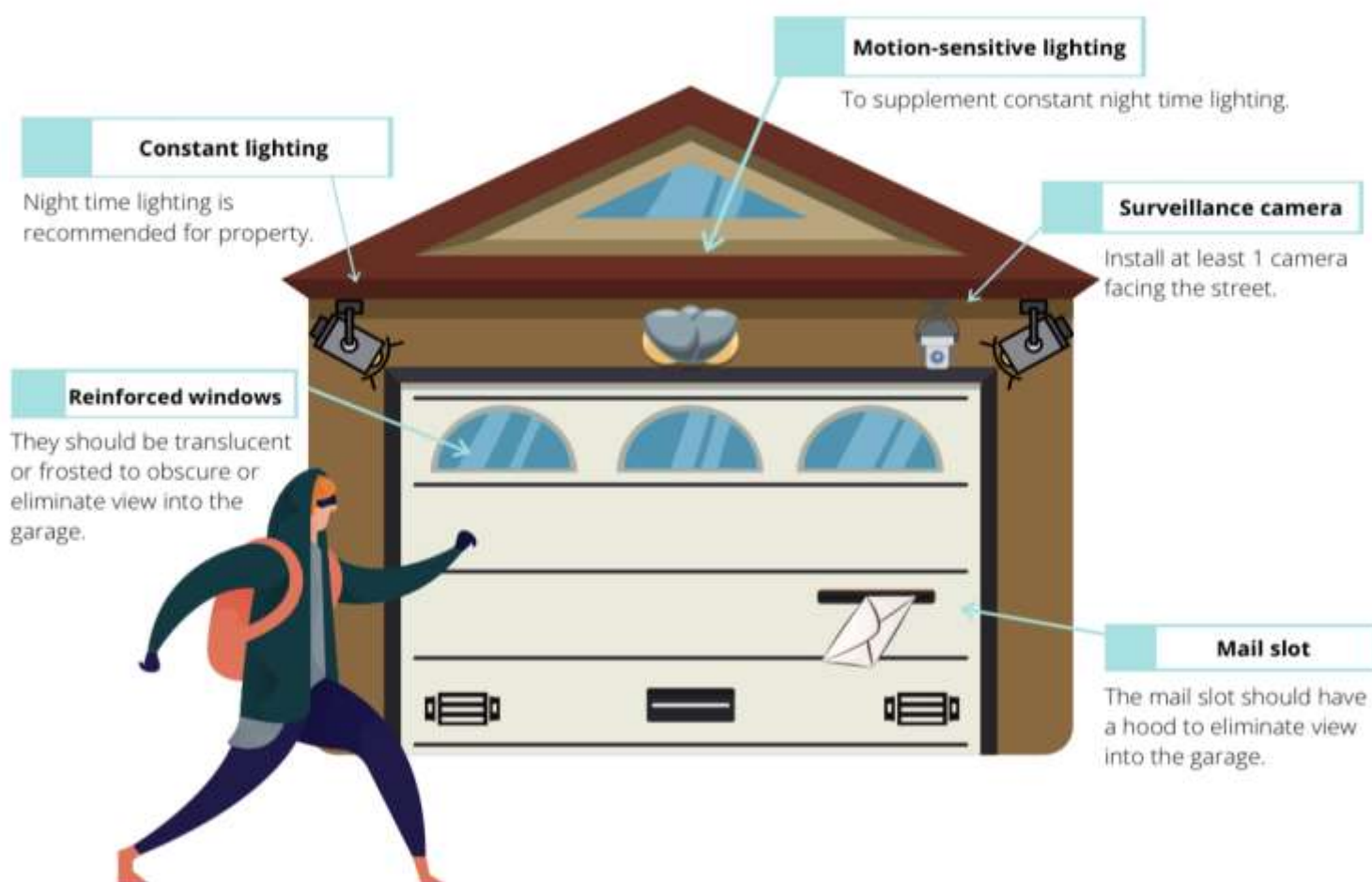

We have implemented the “**Focus on the Five**” traffic safety initiative. Southern Station Officers will be engaging in increased traffic enforcement at these intersections and other locations in the district. ## Focus on the Five Dangerous Intersections

**22450(a) CVC:** The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection

**21453 (a) CVC:** A driver facing a steady circular red signal alone shall stop at a marked limit line, but if none, before entering the crosswalk on the near side of the intersection, and shall remain stopped until an indication to proceed is shown.

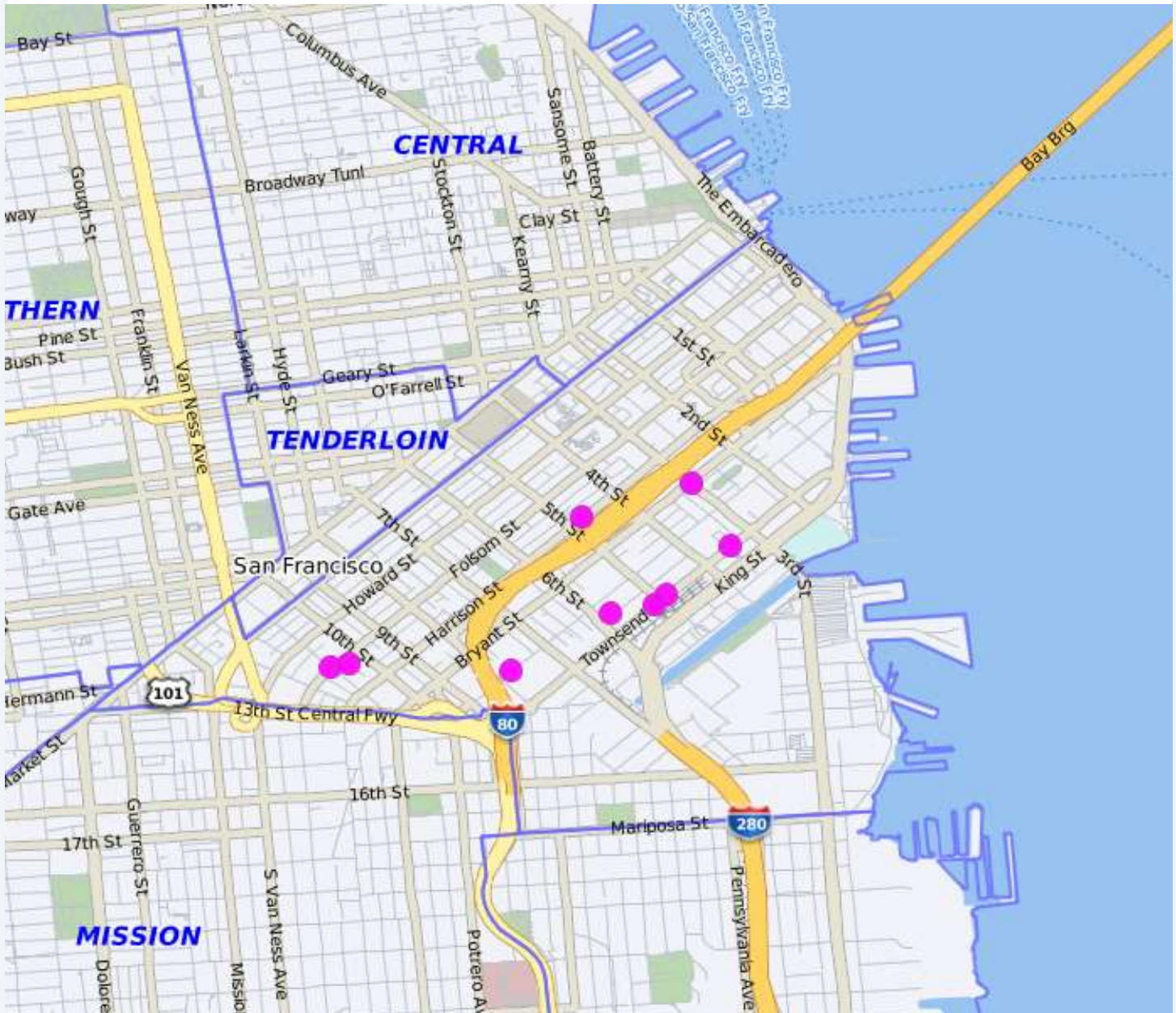
**22350 CVC:** No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

**21950(a) CVC:** The driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection, except as otherwise provided in this chapter.

**22107 CVC:** No person shall turn a vehicle from a direct course or move right or left upon a roadway until such movement can be made with reasonable safety and then only after the giving of an

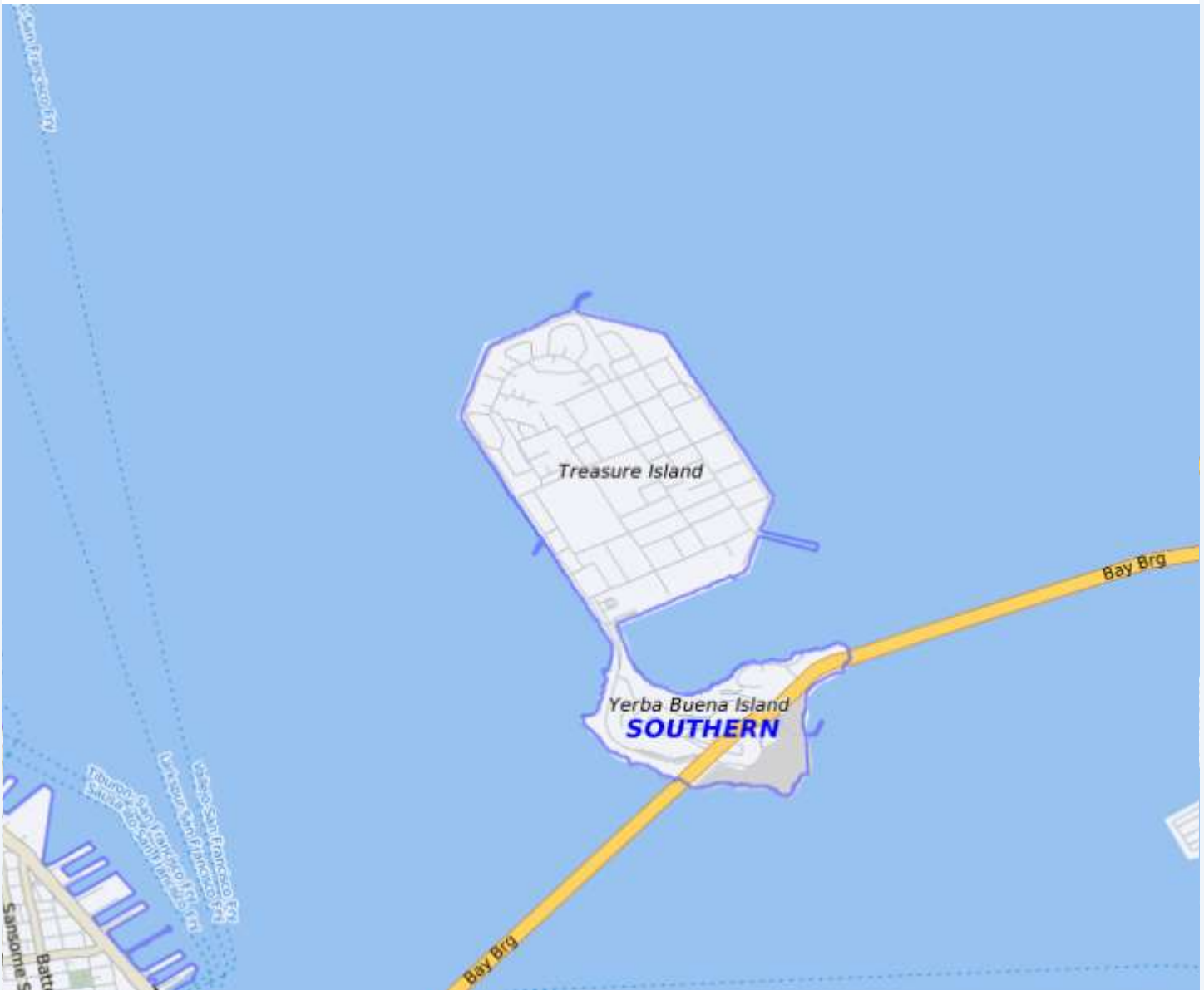

### **SFPD Arrests Armed Robbery and Shooting Suspects**

On 10/11/22 at approximately 12:00 am, San Francisco Police Officers from Mission Station responded to the 3200 block of 23<sup>rd</sup> Street for a report of a shooting. Three suspects approached the victims in a white, four door sedan. The male suspects exited the vehicle and proceeded to rob the victims, shot one victim, and fled the scene in the white sedan. The victim was transported to a local hospital for non-life-threatening injuries. During the robbery, the suspects brandished firearms, which included a rifle.

San Francisco Police Department's Robbery detail took over the investigation. Investigators gathered information and disseminated a department wide crime alert for our officers to be cognizant of the armed and dangerous subjects as well as their vehicle.

On October 12, 2022 at approximately 11:00 a.m., dedicated San Francisco Police Officers on their way into work, observed the suspect vehicle described in the crime alert, traveling into San Francisco.

The off duty officer notified additional officers from the SFPD Narcotics unit who were working in a plain clothes capacity. The officers observed the suspect vehicle parked at 7<sup>th</sup> and Folsom Streets where three males exited the vehicle and entered a business on the 1100 block of Folsom Street.

Investigators from the Robbery detail were notified and responded along with patrol officers from Southern Station. A plan was formulated to apprehend the suspects who were possibly armed and considered dangerous. Southern Station patrol officers approached the building and quickly detained one of the males, 22-year-old Kiemariah Richmond of San Francisco, without incident. The officers seized a concealed firearm from Richmond on scene. In an attempt to escape, the other two males fled on foot through the backdoor of the business and up to the rooftop.

Officers on scene coordinated efforts and set up a perimeter around the block to prevent escape. Officers gave multiple commands to the males on the rooftops to surrender, but the males refused to comply and retreated into the building. A short time later, the males attempted to flee on foot through the perimeter and a foot pursuit ensued. Officers quickly apprehended both males identified as, 21-year-old Keyari Carter of San Francisco, and a 15-year-old male juvenile. Officers located and seized a concealed firearm from Carter on scene.

During the course of the investigation, officers located and seized a rifle from the rooftop where the suspects were seen.

Investigators developed probable cause to arrest Richmond, Carter, and the juvenile for the above listed robbery and shooting incident and placed them into custody on scene.

Richmond was booked into San Francisco County Jail on two counts of Robbery (211 PC 2nd), four counts of Attempted Robbery (664/211 PC), six counts of Firearm Enhancement (12022.53 PC), two counts of a Felon in Possession of a Firearm (29800(a)(1)), Attempted Murder (664/187 PC), Assault with a Firearm (245(b) PC, and Resisting Arrest (148(a)(1) PC).

Carter was booked into San Francisco County Jail on two counts of Robbery (211 PC 2nd), four counts of Attempted Robbery (664/211 PC), six counts of Firearm Enhancement (12022.53 PC), two counts of a Felon in Possession of a Firearm (29800(a)(1)), Attempted Murder (664/187 PC), Assault with a Firearm (245(b) PC, Resisting Arrest (148(a)(1) PC) and Conspiracy (182(a)(1) PC).

The male juvenile was booked into San Francisco Juvenile Justice Center on Two Counts of Robbery (211 PC 2nd), Four Counts of Attempted Robbery (664/211 PC), Six Counts of Firearm Enhancement (12022.53 PC), Two Counts of Possession of Armor Piercing Ammunition (30315(a)(2) PC), Attempted Murder (664/187 PC), Assault with a Firearm (245(b) PC), and Resisting Arrest (148(a)(1) PC, and a No Bail Warrant out of Alameda County.

# Summaries of Supreme Courts Case Laws

(Released Every 3 Months-First Week January, April, July, October )

## **Kansas v. Glover (2020) 140 S.Ct. 1183.**

A Kansas deputy sheriff ran a license plate check on a truck and discovered that the registered owner had a revoked driver's license. The deputy assumed the registered owner was driving the vehicle and pulled it over. The registered owner, Glover, was in fact driving and charged with being a habitual offender. Thereafter, Glover moved to suppress the evidence, claiming that the deputy lacked reasonable suspicion to detain him.

The United States Supreme Court held that, "when the officer lacks information negating an inference that the owner is the driver of the vehicle, the stop is reasonable." The Court noted that the Fourth Amendment permits an officer to detain an individual when that officer has a "particularized and objective basis for suspecting the particular person stopped of criminal activity." Officers must be permitted to make commonsense judgments and inferences regarding human behavior. The Court found that prior to pulling the vehicle over, the deputy observed an individual operating the vehicle, he knew the registered owner had a revoked license, and the model of the vehicle matched what he observed. From these facts the deputy drew the commonsense inference that the driver was the registered owner and the Court found that provided more than reasonable suspicion to initiate the traffic stop.

## **People v. Henderson (2020) 9 Cal.5th 1013**

Henderson was convicted of first degree murder with special circumstances, the personal use of a deadly weapon, and sentenced to death which triggered an automatic appeal to the California Supreme Court. Following his arrest, and during a custodial interrogation, Henderson initially waived his Miranda rights. When asked if he was present at the scene of the crime, Henderson stated, "Uhm, there's some things that I, uhm, want uh ..." He was again asked if he was present and Henderson continued, "[want] uh, want to speak to an attorney first, because I, I take responsibility for me, but there's other people that..."

Under established Miranda law, officers must terminate a custodial interrogation of a suspect when that individual invokes their right to counsel or to be silent. That being said, "various cases have held that a suspect's use of equivocal words or phrases does not constitute a clear request for counsel." A suspect must unambiguously assert his right to counsel or to remain silent. Courts objectively look to whether the suspect expressed their desire for counsel with sufficient clarity "that a reasonable police officer in the circumstances would understand the statement to be a request for an attorney." Courts have found the following statements to be equivocal and not an invocation: "maybe I should talk to a lawyer;" "[i]f you can bring me a lawyer;" "I think it'd probably be a good idea for me to get an attorney." In this case the court found that by stating, "[I] want to, speak to an attorney first," Henderson did not use equivocal language and the California Supreme Court found this was a violation of the Fifth Amendment.

### **SFPD Makes Arrests in Violent Mission District Robbery**

On Wednesday October 5, 2022, at approximately 2:47 a.m., San Francisco Police Officers assigned to Mission Station responded to the area of 26<sup>th</sup> and Folsom Streets for a report of a robbery. Officers arrived on scene and met with a 48-year-old male victim who stated that he was attempting to enter a business on the 2900 block of Folsom Street when two individuals blocked the victim's access. After a brief discussion, he was allowed in, and upon leaving the business, without provocation, the two individuals ran after the victim and began to physically assault him. The suspects punched the victim numerous times and dragged him to the ground where they continued to assault the victim. The two suspects then fled with the victim's backpack. Officers summoned medics to the scene and the victim was evaluated for non-life-threatening injuries and released.

During the course of the investigation, several Mission station officers were able to identify the two suspects as San Francisco residents Jaimie Poole, 50, and Matthew Venegas, 32. A warrant was obtained and on Wednesday October 12, 2022, officers located Poole and Venegas in the area of 26<sup>th</sup> and Folsom Streets. Both men were transported to San Francisco County Jail.

Venegas was booked on charges of possession of methamphetamines (H&S 11377(a)), possession of drug paraphernalia (H&S 11364(a)), possession of a controlled substance (H&S 11350(a)) and warrant violations for robbery (211 PC) and assault by means likely to produce great bodily injury (245(a)(4)). Poole was booked on charges of possession of methamphetamines (H&S 11377(a)) and warrant violations for robbery (211 PC) and assault by means likely to produce great bodily injury (245(a)(4)).

### **SFPD Arrests Wanted Aggravated Assault Suspect**

On Tuesday September 20, 2022, at approximately 11:45 p.m., San Francisco Police Officers assigned to Mission Station responded to the 3500 block of 18<sup>th</sup> Street for a report of an assault. Officers arrived on scene and met with a 51-year-old male victim who was injured from an assault. Officers summoned medics to the scene and the victim was later transported to a local hospital with non-life-threatening injuries.

The victim told officers he was out on a walk with his dog when he encountered an unknown male suspect who was also outside with his dog. The suspect encouraged his dog to attack the victim's dog. The male suspect then struck the victim in the face without warning. The suspect fled the scene. The victim noticed his cell phone, which he dropped during the assault, was missing after the suspect fled.

Investigators from the SFPD General Work Detail led the investigation and identified the suspect as 35-year-old David Camet. On October 8, 2022, San Francisco Police officers assigned to Tenderloin Station were working as footbeat officers in the area of UN Plaza when they observed Camet. Camet was taken into custody without incident. Camet was later transported to San Francisco County Jail and booked on charges of assault with a deadly weapon (245(a)(1) PC), battery with serious bodily injury (243(d) PC), and grand theft (487(a) PC).

**District Attorney Brooke Jenkins Announces Arrest Warrant Issued for Bill Hobbs for Felony and Multiple Misdemeanor Charges**

*Hobbs is wanted for felony false imprisonment, misdemeanor assault, misdemeanor battery, misdemeanor sexual battery and misdemeanor public nuisance*

**San Francisco, CA** – Today, San Francisco District Attorney Brooke Jenkins announced that an arrest warrant has been issued for the arrest of Bill Gene Hobbs. Hobbs is wanted in connection to 14 incidents for numerous crimes committed against multiple women in San Francisco. The arrest warrant issued is for a total of 16 counts including: one count of felony false imprisonment, two counts of misdemeanor assault, six counts of misdemeanor battery, three counts of misdemeanor sexual battery and four counts of misdemeanor public nuisance. The felony false imprisonment charge is punishable by probation up to three years in county jail. For the misdemeanor charges he faces up to six months in county jail per victim.

“I would like to thank the courageous women and men who came forward to share their stories and evidence with authorities so that we could build a case against Mr. Hobbs,” said District Attorney Brooke Jenkins. “Hobbs will be held accountable for the harassment and crimes he committed against women across San Francisco. We will seek pre-trial detention because he is a public safety threat, and we must send a strong message that this type of behavior and harassment will not be tolerated. We will use every legal means available to hold him accountable and seek justice for all of the victims. He will be prosecuted to the fullest extent of the law. I encourage the public to immediately call 9-1-1, if they see Mr. Hobbs, so we can move swiftly to hold him accountable.”

The District Attorney’s Office will seek pre-trial detention in this case because of the public safety risk that Hobbs poses. Hobbs has victimized numerous women across the city and less restrictive means are not adequate to protect public safety.

Prosecutors from the Child Abuse and Sexual Assault Unit worked closely with members of the San Francisco Police Department to bring the case against Hobbs. Victim Advocates will be working with all victims that have come forward to offer support and assistance. The District

# CPAB– Project Updates

August 2022

Community Police Advisory Board (CPAB) “CPABs” are community-oriented police advisory boards for each police district. Each CPAB, led by the District Captain for that police district, is comprised of approximately 10 to 15 committed volunteer community members and a representative from the Community Engagement Division of the SFPD. District Captains may choose more members if they wish to accomplish specific tasks. Each district’s Board members live and/or work in the communities within that district, where a community may be either a neighborhood with specific needs or a specific demographic. Each member thus represents the diversity of their community. In addition to the district CPABs, there will also be a City-wide CPAB Steering Committee facilitated by SF Safety Awareness For Everyone (SAFE). Two representatives from each Community Police Advisory Board shall be selected to participate in this Committee, with the purpose of sharing information across districts.

Captain Falvey held his monthly CPAB meeting on 08/10. Time was spent debriefing this year National Night Out and discussing the Citywide CPAB meeting.

Next months meeting is scheduled for Wednesday, 09/14 at 6:00pm.

# Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ♦ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ♦ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ♦ An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

# Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on the police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Southern Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Southern Station has beat officers assigned to the Mission Street corridor from 4th St to 9th St and on 6th St between Mission St and Howard St.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Southern Station sends out newsletter updates to residents in the district that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the district station.
- Twitter: Southern Station's Twitter sends out the updates on upcoming community events, notable arrests and crime alerts.



# Crime Definition

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery - (Misdemeanor battery)** is any willful and unlawful touching of another.  
**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

**Assault** is when a person swings their arm and **battery** is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

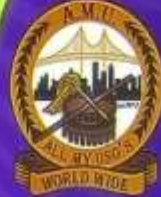

## PACKAGE THEFT PREVENTION GUIDE

### WON'T BE HOME?

Use the "Hold Package" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

### CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

### USE SPECIAL SERVICES

Use USPS special services like *Signature Confirmation* or *Registered Mail* to add a layer of security.

### DELIVER TO SECURE LOCATIONS

Send packages to secure locations such as Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

### REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

### USE MODERN ALTERNATIVES

Take advantage of contemporary options like smart lockers, lockboxes, cameras, motion detection lighting, alarms like Package Guard, and services like Doorman.

### NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

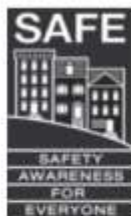
### PORCH AREA VISIBILITY

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.





# Addressing Crime / Safety tips



## PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.



### ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



### INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



### REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



### DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



### INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



### TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



### INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



### SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



### HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.



### INSTALL INTERIOR MAIL SLOT HOOD COVER

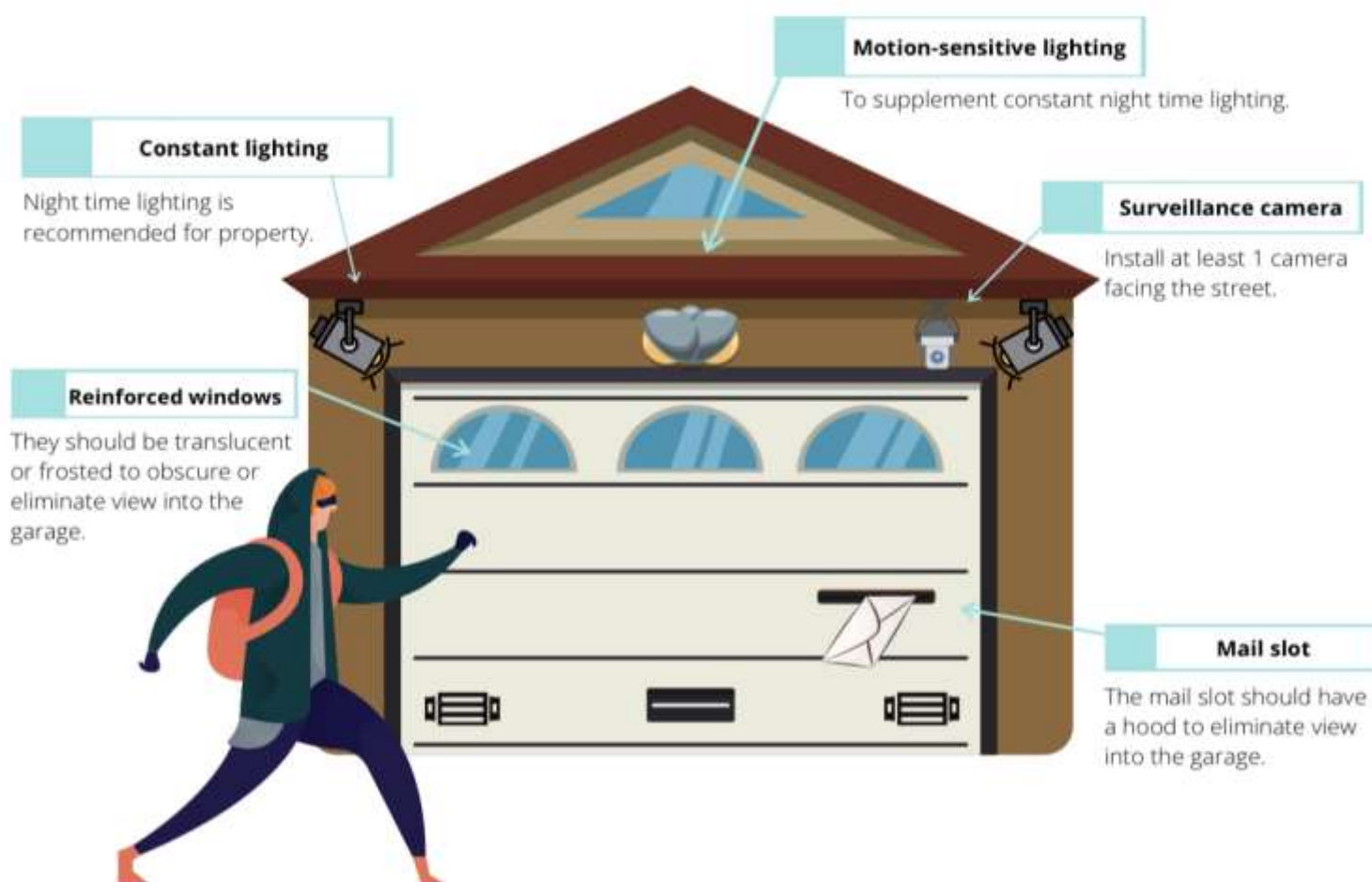
If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

When out and about, drivers need to be ever-mindful of sharing the road with cyclists.

### ➡ Stay Off the Horn

Sudden honking might startle a cyclist and can cause them to swerve into traffic or off the road.

### ➡ Follow the 3 Foot Rule

Maintain a distance of 36 inches from cyclists whenever passing them. If possible, keep an even wider berth if there's bad weather or if in a higher speed limit zone.

### ➡ Mind Your Blind Spots

Drivers should double-check their mirrors when changing lanes, making turns, and especially before opening their car door after parking.

### ➡ Be Cautious with Kids

Kids can be unpredictable since their motor skills and decision-making faculties aren't fully developed. Be on alert when driving near schools and residential areas.

### ➡ Be Patient

Don't tailgate a cyclist. When you need to pass one, patiently wait until it's safe to do so.

**22450(a) CVC:** The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line, if marked, otherwise before entering the crosswalk on the near side of the intersection

**21453 (a) CVC:** A driver facing a steady circular red signal alone shall stop at a marked limit line, but if none, before entering the crosswalk on the near side of the intersection, and shall remain stopped until an indication to proceed is shown.

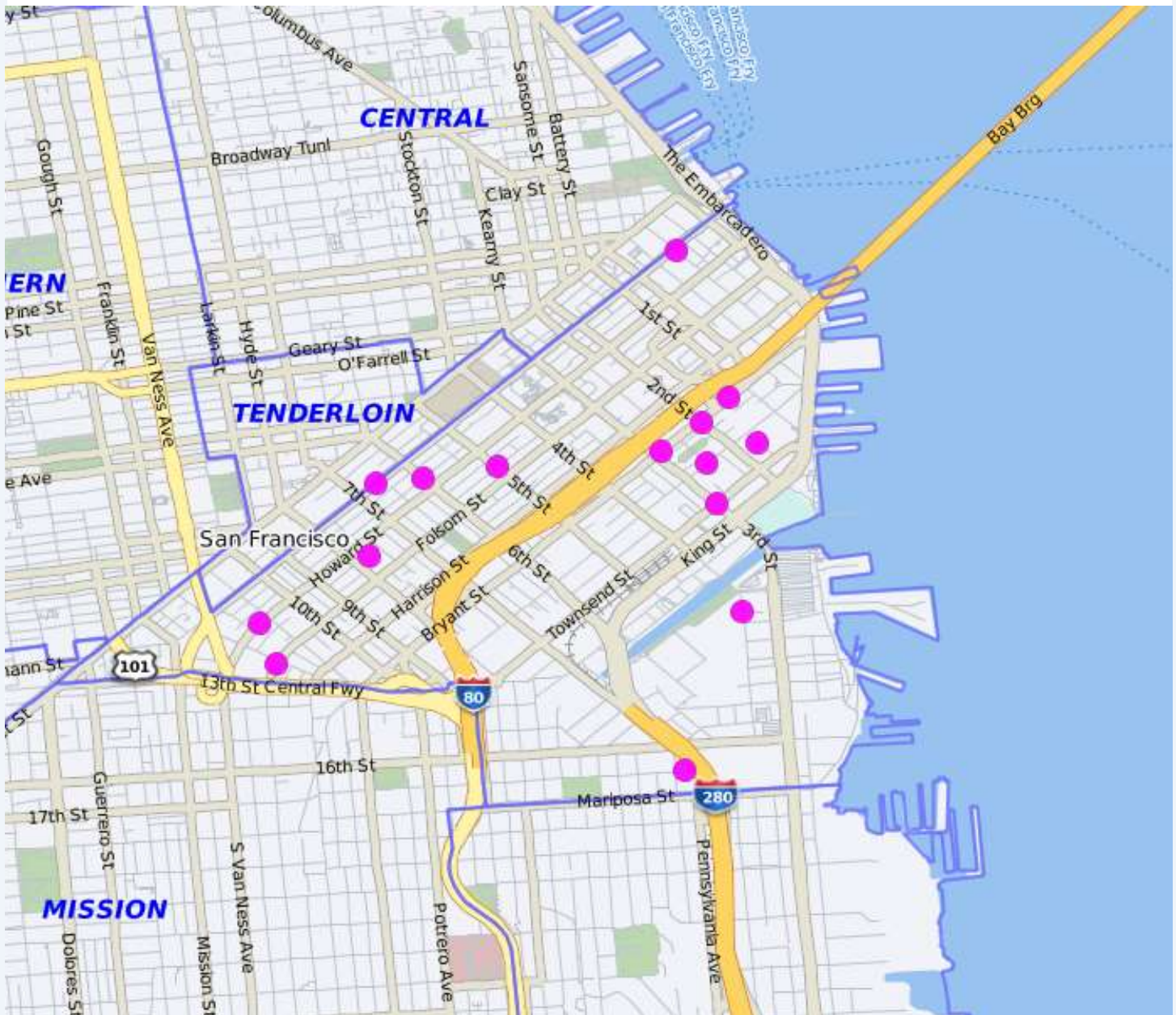
**22350 CVC:** No person shall drive a vehicle upon a highway at a speed greater than is reasonable or prudent having due regard for weather, visibility, the traffic on, and the surface and width of, the highway, and in no event at a speed which endangers the safety of persons or property.

**21950(a) CVC:** The driver of a vehicle shall yield the right-of-way to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection, except as otherwise provided in this chapter.

**22107 CVC:** No person shall turn a vehicle from a direct course or move right or left upon a roadway until such movement can be made with reasonable safety and then only after the giving of an

# Summaries of Supreme Courts Case Laws

(Released Every 3 Months-First Week January, April, July, October )

## **Kansas v. Glover (2020) 140 S.Ct. 1183.**

A Kansas deputy sheriff ran a license plate check on a truck and discovered that the registered owner had a revoked driver's license. The deputy assumed the registered owner was driving the vehicle and pulled it over. The registered owner, Glover, was in fact driving and charged with being a habitual offender. Thereafter, Glover moved to suppress the evidence, claiming that the deputy lacked reasonable suspicion to detain him.

The United States Supreme Court held that, "when the officer lacks information negating an inference that the owner is the driver of the vehicle, the stop is reasonable." The Court noted that the Fourth Amendment permits an officer to detain an individual when that officer has a "particularized and objective basis for suspecting the particular person stopped of criminal activity." Officers must be permitted to make commonsense judgments and inferences regarding human behavior. The Court found that prior to pulling the vehicle over, the deputy observed an individual operating the vehicle, he knew the registered owner had a revoked license, and the model of the vehicle matched what he observed. From these facts the deputy drew the commonsense inference that the driver was the registered owner and the Court found that provided more than reasonable suspicion to initiate the traffic stop.

## **People v. Henderson (2020) 9 Cal.5th 1013**

Henderson was convicted of first degree murder with special circumstances, the personal use of a deadly weapon, and sentenced to death which triggered an automatic appeal to the California Supreme Court. Following his arrest, and during a custodial interrogation, Henderson initially waived his Miranda rights. When asked if he was present at the scene of the crime, Henderson stated, "Uhm, there's some things that I, uhm, want uh ..." He was again asked if he was present and Henderson continued, "[want] uh, want to speak to an attorney first, because I, I take responsibility for me, but there's other people that..."

Under established Miranda law, officers must terminate a custodial interrogation of a suspect when that individual invokes their right to counsel or to be silent. That being said, "various cases have held that a suspect's use of equivocal words or phrases does not constitute a clear request for counsel." A suspect must unambiguously assert his right to counsel or to remain silent. Courts objectively look to whether the suspect expressed their desire for counsel with sufficient clarity "that a reasonable police officer in the circumstances would understand the statement to be a request for an attorney." Courts have found the following statements to be equivocal and not an invocation: "maybe I should talk to a lawyer;" "[i]f you can bring me a lawyer;" "I think it'd probably be a good idea for me to get an attorney." In this case the court found that by stating, "[I] want to, speak to an attorney first," Henderson did not use equivocal language and the California Supreme Court found this was a violation of the Fifth Amendment.

## **District Attorney Brooke Jenkins Announces Byron Reed Convicted of Second-Degree Murder**

*A jury convicted Byron Reed of second-degree murder for killing a man in the Bayview District in 2020*

**San Francisco, CA** – Today, San Francisco District Attorney Brooke Jenkins announced that her office secured a second-degree murder conviction of Byron Reed, 47, after trial by jury. Reed killed Paul Ortega, 58, in the early morning hours of July 23, 2020 on Jennings Street in the Bayview District of San Francisco. Ortega interrupted a drug sale Reed was conducting leading to an initial confrontation between the two men. After separating Reed returned to the scene and began a second confrontation with the victim. This second encounter quickly escalated into a fist fight where Reed quickly overpowered Ortega. As Ortega lay on his back in the street, Reed repeatedly kicked and stomped Ortega's face and neck, before lifting his limp body and slamming his head against the asphalt, killing him. Reed left the scene leaving Ortega face down on the street to die. The jury reached a guilty verdict on October 20, 2022.

"The jury's verdict deliver's justice for Ortega's family and sends a clear message that brutal acts of violence will not be tolerated in San Francisco," said District Attorney Brooke Jenkins. "Reed is being held accountable for his extreme violence and shocking disregard for Ortega's life. Ortega did not have to die on the street as he did. We will always stand with the victim's family and communities impacted by violence and seek justice."

The case against Reed was successfully prosecuted by Assistant District Attorney Aaron Laycook with assistance from paralegals Jessica Diamond and Tony Yu. Victim Advocates Maria Reynoso and Shychai Douangsawang worked closely with the victim's family throughout the case. Prosecutors were able to develop a strong case against Reed based on the careful and diligent investigation work performed by the San Francisco Police Department's Homicide Detail and District Attorney's Office Investigators Lissette Souza and Scott Wong.

"Paul Ortega's death is a terrible loss to his family and friends," said Assistant District Attorney Aaron Laycook. "And while I know nothing that happens in our courtrooms can bring Mr. Ortega back, I am hopeful that the jury's decision today will bring them some sense of justice and closure. Serving as a juror on a case like this is always a solemn responsibility, and this jury rose to the occasion. I am deeply grateful for their thoughtful, diligent deliberations in reaching this verdict."

# CPAB– Project Updates

August 2022

Community Police Advisory Board (CPAB) “CPABs” are community-oriented police advisory boards for each police district. Each CPAB, led by the District Captain for that police district, is comprised of approximately 10 to 15 committed volunteer community members and a representative from the Community Engagement Division of the SFPD. District Captains may choose more members if they wish to accomplish specific tasks. Each district’s Board members live and/or work in the communities within that district, where a community may be either a neighborhood with specific needs or a specific demographic. Each member thus represents the diversity of their community. In addition to the district CPABs, there will also be a City-wide CPAB Steering Committee facilitated by SF Safety Awareness For Everyone (SAFE). Two representatives from each Community Police Advisory Board shall be selected to participate in this Committee, with the purpose of sharing information across districts.

Captain Falvey held his monthly CPAB meeting on 08/10. Time was spent debriefing this year National Night Out and discussing the Citywide CPAB meeting.

Next months meeting is scheduled for Wednesday, 09/14 at 6:00pm.

Candidates with demonstrated financial hardship may submit a request to have the fee waived prior to test registration.
