PermitSF Project Health		<p>All workflows remain in the Configuration phase, with Record Type workflows now tracking Yellow as a small number of outstanding items require final discussion and refinement with CCSF. The team remains confident that OTC DSW configuration will complete by December 23, keeping the February 13 go-live plan intact. <small>[OBJ]</small></p> <p>The Reporting & Dashboards workstream is also in Yellow during configuration as CCSF and OpenGov finalize the most appropriate data access approach. OpenGov's R&D team has made progress and will present a viable solution this week to support CCSF's final decision on which OpenGov reporting tools will be adopted.</p> <p>Training planning is actively in progress, with the rollout on track to begin the week of January 12. This aligns with the finalized go-live sequencing and supports staff and applicant readiness ahead of deployment.</p> <p>This week's focus is on completing February workflow configuration, finalizing the training plan and communications, and closing the remaining integration Validate items to fully transition into testing and readiness.</p>

<p>1. Change Management / Readiness Risk – Staff and applicant readiness remains one of CCSF's highest priorities for February launch; accelerated training and communication are required.</p> <p>2. Holiday Resource Capacity – Holiday schedules continue to compress timelines and require tighter coordination.</p> <p>3. Training – A large number of staff will require training without disrupting essential City operations. A detailed OG training plan is prepared and will be finalized with CCSF this week so scheduling and communication can begin before the holiday break.</p>	<p>1. Reporting & Dashboard Decision Dependency – CCSF to Finalize requirements by end of December.</p> <p>2. Staff & Applicant Readiness – Requires clear messaging, SOP updates, and training pathways to prepare users for new workflows.</p> <p>3. Reporting & Dashboards configuration is advancing, pending final data access decisions. Training preparation and informal testing have begun, signaling readiness momentum.

Training rollout is scheduled to begin the week of January 12, supporting readiness ahead of both deployment dates.</p>
Resource/Capacity		Resource capacity remains steady. CCSF has a coverage plan in place to support timely decisions through the holiday period. Both CCSF and OpenGov teams are increasing activity over the next two weeks to prepare for testing, finalize training materials and schedules, and align communications to support a smooth transition into the readiness phase.
