Project Status - High Level

PermitSF Project Health Steady progress with manageable risks and strong cross-team alignment

Project performance remains stable and trending positively. As the Validate and Configure phases now overlap, CCSF staff are dedicating increased time to reviewing prototypes, validating workflows, and providing feedback during configuration. To support this, OpenGov is developing shared scheduling and tracking tools to help manage meeting cadence, expectations, and workload balance across all teams.

This week, OpenGov received the first draft of the GIS Flag (Parcel) dataset from CCSF. Both teams are working collaboratively to review and validate the data against integration requirements, marking a significant milestone in preparing for Addressing data integration.

The Payment Processor integration continues to progress smoothly and remains on track following strong alignment across CCSF, EUNA, and OpenGov. Leadership engagement, consistent coordination, and quick business decision-making continue to drive implementation progress forward.

Top Risk(s)

- Change Management Timely responsiveness and provision of City information are critical to maintaining project milestones.

Top Issue(s)

 Increased Meeting Load – Validate and Configure phase overlap requires added time from CCSF teams. OpenGov is collaborating with CCSF and implementing scheduling and tracking tools to help maintain alignment and prevent capacity strain.

- Payment Integration On Track CCSF, EUNA, and OpenGov coordination remains strong; deliverables progressing as planned.
- GIS Flag Data Received First dataset delivered; joint validation and integration planning underway.

Delivery	Progress remains steady, with Payment Integration on schedule and GIS Flag data review underway. Delivery momentum continues as teams manage the overlapping Validate and Configure phases through structured collaboration tools and consistent cross-team engagement.
Schedule	Minor delays observed due to extended Validate and feedback cycles, but overall project timeline remains intact. Some workflows experienced 1–2 week shifts in Validate completion as teams balance configuration activities and review cycles. The overall milestone target remains to complete Configuration by the end of December, enabling January to be fully dedicated to training and change readiness activities. Select workflows, including Fire Construction and Special Events, are expected to enter training in early to mid-December as configurations are finalized on schedule.
Resource/Capacity	Capacity remains stable overall. OpenGov continues to operate without any resource constraints, ensuring full coverage across all implementation activities. CCSF staff are balancing their regular operational responsibilities while remaining actively engaged in validation and configuration sessions. With upcoming holiday schedules and time-off periods, both teams are proactively coordinating and leveraging shared scheduling and tracking tools to maintain alignment, balance workloads, and maintain project momentum. Collaboration and responsiveness remain consistently strong despite seasonal capacity pressures.
