Weekly Status Report - November 21, 2025



## **Project Status - High Level**

PermitSF Project Health Strong progress, high engagement, and well-managed risks: The project continues to move steadily through the overlapping Validate and Configure phases, with CCSF and OpenGov teams working in close coordination to stay on schedule.

Minor delays in the Fire Operational and Online Trade workflows are being addressed and are on track to complete Validate phase by next week. Solar finished ahead of schedule, while Water Flow and Signs are ready for sign-off. On the configuration side, Fire Construction (Alarm & Sprinklers) is complete, and OTC DSW-R is slightly behind but expected to finish on time.

These brief delays reflect ongoing change management alignment as processes are refined. CCSF has been highly responsive by owning prework, shortening decision cycles, and helping sustain delivery pace.

Overall, the project remains on track to complete all Validate phases by the end of November and finalize Configuration before Christmas week, setting up January for training and readiness ahead of the February go-live.

- Change Management Timely responsiveness and provision of City information are critical to maintaining project milestones.
- Holiday Resource Capacity Q4
   vacation schedules continue to constrain
   staff availability, compressing timelines for
   deliverables.

#### Top Issue(s)

- Validate Phase Delay Fire Operational and Online Trade validations delayed, but mitigation in place to complete by next week.
- Configuration Process Minor delay in OTC DSW-R due to alignment discussions; confidence remains high for completion on time.

#### Top Win(s)

- Solar Workflow Validation completed ahead of schedule.
- Fire Construction (Alarm & Sprinklers) –
  Configuration successfully completed this
  week.
- 3. **Water Flow & Signs** Ready for Validate phase sign-off.
- 4. **Cross-Team Coordination** CCSF's proactive ownership and governance involvement continue to drive efficiency, risk management, and accountability.

Delivery	Progress remains steady across workflows. Fire Construction configuration is complete, while Fire Operational and Online Trade validations will finish next week. The team is confident all configuration work will be completed before Christmas week.
Schedule	Minor delays in validation and configuration feedback cycles. Validate phase completion remains targeted for end of November, keeping the February timeline intact. Training readiness is in progress, with early sessions starting mid-December.
Resource/Capacity	Both teams continue to manage overlapping workload effectively. CCSF has shown ownership in completing prework, accelerating decision-making, and maintaining project alignment. The joint governance model continues to ensure effective communication and rapid issue resolution.
