Project Status - High Level

PermitSF Project Health



The project remains in the Validate Phase, with strong collaboration between OpenGov and the City's Core Project Team. While the City team continues to respond quickly and engage proactively, ongoing Q4 time-off schedules and dependencies on data and integration activities are limiting progress velocity.

Last week, the City's data team identified that OpenGov must complete an MOU for access to parcel data (GIS Flag). This new requirement will delay this deliverable's validation and sign-off by approximately one week. In addition, there are knowledge gaps around OpenGov's data migration and integration processes on the City side. To address this, OpenGov will conduct additional sessions and provide reference materials to ensure full understanding and alignment to reduce future risk of miscommunication or rework.

Despite these challenges, notable improvements in governance execution and collaboration are driving steady forward momentum. The core team members: Liz, Bridget, Darcy, Florence, Ned, and Patrick, have been instrumental in maintaining decision progress and reinforcing cross-department accountability.

Top Risk(s)

- Payment Processor Dependency on EUNA coordination remains open, impacting downstream integration and reporting timelines.
- Change Management Timely responsiveness and provision of City information at SMEs level are critical to maintaining project milestones.
- 3. Holiday Resource Capacity Q4 vacation schedules continue to constrain staff availability, compressing timelines for deliverables.

Top Issue(s)

- GIS Flag (Parcel Data) MOU required before the City can release parcel data to OpenGov; expected to extend timeline by one week.
- Data Migration and Integration
 Understanding Additional clarity sessions planned to ensure shared understanding of OpenGov's data model and process to avoid decision delays.

Top Win(s)

- Governance Execution Enhanced alignment on roles, responsibilities, and escalation pathways.
- Cross-Department Accountability Core project team collaboration has improved; CCSF leadership demonstrating strong ownership and coordination.
- 3. Partnership Momentum High engagement and problem-solving attitude from CCSF core team (Liz, Bridget, Darcy, Florence, Ned, Patrick) are helping maintain project traction despite constraints.
- 4. Validate Phase Progress Fire Construction workflow successfully signed off in Validate Phase. MAT, OTC, and Special Events permit types are on track for sign-off next week.

Delivery	Delivery remains at risk due to continued dependencies on EUNA and City data readiness. The team achieved a major milestone with the Validate Phase sign-off for Fire – Construction, and MAT, OTC, and Special Events workflows are on track for completion next week. However, EUNA's responsiveness and lack of a confirmed integration schedule are now the primary blockers affecting downstream progress. OpenGov continues active coordination to obtain clearer milestones while mitigating schedule impact through targeted technical working sessions and additional data migration alignment efforts.
Schedule	Approximately 3–4 weeks behind baseline, mainly Payment Integration. The overall schedule risk has increased as EUNA has not provided a committed integration timeline, citing holiday constraints. The GIS Flag MOU delay and Q4 time-off schedules further contribute to compressed delivery timelines. Focused governance actions and cross-vendor coordination are underway to protect critical path items and maintain momentum toward the February go-live target.
Resource/Capacity 🔴	At risk due to vendor dependencies and limited vendor engagement. The City's Core Project Team continues to demonstrate strong ownership and collaboration, helping offset delays where possible. OpenGov is closely monitoring capacity impacts from EUNA's availability, responsiveness and City time-off schedules, with adjusted attendance and escalation plans to sustain progress through November.
