Highlights for July 9, 2025

The following report includes the Department of Police Accountability's recent developments:

- The Association of Local Government Auditors featured DPA's audit of SFPD's stop data in its 2025 Summer Quarterly.
 - This edition focuses on "Police and Law Enforcement", and it highlights innovative audits from across the country.
 - DPA's work appears alongside pieces from oversight agencies in Washington, Chicago, Pasadena, and Seattle, covering topics such as body-worn camera compliance, jail conditions, and use-of-force investigations.

Investigation Updates

- ◆ **Statistics Since Last Commission Meeting on June 18, 2025:**
 - **Cases Opened/Closed:** Our office opened 66 cases and closed 65 cases.
 - **Cases Opened:** Increased 24% (97 cases) compared to 2024 year to date.
 - **Cases Past 270 Days:** As of July 3, 2025, all cases past 270 days are tolled.

Unwarranted Action	The officer conducted an improper search or seizure.	7%
