Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Acting Chief Yep, reported on crime trends YTD: Violent Crime down 19 percent; homicide down 32 percent; rape down 22 percent; robbery down 24 percent; assault down 14 percent; human trafficking up 100 percent. Property Crimes down 28 percent; burglary down 28 percent; motor vehicle theft down 46 percent; arson down 19 percent; larceny theft down 23 percent, organized retail theft down 7 percent. Gun violence is down 26% compared to 2024; Three non-fatal shooting incidents this week; total 65 fire-arm related incidents resulting in 79 victims YTD. No homicides for the week; One Homicide in August. there is a total of 15 homicides YTD with 12 resulting from a firearm; 147% overall clearance.

Updates: Provided update regarding position eliminations, drone operators, Federal Enforcement in San Francisco – a Department Notice was issued.

Significant Incident: Three weeks' worth of incidents. 9/3/25 03:25, Unit block of Golden Gate, Tenderloin, victim located with gunshot wound to head, transported, succumbed to injuries. Three non-fatal shooting incidents, caused injury to three victims, Bayview 8/26 05:30, no arrests, Northern 8/27 20:30 occurred in area of Willow, an alley between Van Ness and Polk, no arrests, and Southern 8/29 19:36 shooting incident on unit block of Colton. 8/31 20:36 USF swatting incident, subject stated hiding under a desk and a shooting occurring in library, multiple Officers arrived, searched building and determined no merit to call, investigation ongoing. Shooting 8/18 14:57, 1900 block of Mission, no arrests. 8/19 02:08, 9th and Mission, Tenderloin, gunshots, no arrests. 8/21 02:19, 2200 block of Mission, shooting, no arrests. Officers saturated area of Mission due to uptick in violence. 8/18 battery and hate crime incident, 8th and Folsom, Southern, victim walking when unknown suspect threw an object at the victim, striking victim in arm, suspect shouted a racial slur, victim refused medical attention, no arrest. Robbery with firearm, 8/23 12:05, Ingleside, Crocker Amazon, juvenile victims walking to park approached by suspects believed to also be juveniles, suspects pointed firearm and demanded property, victims complied and fled, no injuries, no arrest. One homicide, 8/11 22:30, 200 block of Harbor, Bayview, two victims located in vehicle, 2200 block of Cesar Chavez, both victims transported with life threatening injuries, passenger succumbed to

injuries, other victim in critical condition, no arrests. Non-fatal shooting incident, one injury to one victim, 8/11 22:10, 15th Street, Mission, no arrests. Shots fired call with no injuries, Northern, 8/16 20:18, 1200 block of Fillmore, Officers responded to Turk and Fillmore, shooting between two subjects and a third subject, two subjects fled in one vehicle, third subject fled in another vehicle, no injuries, damage to a building, no arrests. Aggravated assault on Officer and firearm arrest in Tenderloin, 8/17, 13:23, unit block of 6th, Officers responded to a report of trespasser possibly with firearm, subject resisted arrest, two Officers injured, arrest made, firearm recovered.

Significant arrest: Pursuit with wanted subject, arrest made, 8/26 12:45, Market and Jones, wanted for violent felony robbery from Los Angeles, Tenderloin foot beat Officers observed subject and knew subject was wanted, three minute pursuit, cancelled due to public safety concerns, subject tracked with RTIC drones, abandoned vehicle and fled on foot, located in the water near Pier 30 at the Embarcadero, Marine Unit responded out and was able to rescue subject from water, was arrested and booked with multiple charges. 8/27 First Amendment demonstration, 137 arrests for demonstration, 14:05, 300 block of Bush Street, multiple protestors inside a building, no reported injuries, no use of force. Taraval 8/30 Shots fired call, 19:44, 600 block of John Muir Dr, Officers responded to shots fired call and observed vehicle fleeing area, Officers attempted stop, vehicle fled, pursuit initiated, pursuit terminated near Alemany and 280N freeway, determined verbal altercation between suspect and victim resulted in suspect shooting at victim, victim not struck, suspect fled with another suspect which resulted in a pursuit, on 9/1 Officers located vehicle and followed it across the Bay Bridge, vehicle lost near Oakland, Oakland PD located and disabled vehicle, Officers responded and made an arrest. A Domestic Violence incident, 8/31 23:54, 1200 block of Quesada in the Bayview, resulted in an Officer being injured, victim assaulted by boyfriend while driving, suspect fled on foot, Officers located suspect, two other subjects interfered with Officers' attempt to detain suspect, a struggled occurred, suspect and one subject who intervened arrested, one subject outstanding, several Officers sustained minor injuries.

Strategies: Stunt driving incident, sideshow, Taraval, 8/30 16:47, 42nd and Judah, several vehicles doing donuts, 30-40 spectators, Officers responded, vehicles left area. Dirt bike gathering with reckless behavior, 8/31 16:00, Mission, 17th, Officers approached group of 40 dirt bikes, traveling southbound on Valencia, group running lights, on sidewalk, nearly striking pedestrians, units trailed group as they dispersed towards 23rd and Valencia, went southbound on 24th and eventually left area.

Paulette Brown: Spoke of son, Aubrey Abrakasa, Jr.'s, homicide case. Provided visuals of unsolved homicides and names of perpetrators. Asked about the Mission Station cameras and her brother being attacked on Market Street.

DPA Director's Report

- Report on recent DPA activities, and announcement

Executive Director Henderson reported the following: In the year 2025: 628 cases opened; 629 closed; 90 pending; 26 cases sustained; 10 cases past 270-day; 7 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting DPA Report)**: 112. Central, 6. Southern, 12. Bayview, 6. Mission, 9. Northern, 6. Park, 3. Richmond, 3. Ingleside, 9. Taraval, 3.

Tenderloin, 24. Airport, 1. Not Applicable, 9. Out of Jurisdiction, 1. Pending, 20 Allegation Summary: Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-21%. Neglect of Duty The officer failed to take required action-14%. Use of Force-The officer used unnecessary or excessive force-7%. Neglect of Duty-The officer failed to properly investigate-7%. Unwarranted Action-The officer conducted an improper search or seizure-6%.

Audits: DPA's audit on SFPD's use of force is currently in progress. DPA is in the process of drafting the report.

Outstanding Issues: DPA Digitization Project, DPA is advancing a major project to digitize all case files and upload them to the cloud. This initiative consolidates case files to ensure accurate indexing and easy searching of cases from 1983 to 2025. The project involves scanning 1,400 boxes containing over 2 million documents and images. Reenvisioning DPA Reports, Over the next few months, DPA will reexamine all reports to improve how they communicate information to the commission, San Francisco leadership, and the public. Aim is to leverage available technology to report the work more comprehensively and efficiently while focusing on data points important to the stakeholders. DPA will improve accessibility, clarity, usability, and ease of navigation.

Renegotiated DPA layoffs with Board of Supervisors and Mayor's Office.

Outreach: NACOLE Regional Conference, August 27-28, 2025, DPA and the California Civilian Oversight Alliance (CCOA) co-hosted a regional conference with the National Association for Civilian Oversight of Law Enforcement (NACOLE) in San Francisco. Civilian oversight leaders from around the country attended this. The conference addressed timely topics including artificial intelligence (AI) in law enforcement practices, using AI to enhance oversight, potential AI bias and concerns, establishing safeguards and policies for responsible AI use, immigration and law enforcement actions at state and federal levels, RIPA data and audit implications, and issues related to diminished support for civilian oversight. Commission Vice President Kevin Benedicto shared his technology and policymaking expertise on a panel about creating AI policies for police practices.

Phone Message System, DPA implemented a new phone messaging system available in seven languages, ensuring all community members can access services and information. This initiative removes language barriers and provides equitable access to police accountability resources for a diverse community. The multilingual system enhances DPA's ability to serve residents who speak languages other than English, strengthening community engagement and accessibility. Can contact DPA at 415-241-7711.
