Chief's Report

- Weekly crime trends
- Major/Significant Incidents

Chief Scott reported on crime trends YTD: Violent Crime up 7 percent; homicide down 2 percent; rape up 5 percent; robbery up 6 percent; assault up 8 percent; human trafficking down 45 percent. Property Crimes up 4 percent; burglary down 21 percent; motor vehicle theft up 4 percent; arson down 10 percent; larceny theft up 11 percent. Gun violence is down 6 percent compared to 2021; One shooting incident for the week ending on 12/4/22; total 169 incident resulting in 192 victims YTD. NO homicides for the week ending 12/4/22; there are a total of 51 homicides YTD with 33 resulting from a firearm; 62 % overall clearance. Guns seized 961; ghost guns seized 163 YTD.

Significant Incident: Efforts in Tenderloin ongoing, most of the efforts are focused on removing Fentanyl, and people selling it, from the streets. Seized 92,486 gross grams of narcotics YTD in the Tenderloin, 60,435 gross grams were of Fentanyl. Double the number from 2021. 493 arrests YTD for sales or possession of sales. \$144k cash seized from narcotic arrests.

Significant arrest: School bomb threats, no arrests yet, suspects not identified. No fatal traffic collisions. On 12/3/22, notified of vehicles en route to San Francisco for a sideshow, stunt driving unit activated. Prevented any major sideshows.

Strategies: Update on DA and SFPD MOU. Discussed military equipment ordinance.

DPA Director's Report

Report on recent DPA activities, and announcement

DPA Executive Director Henderson reported the following: In the year 2022: 647 cases opened; 728 closed; 254 pending; 54 cases sustained; 24 cases past 270-day; 18 cases mediated. Cases received in the past three weeks: 52 new cases; Central (2) Repeatedly requesting a person's skin color and a Sergeant failed to curb the front wheels of a patrol vehicle. Southern (4) Excessive force during detention and officer prevented a person from recording construction work on public property. Bayview (2) Officers were preventing a person from receiving medical treatment and failing to tell the reason they were arrested. Mission (8) Driving recklessly, entering a hotel room inappropriately, officer loitering, and making inappropriate comments about a person's race. Northern (3) Failing to investigate a vehicle theft and making inappropriate comments. Park (2) Failing to write an incident report. Richmond (4) Failing to investigate, failing to enforce a restraining order, and racially profiling a person. Ingleside (2) Failing to take action regarding a noise complaint and issuing a falsified citation. Taraval (4) Detaining a person without cause and making inappropriate comments via phone. Tenderloin (4) Speaking inappropriately and hanging up on a caller. Unlawfully detaining and racially profiling a person. Airport (2) Pulling over a person without justification and acting rudely to a person. Not Applicable (6) Referral. Out of Town (1) Referral. Pending Further Investigation (2) Failing to arrest a person for violating a restraining order.

Audits: November 21st released to Police Commission and public key issues report. Will present report tonight and provide next steps. Received 24-month response from SFPD regarding use of force audit report.
