Summary for Nov 5, 2025

The Department of Police Accountability's highlight for the week:

- **DPA Website Accessibility Project**
 - We are updating our website to comply with Digital Accessibility and Inclusion Standards (DAIS) and the Americans with Disabilities Act (ADA).
- **Archived Case Digitization Project**
 - We are in the process of digitizing decades of archived case files. Once complete, the files will be searchable and will result in savings in physical off-site storage fees.
- **Audit Update**
 - We held an exit conference with SFPD on October 30th. We are finalizing the report and plan to submit it to SFPD for formal response the week of November 10th.

Investigation Updates:

- ♦ **Statistics Since the Last Police Commission Meeting (October 8, 2025):**
 - **Cases Opened:** 63
 - **Cases Closed:** 77
 - Year-to-Date Comparison:
 - **Case openings are up 22%** (143 cases) compared to the same period in 2024.
 - **The number of pending cases is currently 10% higher** (an increase of 21 cases) than at this time last year.
