Chief's Report

- **Weekly crime trends**
- **Major/Significant Incidents**

Acting Chief Yep, reported on crime trends YTD: Violent Crime down 17 percent; homicide down 23 percent; rape down 15 percent; robbery down 23 percent; assault down 13 percent; human trafficking up 120 percent. Property Crimes down 27 percent; burglary down 28 percent; motor vehicle theft down 45 percent; arson down 17 percent; larceny theft down 22 percent. Gun violence is down 14% compared to 2024; One fatal-self-inflicted shooting incident this week, three shooting incidents this week; total 89 fire-arm related incidents resulting in 114 victims YTD. One homicide for the week; total of 23 homicides YTD with 18 resulting from a firearm; 136% overall clearance.

Updates: Follow up from last week's crime trends regarding Robbery, asked Investigations to review trends, Investigations did an analysis – uptick in forceful stealing of gold chains and other jewelry, provided statistics, Investigations working together for a proactive strategy.

Significant Incident: Office Involved Shooting, 11/9/25 16:27, Market and O'Farrell, Tenderloin, SFPD, DA's Office, DPA investigating, Town Hall Meeting is scheduled for 11/18/25 at 3:00 pm, related material to be posted to website. Homicide reported on 9/13/25, unresponsive 6-month-old taken to a hospital ER, infant succumbed to their injuries on 11/3/25, Medical Examiner ruled the death a homicide, investigation ongoing. Three shooting incidents, 7 victims with injuries. Mission

District – 11/6/25 20:23, 1900 block of Mission, victim and suspect in verbal argument, suspect retrieved handgun and shot victim, suspect fled, victim transported in stable condition, no arrest. Richmond District – Ocean Beach, 11/8/25 20:59, group of high school students gathered in area of Fulton and Great Highway, physical altercation occurred, multiple shots fired, Officers responded, 5 victims with gunshot wounds, all victims transported, 4 juveniles-stable condition, one bystander in serious condition, investigation ongoing. Shooting ruled a suicide, 11/9/25.

Significant arrest: Robbery with knife series, 11/5/25, 18:23-19:09, Southern and Central Districts, two subjects matching description, Officers conducted surveillance, witness spoke to Officers, suspect descriptions, cold shows conducted, subjects positively identified, stolen e-bike identified, property recovered, two arrests.

Strategies: DMACC, with partner agencies, targeted operations, made over 70 arrests, seized 10 pounds of narcotics, recovered 4 firearms, Tenderloin, South of Market and Mission neighborhoods, since 10/28 the department has arrested at least 28 drug dealers and seized 9.4 pounds of narcotics including fentanyl, heroine, cocaine and methamphetamines, on 11/5/25 arrested 40 individuals with outstanding warrants for various crimes in a one day operation.

DPA Director's Report

Executive Director Henderson reported the following: In the year 2025: 796 cases opened; 828 closed; 84 pending; 32 cases sustained; 11 cases past 270-day; 10 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting DPA Report)**: 9. Central, 0. Southern, 0. Bayview, 2. Mission, 0. Northern, 1. Park, 0. Richmond, 0. Ingleside, 2. Taraval, 1. Tenderloin, 1. Airport, 2. Not Applicable, 0. Out of Jurisdiction, 0. Pending, 0. Allegation Summary: Conduct Unbecoming an Officer -The officer behaved or spoke inappropriately-25%. Unwarranted Action-The officer displayed threatening, intimidating, or harassing behavior-25%. Neglect of Duty-The officer failed to provide his or her name or star number-16%. Neglect of Duty-The officer failed to take required action-16%. Neglect of Duty-The officer failed to write an incident report-8%.

Audits: DPA expects to send the final draft of the Use of Force audit to SFPD by the end of this week for comment.

Outstanding Issues: DPA is recommending that the Commission initiate an amendment of DGO 8.10 "First Amendment Activities" to fill a gap in public guidance on facilitating peaceful protests. The DGO currently only applies to investigations of people engaged in First Amendment activities.
