**Chief's Report**

- **Weekly crime trends**
- **Major/Significant Incidents**

Deputy Chief Nicole Jones, on behalf of Interim Chief Yep, reported on crime trends YTD: Violent Crime down 17 percent; homicide down 23 percent; rape down 15 percent; robbery down 22 percent; assault down 13 percent; human trafficking up 100 percent. Property Crimes down 27 percent; burglary down 28 percent; motor vehicle theft down 44 percent; arson down 15 percent; larceny theft down 22 percent. Gun violence is down 12% compared to 2024; No shooting incidents this week; total 89 fire-arm related incidents resulting in 114 victims YTD. One homicide for the week; total of 24 homicides YTD with 19 resulting from a firearm; 130% overall clearance.

**Updates:** Office Involved Shooting, Town Hall conducted on 11/18/25, all material available on the website.

**Significant Incident:** Water rescue, 11/15/25, SFPD Marine Unit and Fire Department responded, person in water near Pier 43, 80 year old women, partially submerged, successfully pulled to safety. Fatal hit and run, 11/16/25, 2700 block of Alemany, Ingleside District, call received hours later that a person was in the street, victim declared deceased when Officers arrived on scene, footage obtained showed vehicle had collided with a bicycle, person riding bicycle was killed.

**Significant arrest:** Homicide 11/16/25 00:00, 16th and Valencia, double shooting, one fatality, verbal altercation inside nightclub, physical when parties went outside, two victims sustained gunshot wounds, transported with life threatening injuries, one succumbed to injuries, suspect contacted police and was taken into custody, investigation ongoing. Sexual Assault of minor, suspect arrested, incident involved teacher occurred multiple years ago, investigation conducted and led to arrest, SFUSD working with department on the matter.

Executive Director Henderson reported the following: In the year 2025: 809 cases opened; 844 closed; 83 pending; 32 cases sustained; 12 cases past 270-day; 10 cases mediated. SFPD Cases received in the past **weeks (since the last Commission Meeting DPA Report)**: 11. Central, 1. Southern, 0. Bayview, 2. Mission, 2. Northern, 2. Park, 0. Richmond, 0. Ingleside, 0. Taraval, 1. Tenderloin, 1. Airport, 0. Not Applicable, 0. Out of Jurisdiction, 0. Pending, 2. Allegation Summary: Neglect of Duty-The officer failed to investigate-17%. Neglect of Duty-The officer failed to take required action-13%. Conduct Unbecoming an Officer-The officer displayed threatening, intimidating or harassing behavior-9%. Conduct Unbecoming an Officer-The officer behaved or spoke inappropriately-9%. Neglect of Duty-The officer failed to make an arrest-9%.

**Audits:** DPA provided a copy of the draft use-of-force audit to SFPD for review, and we've asked SFPD to provide a response by December 4th.

**Outstanding Issues:** DPA has identified crowd control cases to discuss with an SFPD SME to see whether policies or practices are leading to unnecessary tension with protesters, pursuant to mandate under San Francisco Charter Section 4.136(h).
